PLEDGE OF ALLEGIANCE

The City Council recited the Pledge of Allegiance.

CITIZEN'S COMMENTS

Oscar E. Puente addresses the Council with his concerns regarding removing Carlos Lara as the CSVFD Chief. Mr. Puente states that they should consider probation or resolving the issues before removing him as the CSVFD Fire Chief and allowing him time to make improvements.

Ted Rodriguez states that Carlos Lara was not given a written notice as stated in the CSVFD by-laws regarding any issues or concerns with his performance. The CSVFD is an independent agency and removing Carlos Lara or any member is illegal. There has also been concerns that a public official has been harassing Carlos Lara and that it will be investigated.

Alfredo Castaneda states that he has concerns with the County parking at the Housing Authority parking area. It is a hazard to the elderly who reside at the apartments, the area is so congested that in case of an emergency the ambulance would not be able to get to the residents.

Julissa Alvarado states that the County Judge was not able to attend, she states her concerns regarding the no parking zone and in the past 8 years there hasn't been any issues.
