### A. LAW ENFORCEMENT

### B. EMERGENCY MANAGEMENT SERVICES

Mayor Pro Tem Sofia Morones asks if the Interlocal Law Enforcement Agreement will be the same of amount of \$250,000. Sheriff Chris Castaneda states that the amount will stay the same.

Councilor Mario Ruiz inquires on the fee of \$75 to house the inmates taken in by the city. Sheriff Chris Castaneda states that they have not charged any fees to the city for inmates.

Mayor Pro Tem Sofia Morones states that the fee should not be included in the new Interlocal Law Enforcement Agreement. Sheriff Chris Castanda states that it would be up to the Commissioners Court.

Dimmit County Judge Martha Ponce states to Council that they will open bids on October 21, 2024 for Emergency Medical Services.

Dimmit County Judge Martha Ponce states that the previous administration approved a \$600,000 agreement with Victory Ambulance but that proposal was never presented to the city. The city had only budgeted \$144,000 for emergency medical services so the County had to incur the difference of \$456,000.

City Manager Azalia Garcia asks for transparency and why the other entities including Big Wells, Asherton and Catarina do not pay for Emergency Medical Services. Commissioner Juan Carmona states that their population is different and they do not have the resources to pay for the services, he also states that the majority of calls come from the City of Carrizo Springs.

Dimmit County Judge Martha Ponce states that emergency medical services will not be cut off, she also states that by law the county shall provide emergency medical services if there is a contract between the city and the county.

Dimmit County Judge Martha Ponce states that the county wants to work with the city to provide emergency medical services for the residents of Carrizo Springs.

Councilor Mario Ruiz asks how can we explain to the taxpayers that pay both city and county taxes might not be able to receive emergency medical services within the city limits. Dimmit County Judge Martha Ponce states that the county lets the city use their heavy equipment free of charge. Councilor Mario Ruiz states that all the Commissioners precincts come into the city limits it does not stop at the city limits so when the city repairs the streets it benefits their precincts as well.

Commissioner Juan Carmona states that if the cost of the emergency medical service agreement is not feasible that maybe the city should consider creating their own emergency medical services to provide for the community.

Mayor Pro Tem Sofia Morones asks how much the county budget for the emergency medical services. Dimmit County Judge Martha Ponce states that \$400,000 was budgeted for the emergency medical services.

Mayor Pro Tem Sofia Morones asks the Judge what amount she is asking from the city for the agreements. Dimmit County Judge Martha Ponce respectfully requests \$250,000 for the Interlocal Law Enforcement Agreement and \$200,000 for Interlocal EMS Agreement.
