15. ORGANIZATIONAL UPDATES

City Manager Ronnie J. Guest, Jr. states to Council that COVID-19 impacted the team in the month of July.

The City mailed out via certified letter, terminating the contract agreement between the City of Carrizo Springs and Carrizo Hill for wastewater treatment services.

The Stratton Wastewater Treatment Services Agreement is still being reviewed by the federal government. The design schedule should be 90% complete by August 19, 2020, once completed the plans for the proposed force main connection to the City of Carrizo Springs wastewater collection system will be provided for review.

The Civic Center Parking Lot project is moving to the next steps as the Church is presenting the plan to the Church Board, as soon as the Church agrees with the plan the City will proceed with RFQ's.

Budget meetings took place with each of the Councilmembers in preparation for the upcoming budget season.

City Manager Ronnie J. Guest, Jr. recognizes Edgar Castillo and Finance Director Gloria Martinez for completing the necessary paperwork to submit for the CARES Act Coronavirus Relief Fund to receive a portion from the State of Texas of the \$450,000 earmarked for those with populations under 500,000. We do not know the actual total the City will receive but the amount will help offset the currented projected shortfalls.
