VETERANS PARK

Second RFP was advertised for electrical services for the Veterans Park.

The Veterans Park exercise equipment installation was completed and the turf is estimated to be completed by October 10, 2024.

The Veterans Park bridge began construction on October 5, 2024 and expected to be completed by October 9, 2024.

WET WELL REHABILITATION PROJECT

Change Order #1 for change of material for PVC and Change Order #2 for the addition of bypass needed during the project was approved by City Council.

The wet well rehabilitation project will begin the week of October 14, 2024 and the estimated completion date should be under two weeks.

MASTER METER REPLACEMENT PROJECT

A total of 460 water meters will be replaced in October 2024.

WATER CONSERVATION

Data analysis for water conservation will be conducted by Dr. Mike Villarreal and funded by WFX.
