## A. CITY MANAGER REPORT

# 1. CIVIC CENTER

Interim City Manager John Camarillo stated to Council that the old floor has been demolished and the new floor has been installed at the Civic Center. A new electric stove, refrigerator, 16 round tables, 20 rectangular tables and 200 chairs have been purchased for the Civic Center. The completion date for the Civic Center Renovation Project was November 7, 2019. The Civic Center Renovation Project plaque for the building has been ordered and will arrive in three to four weeks.

# 2. WATER METER REPORT ISSUES

Interim City Manager John Camarillo updates Council on the water meter radio read computer and states that they have been having issues with the meter since June and July and the meter was sent to the Dallas office for a software upgrade. After receiving the meter there were still issues with the meter and an IT Technician from Master Meters came to look into the issue with no results. Finance Director Gloria Martinez contacted Mr. Jose Velasquez and Mr. Johnny Martinez from the City of Eagle Pass Water Department and the problem with the meter was corrected.
