3. DISCUSSION AND APPROPRIATE ACTION TO APPROVE THE CITY OF CARRIZO SPRINGS AND DIMMIT COUNTY INTERLOCAL LAW ENFORCEMENT AGREEMENT

Mayor Oscar E. Puente asked if there were any changes made to the interlocal agreement compared to last year. Interim City Manager Melissa M. Guerra states that the Interlocal Law Enforcement Agreement is renewed every year and the amount for Fiscal Year October 1, 2021, through September 30, 2022, is \$300,000 in which \$200,000 will be for the current fiscal year service and the remaining \$100,000 will be applied and credited to outstanding debt owed to the County.

Councilor Mario Ruiz asked what the total amount was for the Interlocal Law Enforcement Agreement last year. Interim City Manager Melissa M. Guerra states that the total amount for the Interlocal Law Enforcement agreement last year was \$350,000 and that \$100,000 of that total was applied to the outstanding debt owed to the County.

Motion made by Councilor Mario Ruiz, seconded by Councilor Ashley Moreno to approve the City of Carrizo Springs and Dimmit County Interlocal Law Enforcement Agreement for a total of \$300,000 in which \$200,000 will be for Fiscal Year October 1, 2021, through September 30, 202 for the current Fiscal Year service and the remaining \$100,000 will be applied and credited to outstanding debt owed to the County.

Vote for approval 4-0 (unanimous).

ORDINANCE(S)

4. DISCUSSION AND APPROPRIATE ACTION TO APPROVE ORDINANCE NO. 825 AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF CARRIZO SPRINGS, TEXAS DESIGNATING ADAM STREET AS A "ONE WAY" ROADWAY BETWEEN THE INTERSECTION OF 15TH STREET AND 13TH STREET

Velma McNeil states to Council that an incident had occurred at the Kids are First Headstart, Inc. where a child ran unaccompanied across the street to his parents' car and the child was almost hit by a car. The child's dad was able to get off the car and protect his child from getting struck by the vehicle.

Kids are First Headstart is requesting to make Adams Street a one-way between the roadway of 15th and 13th streets. Ms. McNeil and Ms. Talamante stated that Adams Street had a speed bump, but it was removed and requested to have the speed bump be re-installed.

Public Works Director John Camarillo states that he performed a traffic study November 3, 2021, on West Adams Street and the traffic was heavy between the hours of 7:30 a.m. to 8:30 a.m. and also between 2:00 p.m. and 4:00 p.m. with several vehicles making U-turns that made the street very congested with high traffic and putting the children's safety in danger. Public Works Director John Camarillo recommended installing a speed bump in the middle of Adams Street.

Councilor Mario Ruiz asks about posting one-way signs and where the signs will be installed. Public Works Director John Camarillo states that they will be installed on both ends of Adams Street. Ms. Velma McNeil also suggested installing a sign with flashing lights.

Interim City Manager Melissa M. Guerra asked Ms. Velma McNeil what hours the Kids are First Headstart, Inc. are requesting for the one-way street so she can update the ordinance. Ms. McNeil states that the hours should be from 7:30 a.m. - 9:00 a.m. and from 2:30 p.m. to 4:00 p.m.

Motion made by Councilor Mario Ruiz, seconded by Councilor Ashley Moreno to approve Ordinance No. 824 an ordinance by the City Council of the City of Carrizo Springs, Texas designating Adam Street as a "One Way" roadway between the intersection of 15th Street and 13th Street with the updated hours and to install a speed bump on Adams Street.

Councilor Mario Ruiz states to Council that the Dimmit Regional Hospital is going to demolish a building that the hospital owns and would like the city's assistance to dispose of the demolition material at the city landfill.

Councilor Mario Ruiz also states that Dimmit County will also be assisting the hospital with the demolition project.

Motion made by Councilor Ashley Moreno, seconded by Councilor David Balderas to assist Dimmit Regional Hospital with their demolition project to allow them to dispose of the demolition materials at the city landfill.

7. DISCUSSION AND POSSIBLE ACTION IN REGARDS TO INSTALLING LIGHTS AT THE WATER TOWER LOCATED ON 9TH STREET

Interim City Manager Melissa M. Guerra recommends getting additional quotes for a multi color light system for the water tower located on 9th Street that can be used year round with a cost of \$30,000 or more, instead of only installing white lights at the tower.

B. PEACE OFFICER MENTAL HEALTH LEAVE POLICY

HR Specialist Brenda Reyes states to Council that the Hazard Communication Program is required by the Texas Hazard Communication Act (THCA) for all public employers in Texas to provide the employees with information regarding hazardous chemicals to which employees may be exposed. Councilor Mario Ruiz asks where the information will be posted. HR Specialist Brenda Reyes states the master copy of the written hazard communication program will be maintained at City Hall and all the departments will have a copy of the program at their location.

HR Specialist Brenda Reyes states to Council as per Government Code, Chapter 614.015, Subchapter A-1 Mental Health Leave for Peace Officers that each law enforcement agency shall develop and adopt a policy allowing the use of mental health leave by the peace officers employed by the agency who experience a traumatic event in the scope of their employment.

Councilor Mario Ruiz asked if the city currently has a policy in effect. HR Specialist Brenda Reyes states that she is working on a safety manual that will include the hazard communication program and the Peace Officer Mental Health Leave Policy.

Motion made by Councilor David Balderas, seconded by Councilor Ashley Moreno to adopt the Hazard Communication Program and Peace Officer Mental Health Policy.

Vote for approval 5-0 (unanimous).

Mayor Pro Tem Sofia Morones recommends premium pay of \$2,500 for the city employees from the American Rescue Plan Funds. Councilor Mario Ruiz agrees with Mayor Pro Tem Sofia Morones recommendation.

Interim City Manager Melissa M. Guerra states to Council that a \$5,000 premium pay was discussed with Interim Finance Director Edgar Castillo, the premium pay would be disbursed in a split payment of which ½ would be paid this year and the other ½ of the premium pay would be paid next year when the city receives the second payment from the American Rescue Plan Funds in March 2022.

Mayor Pro Tem Sofia Morones recommends paying a lump sum of \$5,000 to the city employees this year and discussing the allocation of American Rescue Plan Funds next year when the funds are received in March 2022.

12. ORGANIZATIONAL UPDATES

Interim City Manager Melissa M. Guerra updates Council with the status of the City of Carrizo Springs, Texas Limited Tax Refunding Bonds, Taxable Series 2021. Mayor Oscar E. Puente asked how much the city saved with the refunding bonds. Interim City Manager Melissa M. Guerra states that the refunding of the Refunded Bonds will result in a net present value savings of \$569,837.65 and a gross saving of \$612,043.75. The closing date for the sale of the Bonds was on November 4, 2021.

Mayor Pro Tem Sofia Morones asked if the bonds were budgeted. Interim City Manager Melissa M. Guerra states that the Limited Tax Refunding Bonds, Taxable Series 2021 Bond was to refinance some of the city's debt and the bonds were budgeted for Fiscal Year 2021-2022.
