6. DISCUSSION AND APPROPRIATE ACTION IN REGARDS TO ELDERLY NUTRITION CENTER CREATING AN AGREEMENT/CONTRACT WITH THE CITY OF CARRIZO SPRINGS TO REQUEST FUNDS FOR THEIR BUSINESS EXPENDITURES

City Manager Ronnie J. Guest, Jr. states that an agreement must be put into place to fund the Elderly Nutrition Center for business expenditures. The city has been providing \$9,500 for business expenditures for years.

Councilor Sofia Morones states that the city should be consistent with every entity and should have requested more information from the Elderly Nutrition Center before releasing the funds.

City Manager Ronnie J. Guest, Jr. states that the funds for the Elderly Nutrition Center were budgeted and the decision was made to release the funds.

Motion made by Councilor Oscar E. Puente, second by Councilor Sofia Morones to require the Elderly Nutrition Center to create an agreement/contract to request funds for their business expenditures.

Councilor Sofia Morones states that it is a great idea to improve the downtown area, but her concern is that \$10,000 was not budgeted for the project. City Manager Ronnie J. Guest, Jr. states that he is working on other projects that have not been budgeted but the improvements will add value and the community will be able to enjoy the new space.

Councilor Oscar E. Puente states that once the budget is approved, he would like to see the progress of the new "Town Square" within the next 3 months.
