Public Works Director John Camarillo states that he never met with anyone regarding the drainage issue.

Mayor Pro Tem Sofia Morones states to City Manager Azalia to speak to the Engineer regarding the city denying fixing the drains.

Commissioner Alonso Carmona states to Council that he is willing to work with the city to resolve the drainage issue.
