# 17. DISCUSSION AND APPROPRIATE ACTION TO APPROVE VARIANCE FROM ORDINANCE NO. 847 RELATED TO WATER SERVICES OUTSIDE THE CITY LIMITS BETWEEEN THE CITY OF CARRIZO SPRINGS & DIMMIT COUNTY

Keith Franklin, a private practice attorney representing Dimmit County presented a contract between the City of Carrizo Springs & Dimmit County dated December 13, 1964 regarding and exchange for a grant of the water rights by the city council on the land where the Dimmit County Rodeo Arena sits and the Sports Facility Project that is going to be developed. Mr. Franklin states that the city has an ordinance that prevents any more utility services outside of the city limits without seeking a variance, but according to the contract the county would be guaranteed water to be delivered by the city to the property for free.

According to the contract it states that all water reasonably required to operate and maintain other recreational facilities which may hereafter be established on said land, so long as such facilities continue to be maintained and operated by public or nonprofit organizations.

Commissioner Jose Urenda asks and requests to work jointly with the city to develop the Sports Facility Project.

County Judge Martha Ponce states that on behalf of the County she thanks the city for taking the time to discuss the Sports Facility Project and would like to work together with the city to resolve the development of a project that will benefit the city and the whole community.

County Judge Martha Ponce states to Council that 80% of the Sports Complex landscaping, baseball and soccer fields will be artificial turf and there will be a minimal use of water. Most of the water that will be utilized in the splash pad area will have a recycling system.

City Manager Azalia Garcia states that she will share the contract to Special Counsel Bobby Maldonado for further review. Ms. Garcia asks if the council approves the variance the city will supervise the project.

Mayor Pro Tem Sofia Morones states that the contract is more than 60 years old and recommends that the contract be updated.

Councilor Estanislado Z. Martinez states that the city should work together with Dimmit County. Councilor Mario Ruiz states that the contract was established in 1964 and not all the council was in agreement with the contract at that time, moving forward the city cannot continue to provide free water to the county.

Motion made by Mayor Pro Tem Sofia Morones, seconded by Councilor Mario Ruiz to approve variance from Ordinance No. 847 related to water services outside the city limits between the City of Carrizo Springs & Dimmit County and for the County to purchase the water meter and the city will assist with the project.
