Veterans Park Restroom Project

Contact was made with Robert Puente of Eagle Builders to discuss the Veterans Park restroom construction project. The project was accepted by Mr. Puente and the construction was started on February 28, 2022.

Civic Center ADA Ramps

John Flores with JF Painting & Construction will start the ADA ramp construction at the Civic Center soon and will follow up with the Civic Center parking lot. Garcia & Wright's existing plans show that the sidewalk will be removed on 7th Street for the ADA ramp.

Carrizo Hill Water Supply Agreement

Special Counsel Bobby Maldonado is still working on the Carrizo Hill Water Supply Agreement with Jeff Snowden and the city has provided information requested for the agreement. Jeff Snowden stated that he needs the actual meter installed to get the exact amount of flow to determine the agreement.

A&M Signs

Interim Finance Director Edgar Castillo found a check that had been issued to A&M Signs for \$21,950 back on February 22, 2021. City Manager Chris A. Castanda made contact with A&M Signs, and they advised that they did receive the check but never heard back from the city. They agreed to give the city credit for the \$21,950 minus work they had to redo. The resolution approved for the project was sent to TX Dot and pending final approval.

Fire Hydrants

Fire hydrants are still in backorder due to pandemic and shortage of workers.

Splash Pad Information

City Manager Chris A. Castaneda reached out to Eagle Pass in regards to the Splash Pad and was informed that the total cost of the project was \$618,829.00. The project was funded through Capital Improvement Funds (CIP).

Water Line Replacement on FM 1917

Water Supervisor Ramsey Castillo requested a state permit to remove the water line from the High School tap and reroute the water for Pilot, Southern Tire Mart and other customers. The project may run between \$35,000 - \$45,000 to replace the water line.
