### 2. OPEN PUBLIC HEARING

Commissioner Elia Ramirez open the Public Hearing at approximately 5:30 p.m.

A. CLEO BUSTAMANTE JR. REQUESTING TO REZONE AN R-1 (SINGLE FAMILY PROPERTY) TO AN R-2 (MULTI-FAMILY PROPERTY) FOR THE PURPOSE OF CONSTRUCTING A DUPLEX, SAID PROPERTY IS LOCATED AT 204 EAST ALAMO STREET, CS-ALAMO DOWNS ADDITION, BLOCK 2, LOT 1-3, CITY OF CARRIZO SPRINGS, DIMMIT COUNTY TEXAS

Code Enforcer Arnold Aguilar states to the Planning & Zoning Commission the applicant Cleo Bustamante, Jr. would like to construct a duplex on his property located on 204 E. Alamo Street.

Commissioner Antonio Rodriguez is concerned regarding the size of the building and the size of the lot. Code Enforcement Arnold Aguilar states that the size of the building will meet the square footage of the property.
