PUBLIC SAFETY QUARTERLY REPORTS

3. DIMMIT COUNTY SHERIFF'S DEPARTMENT

Deputy Luciano Quintanilla presented Council with the Dimmit County Sheriff's Department quarterly report.

4. MEDSHIELD

Eric Olivarez presented Council with Victory Ambulance Care, LLC. quarterly report. Mr. Olivarez states that Medshield has transitioned to Victory Ambulance Care, LLC, he also reported an ambulance loss due to transferring COVID patient with no insurance.

Eric Olivarez states that Dimmit County will be allocating some American Rescue Plan Funds to help with their ambulance losses. Mayor Oscar E. Puente states that the city will also work on allocating some ARP Funds as well to cover some of their ambulance losses.

5. CARRIZO SPRING VOLUNTEER FIRE DEPARTMENT

Fire Chief Noel Galvan reported a total of 12 calls for the months of July, August, and September 2021. The Carrizo Springs Volunteer Fire Department currently has 18 members.

6. MUNICIPAL COURT

Municipal Judge Francisco R. Ponce reported a net revenue of \$125,940.76 for the months of July 1, 2021 – September 30, 2021.

Mayor Pro Tem Sofia Morones asks why the revenue went up in comparison to 2020 quarterly report net of \$40,901.42. Municipal Judge Francisco R. Ponce states that with COVID-19 in the year 2020 there were no court personal appearances.

ACCOUNTS PAYABLE

7. DISCUSSION AND APPROPRIATE ACTION TO APPROVE ACCOUNTS PAYABLE FOR SEPTEMBER 2021

Mayor Oscar E. Puente inquires on the payments made to the Dimmit County Treasurer. Interim City Manager Melissa M. Guerra states that it was a lump sum payment made for the Dimmit County EMS Interlocal Agreement.

Mayor Oscar E. Puente inquires on the payment made to Daniel Flores for the Civic Center air condition and if the ac was still under warranty. Account Specialist Edgar Castillo states that the air condition was an old unit that was not replaced when the Civic Center was remodeled.

8. DISCUSSION AND APPROPRIATE ACTION IN REGARDS TO APPOINTING INTERIM FINANCE DIRECTOR

Interim City Manager Melissa M. Guerra recommends to Council to appoint Account Specialist Edgar Castillo as the Interim Finance Director. Interim City Manager Melissa M. Guerra states that Mr. Edgardo Castillo has been working in the Finance Department assisting the Finance Director for 6 years and will be receiving his bachelor's degree in business administration in December 2021.

Mayor Pro Tem Sofia Morones states that in her 10 year term as a Councilmember an Interim is someone who is temporary until a full time person is hired for the open position. Interim City Manager Melissa M. Guerra stated that she was appointed Interim City Clerk seven (7) years ago and became the official City Clerk within 90 days of her appointment.

Councilor Mario Ruiz states that Edgar Castillo was hired as an IT and not for the Finance Department and recommends advertising for Finance Director position.

Councilor Mario Ruiz asks if there has ever been an Interim Finance Director in the past. Interim City Manager Melissa M. Guerra states that there has been an Interim Finance Director in the past and eventually became the full time finance director within 90 days. Council Mario Ruiz requested the minutes in regards to the Interim Finance Director appointment.
