## City's Manager Monthly Organization Update

The City in partnership with the South Texas Blood and Tissue Center will be hosting a Convalescence Plasma Drive on December 13, 2020 at the Civic Center.

The Head Start/Early Head Program will no longer be operating effective January 1, 2021. A new grantee will be taking over with a new lease agreement.

The long-standing gas leak located on the corner of  $13^{th}$  and Oak has been repaired and there is another contractor addressing the leak on  $2^{nd}$  Street. As these projects are completed the Council will be updated.

The construction has begun on the addition of the new Utility Kiosk located at the drive thru at City Hall and is expected to be completed in December.

The draft for the First United Methodist Church parking lot is completed however staff is waiting on review and input from the legal staff from the Church.

The RFQ related to the NAD Bank Increased Water Distribution Services, was released and the deadline is December 4, 2020. The leadership team will be reviewing and scoring the RFQ's in the next couple of weeks.

City Manager Ronnie J. Guest, Jr. states that since there has never been an official Grand Opening for the Carrizo Springs Civic Center, he would like to schedule it for January 9, 2021.
