RESOLUTION NO. 24-41

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHIPLEY OF WASHINGTON COUNTY, FLORIDA, ADOPTING THE FINAL MILLAGE RATE FOR FISCAL YEAR 2024-2025; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Chipley of Washington County, Florida, on September 30, 2024, adopted the Fiscal Year 2024-2025 Final Millage Rate following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the City of Chipley of Washington County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Washington County has been certified by the County Property Appraiser to the City of Chipley as \$193,401,731.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chipley of Washington County, Florida, that:

- 1. The Fiscal Year 2024-2025 final operating millage rate is 7.0000 mills which is more than the rolled-back rate of 6.7030 mills by 4.4300%.
- 2. This resolution shall take effect immediately upon its adoption.

RESOLUTION NO. 24-42

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHIPLEY OF WASHINGTON COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2024-2025; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Chipley of Washington County, Florida, on September 30, 2024, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, at the said public hearing it was publicly announced that the proposed millage rate is more than the rolled-back rate of 6.7030 mills by 4.4300%; and

WHEREAS, the City of Chipley of Washington County, Florida set forth appropriations and revenue estimates for the final budget for Fiscal Year 2024-2025 in the amount of \$18,967,980; and

WHEREAS, the City Council's intent to adopt a final millage and budget at a final public hearing and the required budget summary was properly published on September 25, 2024.

- 1. The Fiscal Year 2024-2025 Final Budget be adopted.
