A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHIPLEY OF WASHINGTON COUNTY, FLORIDA, ADOPTING THE FINAL MILLAGE RATE FOR FISCAL YEAR 2026-2027; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Chipley of Washington County, Florida, on September 25, 2026, adopted the Fiscal Year 2026-2027 Final Millage Rate following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the City of Chipley of Washington County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Washington County has been certified by the County Property Appraiser to the City of Chipley as \$226,924,221.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chipley of Washington County, Florida, that:

1. The Fiscal Year 2026-2027 final operating millage rate is 7.0000 mills which is more than the rolled-back rate of 6.6588 mills by 5.12%.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
CHIPLEY OF WASHINGTON COUNTY, FLORIDA, ADOPTING
THE FINAL BUDGET FOR FISCAL YEAR 2026-2027; PROVIDING
