# 2024 GENERAL ELECTION

Section C, Item 1.

- The 2024 General Election was held on Tuesday, November 5, 2024.
- 20 Senate seats and all 120 House seats were up for election.
- Liberty Partners was busy throughout the summer, meeting and interviewing candidates across the state.
- There were approximately 1,078,000 more registered Republicans than Democrats.

# FEDERAL RACES

---

- 1 U.S. Senate seat was on the ballot and Senator Rick Scott won re-election by over 12%
- The 2020 Census yielded Florida an additional Congressional District giving the state 28 seats in the U.S. House
- The Election resulted in **20 Republicans** and **8 Democrats** winning office

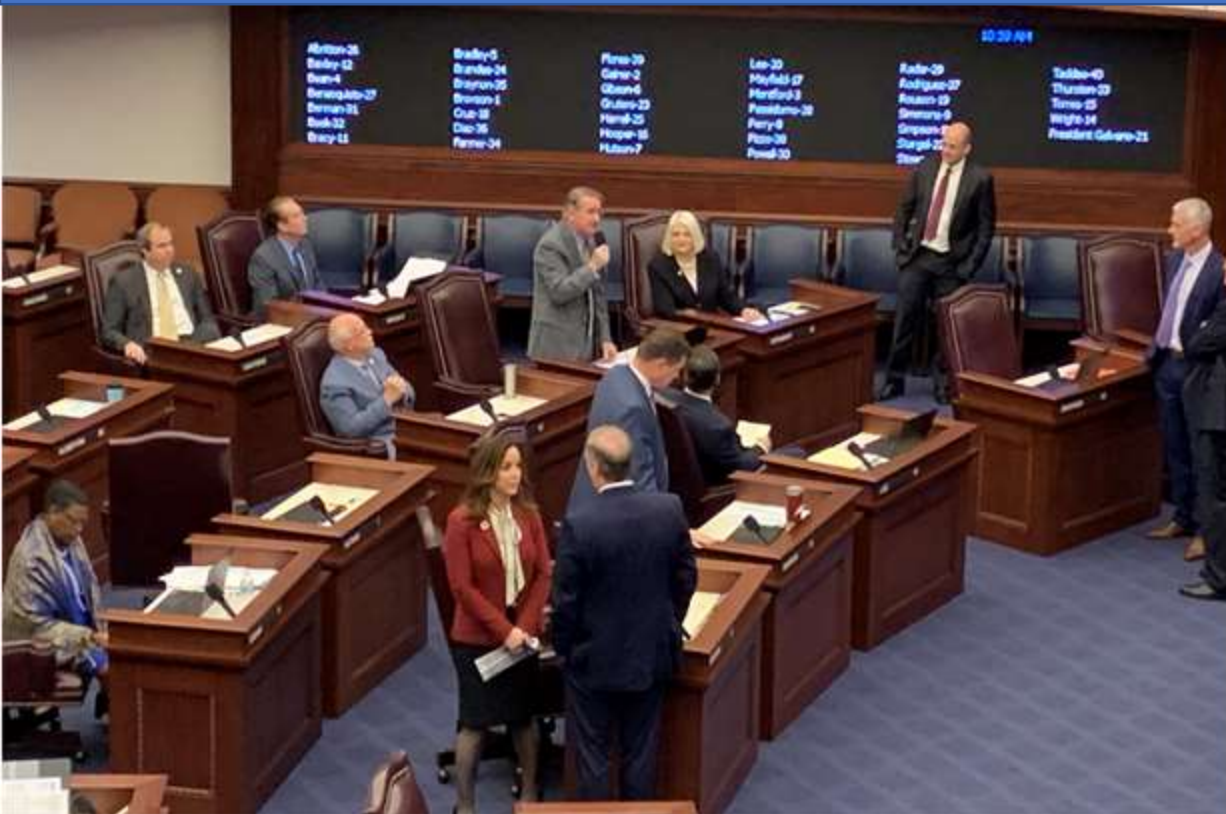

---

**Organizational Session:** Was held on November 19, 2024

- Senate President-Ben Albritton (R-Naples)
- House Speaker-Danny Perez (R-Miami)

**Interim Committee Weeks:** Began on December 2, 2024 and will continue through the end of February 2025.

**2025 Legislative Session:**

- Convenes on **Tuesday, March 4, 2025**
- Adjourns *Sine Die* on **Friday, May 2, 2025.**

# LEGISLATIVE DELEGATION MEETINGS

---

- **County Legislative Delegations** are comprised of bipartisan members of the Florida Senate and House of Representatives who represent each of Florida's 67 counties while in Tallahassee.
- The **Washington County Legislative Delegation** is scheduled to meet on Tuesday, January 7<sup>th</sup>, 2025 to hear from constituents prior to the 2025 Legislative Session.

# THE STATE BUDGET PROCESS

Section C, Item 1.

- Agency Budgets were due **October 15** and include Legislative Budget Requests (LBRs) detailing the amount of money needed to perform its functions.
- Governor's recommended budget due at least **30 days prior** to the start of Session and uses the LBRs to complete an overall budget recommendation.
- Each chamber passes an independent appropriations bill and the differences are then reconciled through the **budget conference process**.
- Conference report must be on the desk at least **72 hours** prior to the conclusion of Session per the Florida Constitution.
- Governor has either **7 days, or 15 days** upon receiving the budget to take action and has line-item veto authority (2/3 vote is needed to overturn any veto).

# AN APPROPRIATIONS PROJECT IS FOR

---

- Any local government or privately operated program or entity
- A transportation facility not in the DOT's 5-Year Work Program
- An education fixed capital outlay project not recommended by the Board of Governors or the State Board of Education
- A local water project
- A program, research initiative, institute, center or similar entity at a state college or university, not recommended by the Board of Governors or the State Board of Education



# HOUSE APPROPRIATIONS PROJECT REQUEST (APR)

---

Section C, Item 1.

- House Rules require all appropriation requests to have an APR form submitted and published by February 28.
- The House also requires the principal of the organization or entity to sign an attestation form confirming the accuracy of the APR that is due by March 7.
- No project will be funded at less than half of the requested amount.

# SENATE LOCAL FUNDING INITIATIVE REQUEST (LFIR)

---

- Senate Rules require all appropriation requests to have an LFIR form submitted and posted to the Senate website.
- There is no deadline for when a LFIR must be submitted by a Senator.
- The Senate does not require the principal of the organization or entity to sign an attestation form confirming the accuracy of the submitted LFIR form.
