#### **General Public Comments**

Philip Kabler, Chief Executive Officer of CDS Family & Behavioral Health Services, Inc., expressed gratitude for CTAC's sponsorship for the CDS Self-Care at the Fair event on September 20<sup>th</sup>, 11:00 am – 2:00 pm, at the Library Partnership Branch.

#### **Chair's Report**

Chair Cornell reported that the hiring process and interviews for Chief Financial Officer were successfully conducted, and Molly Greenwald will start September 15<sup>th</sup>. He also shared the new CTAC Podcast: Community Conversations: Real Talk. Real Impact kicked off last week at Tu Fiesta Radio. The episode will be airing soon.

## **Executive Director's Report**

#### Strategic Planning Update

Executive Director Marsha Kiner presented the timeline for the next steps in the strategic planning process. A series of follow-up workshops and sessions are scheduled for staff, the Board, and the community over the next coming months. Board members were asked to save the date on November 10, 2025, for a Board Workshop from 12:30 pm to 3:30 pm. A second Board workshop is tentatively planned for January 2026 to finalize the draft plan with final Board approval scheduled for February 2026. ED Kiner's goal is to have the plan completed by March 2026.

# Resolution No. 2025-08 Adoption of Changes to the Employee Handbook

ED Kiner outlined the adopted changes to the Employee Handbook. The Board discussed policy 4.60 Family Medical Leave and felt that there needed to be some criteria added for when an employee would be required to pay the Trust back for their insurance premium. Staff are instructed to develop parameters for when CTAC would or would not elect to have the employee pay. Member Pinkoson moved to approve Resolution 2025-08 adopting changes to the Employee Handbook with the exception of 4.60 section G. Member Certain seconded the motion, which passed by a unanimous voice vote.

#### **Old Business**

#### FY 2026 Budget Review

Chief Operating Officer Kristy Goldwire explained program funding changes and reductions to the FY 2026 budget in each Goal area. A detailed synopsis of revisions and changes to contracts was provided. The changes represent the difference between the proposed budget that was presented in June and the current tentative budget. Member Pinkoson suggested an addition of a column to be able to tell what the differences are for easier reading. COO Goldwire shed light on what led to Goal 2 being overbudget. Judge Wilson Bullard asked if the City of Gainesville was being funded through Youth Engagement. COO Goldwire informed her that the YMCA received those funds for FY24/25. ED Kiner clarified that Food for Kids funding came from unallocated funding, and not Emergent Needs. Judge Wilson Bullard asked if the \$150K allocation for the City of Gainesville was funding the Interrupter Program. ED Kiner informed her that the program is receiving rollover funds from this year in addition to the \$150,000 proposed for FY25/26 budget. The \$150,000 is a reduction. Judge Wilson Bullard questioned if the Violence Interrupters are receiving training and is interested in what sort of certifications they have. Judge Wilson Bullard shared that she is seeing an uptick in gun violence and wants to know exactly what the Violence Interrupter Program is providing. Member Certain reiterated her interest in data in correlation to TeensWork. Chair Cornell would like staff to compose a chair letter to the City of Gainesville requesting data and information and bring it back for the Board to review at the next meeting.

A draft Program Goal and Life Cycle overview was provided to the Board. Chair Cornell requested Board members receive the document as a "homework" assignment to review. The Board will discuss the overview further during the Strategic Planning process. ED Kiner considered the report a good first pass and will work with the strategic planners to bring back discussions on how CTAC will fund what it does and how it will be prioritized. ED Kiner thanked Research, Planning, & Evaluation Coordinators, Bonnie Wagner and Dr. Amy Wagner, as well as Belita James, Director of Program Operations, for compiling and working on this program draft. Chair Cornell commented that for its size, CTAC is doing 2-3 times more programs than others - heading into the strategic plan, this needs to be discussed. The Board will need to examine if it makes sense in year 8 of a 12-year special district. Research, Planning, and Evaluation Coordinator, B. Wagner, noted that only a third of the programs fall into only one Goal area. Almost half of the programs fall in all three Goals. In closing, Wagner expressed challenges categorizing the lifecycles of the organizations without more information.

The Regular Board meeting was paused at 5:01 pm for the first TRIM hearing.

The meeting resumed at 5:17 PM

Member Certain expressed concerns about how CTAC makes funding decisions, including which priorities to support and how much to allocate to each. She cautioned that funding mature organizations may create friction in the community, especially when established organizations are requesting CTAC funds based on defunding on the state level. Member Certain's dilemma is funding big organizations rather than small grassroots providers that need the support. Member Chance agreed. Dr. Hardt commented there is not an easy solution, but CTAC is here to spend these tax dollars the best way we know how on behalf of the children of this county. Dr. Hardt thinks CTAC is doing the best it can, and we can demonstrate that to the voters when it's time to renew. Dr. Patton wants to prepare providers seeking additional funds and agrees with supporting the smaller organizations. ED Kiner clarified that this was an exercise, and it does not mean that the smaller organizations will not be funded based on where they are in the lifecycles and Goal areas. ED Kiner does not want any providers to panic but to pay attention. Cornell referred to the summary page and asked for the dollar amounts of start-up growth to mature. Chair Cornell pointed out that staff's report shows nearly half of our funding is going toward providing a safe community. The Board agreed that the next step is for staff to work with providers and see if they agree with the goal assignments and then look at the allocation of dollars by percentage (staff and provider exercise). This information is to be provided at the strategic plan discussion. Member Pinkoson recalled that there were some areas where staff did not agree with the Board on priorities and requested staff feedback on those areas. Board members will take the Program Goal and Life Cycle overview and review it as "homework" in preparation for the strategic planning conversation. Member Chance inquired if any of these are driven by RFP cycles. ED Kiner – staff can provide board with background on how we got to these decisions.

## **Emergent Needs Fund Update**

Demetrica Tyson, Data Support Coordinator, provided a history and overview of the Emergent Needs Fund and described the providers and services that received those funds. Totals: FY 22-23 \$26,325.00; FY 23-24 \$49,330.73; FY 24-25 \$54,491.98 for a total of \$130,147.71. ED Kiner added that the Lil Sprouts Emergent Need was especially urgent due to the special needs population they serve. Member Certain was disappointed that the Family Church building was sold after CTAC paid for the AC. Pinkoson asked about the capacity building support that is offered to the providers that receive emergent need funds. Staff responded support is provided in a variety of ways for the applicants.

#### **Board Member Comments**

Member Chance commented that people from the community and families that work with the organization Food for Kids thanked her for CTAC's support of the program.

Dr. Patton thinks it is important to capture kids' thoughts on the programming – especially for when it's time for renewal.
