#### **Executive Director's Report**

#### 12. 2.12.2024 ED Report

ED Kiner shared her thanks to all those who assisted with our move to the new building, noted the successful launch of the 2023 Annual Report, and reported that the Trust was well represented at the national FACCT conference in December. She reminded the board about the RFP Workshop on March 25, 2024, and confirmed a BoCC Joint Meeting for May 6, 2024.

#### **Old Business**

13. Strategic Plan – Implementation Update (Kristy Goldwire)

Director of Program Operations, Kristy Goldwire updated the board on future funding opportunities currently being prepared for release. Under Goal 1, an RFP will be opened for Access to Comprehensive Care. CTAC staff is currently looking into existing and gaps in services in Alachua County. Other updates included partnering with the Early Learning Coalition to assist with costs of after-hours VPK, using unallocated funds as mini grants for additional mentoring programs, increasing the number of enrichment programs and partnerships to increase math and literacy proficiency, along with increasing the number of training courses available to providers.

Motion made by Vice Chair Cornell, Seconded by Member Andrew to approve the unallocated funds from RFP 2023-02 Youth Mentoring Program (around \$154,000) to be used as mini grants for the eight applicants that scored between 70-80%.

Motion was unanimously approved by voice vote.

Member Chance reminded staff to ensure the awarded programs understand that these Trust funds, are "capacity grants" and are one-time funds and non-recurring. The board suggested the creation of an FAQ document to communicate future funding processes and expectations to awarded providers.

#### **Presentations**

14. Children's Home Society – Community Partnership School & Wellness Program

Representatives from CHS, Becky Couch, Associate VP of Community Partnership Schools, CHS of Florida, and LaToya Jennings Lopez, Community Partnership School Director, Howard Bishop Middle School, presented to the board. They have received funding from the Trust for the HBMS Wellness Program, which offers wraparound support to children and families struggling with poverty, homelessness, hunger, mental health issues, and more. CHS brings together community resources to offer programs, initiatives, and engagement to minimize challenges to children's learning and academic performance. This model eliminates barriers for families to access services, which allows schools to concentrate on the core functions of education. Due to the allocation of Trust funds, 781 students received vital services, such as dental care, vision care, flu shots, and behavioral/mental health counseling. The board discussed the referral process and the potential of scaling the model to other Alachua

County schools. CHS shared that HBMS has been recognized as an accredited CPS, and thanked CTAC for their essential involvement.

#### **New Business**

15. Business Leadership Institute for Early Learning *V'Locity Masterclass and Accreditation Academy* Overview (Mia Jones)

Early Childhood Coordinator, Mia Jones updated the board on the success of the BLI program which supports local childcare providers with sessions in marketing, finance, human resources, and real estate in order to build business sustainability and high-quality care for children. It includes access to local mentors, industry forms, and a continuing education online platform. Participants create a business plan, receive feedback and recommendations from SCORE, and have the opportunity to continue on to apply for accreditation with APPLE or NAFCC. The first cohort began in 2022, and many local providers have taken part, leading to increased business revenue, increased teacher salaries and retention, increased enrollment, and an increase in accredited centers in Alachua County. The third cohort is currently in session, with graduation expected in June 2024.

Ms. Samantha Jamison has been an invaluable component of the Saving Smiles partnership with Howard Bishop Middle School (HBMS). She provides assistance in the School Based Sealant Program with HBMS, ensuring parents are aware of the preventative service offered and ensures as many children are signed up as possible. Last year she provided further assistance with connecting our program with key decision makers at the school to facilitate the first Saving Smiles restorative clinic over the summer so children identified in the sealant program were then able to receive needed care. With her support of our first HBMS Saving Smiles in June 2023, 47 children were able to receive dental care, totaling nearly \$7,000 at zero cost to families. We plan to continue our partnership and have our 2024 HBMS Saving Smiles scheduled for June. Thank you for considering the continued support of Ms. Jamison.

#### **Evaluation of Meeting Components:**





January 2024 Statements mark the four month of the Fiscal Year 2023-24, as such, budget to actual variances *should be* at 33%.

#### **Revenues:**

- The Ad Valorem revenues are based on the millage rate of .4612. The majority of Tax distributions have been received for FY 2024 88%.
- Interest received from the Prime account is \$252,665.44, and \$47.18 from the Tax
   Collector.
- Use of Fund Balance the CTAC Board opted to use \$5,386,958 from Fund Balance to complete obligations as budgeted.
- The Opioid Task Force budget of \$55,000 is comprised of; City of Alachua \$10,000, City of Archer \$10,000, City of High Springs \$10,000, City of Micanopy \$10,000 and City of Newberry \$15,000.
- The CTAC Board approved \$1,000,000 to transfer to Capital. This creates a corresponding expense in the General Fund.

#### **Expenses:**

- Personnel is at 28% due to one position recently filled.
- Grants & Awards FY 2024 Payments to providers are at 3% of budget without encumbrances. Though all funds have been allocated, contracts are still in the process of execution. Also, providers are being trained to use SAMIS for entering reimbursement requests. Providers have received or are in process of receiving their 25% advance payment.

Depreciation Expense – In November, CTAC purchased a building. The Depreciation
 Expense is amortized per policy over 40 years. Through end of January, three months
 have been recorded to ledger.

#### **SUCCESS STORIES**

The following is a success story shared for PACE Center for Girls; names have been changed to protect youth identity.

January was referred to Reach while in the Pace Day program to address and process the loss of her daughter. January successfully transitioned out of the program and into the GED program at Santa Fe college. January also held employment at Publix until a health condition kept her from working. This didn't stop her from continuing to work on her GED and her healing. January was highly engaged and with the support of her family, stepped into her grief head on. She learned coping skills such as grounding, thought stopping, and art therapy that helped to reshape unhealthy thought patterns. January decreased negative thinking and increased confidence, acceptance, and self-compassion. She improved interpersonal communication and took up journaling to increase self-love and feel closer to her daughter. Her determination, resilience, and growth extended into her family unit is to be honored and celebrated.

### **Requested Action:**

The Trust has been asked to discuss funding and the next steps.

### **Background**

The Trust was tasked with creating a Comprehensive Literacy Plan after a joint meeting in May 2023, with the Trust Board and the Alachua County Board of County Commissioners.

The staff convened a Comprehensive Literacy Planning Committee on May 30<sup>th</sup>, 2023. The planning committee includes representation from:

Alachua County School District United Way of North Central Florida

Alachua County Library Alachua County Campaign for Grade Level

Reading

UF Anita Zucker Center Florida Campaign for Grade Level Reading

UF Lastinger Center Greater Gainesville Chamber of Commerce

Early Learning Coalition of Alachua County University of Florida Literacy Institute

Gainesville Thrives Peak Literacy

Cuscowillia Nature and Retreat Center One Community Health and Wellness Center

The planning committee has convened by zoom on July 19, 2023, October 11, 2023, and January 24, 2024. Additionally, meetings have been scheduled for March 18, 2024, April 15, 2024, and May 20, 2024. The first three meetings discussed the purpose of the planning committee, work completed by the Alachua County Campaign for Grade Level Reading, who should be included in the plan development, literacy gaps from members perspectives, reviewed the research paper completed by Dr. Sunshine Moss, and attempted to determine next steps. It was determined that a comprehensive needs assessment was needed to help inform the development of a comprehensive literacy plan aimed at improving literacy achievement for all students. In October 2023, ED Kiner reached out to the UF Lastinger Center to begin a discussion about the plan development and a coordinator for the project. After several meetings, Lastinger agreed to facilitate a Needs Assessment and partner with the Comprehensive Literacy Planning committee.

The University of Florida Lastinger Center is a nationally recognized leader in researching and creating innovative learning and educational strategies to improve the well-being of children from birth through age 18. The Center's extensive expertise in researching, creating,

implementing, and evaluating educational initiatives results in improved teaching and learning that advances youth development.

The Lastinger Center proposes utilizing Asset Mapping and a Three- Phase plan for assessing the learning needs of educators and students in Alachua County Public Schools. The timeline for the project is February 1, 2024- June 30, 2024. The cost is \$175,000.

In addition, the Children's Trust is collaborating with Peak Literacy and the Alachua County School District to pilot Peak's Literacy program in one to two Alachua County elementary schools during the summer. Peak Literacy utilizes Great Leaps which is used in several Alachua County elementary schools and is an evidence-based program. Although the timeline is projected for six weeks in Summer 2024, the location, cost, and final scope are pending. All three organizations will be meeting with potential school principals in early March to determine participation, direction, and next steps.

This report is intended to provide an update on the activities of the comprehensive literacy planning committee, share the proposal from UF Lastinger Center, and share the pending pilot project concept with Peak Literacy.

## **Programmatic Impact:**

Goal 2 – All Children and Youth Can Learn What They Need To Be Successful

## **Fiscal Impact:**

The county pledged \$40,000 and the Trust pledged \$40,000 during the joint meeting last May. The proposal cost is \$175,000.

## **Recommendation:**

Request for a split of the cost from all parties (BoCC, the Trust, and the School Board). This would equal approximately \$60,000 from each entity.



## Background

"The ability to read fluently and for understanding...is perhaps the most important foundational skill for U.S. adult citizens' health, well-being, and social and economic advancement. It is a gateway to lifelong learning, education, and training" (Sabatini, 2015, p. 1). However, only 35% of fourth grade students in the United States read grade level material proficiently. Even more alarming is the discrepancy between white and black children with 45% of white children scoring at the proficient level or above compared to 18% of black children (NAEP, 2019). Illiteracy is arguably the single greatest challenge in education today given both the overwhelming number of students failing to reach grade level reading standards and the achievement gap for historically marginalized groups of children.

We are facing a perfect storm in the U.S. given the challenges of an existing literacy crisis, a global pandemic resulting in loss of academic engaged time, particularly for students from underrepresented groups, a lack of teacher knowledge in the science of reading, and a lack of evidence-based strategies for reading instruction in the primary grades. Although the pandemic has affected children and families of all backgrounds across the U.S., its impact has been far greater on children who are non-white and living in poverty. The achievement gap, which has been present for decades, has not improved over the past 50 years, and the pandemic has not only exacerbated the problem, but perhaps revealed the magnitude of this chasm.

This problem did not happen overnight, and it will take the efforts of all of us, researchers, policy-makers, teachers, parents, and the community to make up the ground we have lost due to a myriad of issues, not the least of which is systemic inequities in the education system. The University of Florida Lastinger Center works to create equitable educational systems where every child and educator, regardless of circumstances, experiences high-quality learning every day to support children's achievement of critical milestones that are predictive of success in school and life. Our research shows that a child who meets major





educational milestones, including reading proficiently by third grade, experiences the most success later on in life.

The UF Lastinger Center is committed to improving student outcomes by developing innovative solutions that can be implemented at scale with fidelity. Our own listening tour of the COVID-19 pandemic (see Zhao et al., 2020) and extensive literature reviews point to the need for a novel approach to improving reading outcomes across the country.

The Children's Trust of Alachua County will partner with the University of Florida

Lastinger Center for Learning (UFLC) to conduct a Comprehensive Needs Assessment to identify
the specific early language and literacy learning needs of each level of the Alachua school
district ecosystem: district personnel, school administrators, coaches, teachers,
paraprofessionals, school based staff, and students. The Needs Assessment data will inform the
development of a comprehensive professional learning plan aimed at improving student literacy
achievement for all students.

## Comprehensive Needs Assessment

The UFLC is a nationally recognized leader in researching and creating innovative learning and educational strategies to improve the well-being of children from birth through age 18. The Center's extensive expertise in researching, creating, implementing, and evaluating educational initiatives results in improved teaching and learning that advances youth development. An integral step in the program development process and later implementation is to identify the needs of the organization (i.e., district, schools, and community). To develop and deliver an educational program that results in improved outcomes for stakeholders, the partner organizations (e.g., Children's Trust of Alachua County, Alachua County Public Schools, and UFLC) must first be informed of the existing structure, including the strengths, assets, and limitations. The assessor initially identifies the assets and needs of the district. A need is the "discrepancy or gap between 'what is' and 'what should be'" (Witkin & Altschuld, 1995, p. 4). The "what is" is the current state, the "what should be" is the desired or expected outcome, and the gap is the identified need(s). UFLC must understand what needs to be targeted with





professional development in order to help achieve the desired situation (the "what should be"). A needs assessment is "a systematic set of procedures undertaken for the purpose of setting priorities and making decisions about program or organizational improvement and allocation of resources" (Witkin & Altschuld, 1995, p. 4).

In addition to identifying what is lacking, the UFLC will utilize Asset Mapping as a tool to "assess and mobilize what a community has" rather than what it lacks (Human Services Commission, 2013, p. 3). This technique: (1) uncovers resources found in a community; (2) relies on the assets within a community at a specific time; and (3) seeks to build linkages among local people, institutions, and organizations (Human Services Commission, 2013). Asset Mapping is not a needs assessment tool, but it provides UFLC with an additional approach to better understand their community (Berkowitz & Wadud, 2018).

UFLC will follow a Three-Phase Plan for assessing the learning needs of educators and students in Alachua County Public Schools. (see Figure 1). The first phase, Pre-assessment, is exploratory by nature and seeks to help prepare the needs assessment for implementation. Assessment is the second phase; data gathering and analysis occur during this phase. During the last phase, Post-assessment, the UFLC will help determine priorities and communicate the results to the district.

## Three Phases of the Comprehensive Needs Assessment

Phase 1: Pre-Assessment (Collecting Existing Data) Phase 2: Assessment (Collecting New Data) Phase 3: Post-Assessment (Determining Needs)

## Phase 1: Pre-Assessment

The purpose of the pre-assessment phase is to (a) investigate what is already known about the needs of the target group, (b) determine the focus and scope of the assessment, and (c) gain commitment for all stages of the assessment, including the use of findings for program





planning and implementation (Witkin & Altschuld, 1995). The pre-assessment phase also provides the beginning stages of collecting the most appropriate data sources for the foundational understanding of the target group and their community. UFLC will work with the Children's Trust of Alachua County and the district to form a Needs Assessment Committee (NAC). A NAC is a critical part of a comprehensive needs assessment. The committee should include stakeholders that represent all parts of the system: superintendents, district office staff, principals, teachers, paraprofessionals, school office staff, parents/guardians, community members, and students all have important information about the system. UFLC will collaborate with NAC to create a management plan, gather pre-existing information, and determine the appropriate needs assessment approach. Existing datasets are often available to help identify what certain needs exist as well as to identify target audiences and locate previously conducted programs and assessment information (Witkin & Altschuld, 1995). During the pre-assessment phase, we will collect data from internal and external sources as outlined in Table 1, Comprehensive Needs Assessment Activity Overview. The data points listed in Table 1 are not exhaustive of the possible data points that the UFLC and NAC may identify as useful to the process.

At the conclusion of the pre-assessment information gathering phase, UFLC will work in tandem with the NAC to determine any additional data that are needed and the assessment tool(s) that will be utilized. The group will identify gaps in the data, determine if sufficient qualitative and quantitative data are present, and consider whether additional information is warranted to triangulate the data.

## Phase 2: Assessment

UFLC will work with the NAC to select valid and reliable assessments to collect any missing information; surveys, focus groups, observations, and established standards-based curriculum measures may be utilized. A matrix will be used as an organizational tool to name the data measures, plan activities, and establish timelines for implementation. The UFLC will





work in coordination with the Children's Trust of Alachua County and the school district to employ equitable assessment practices such as consistently worded survey items, scripts, and trained interviewers who do not intentionally introduce bias into the data collection process.

## Phase 3: Post-Assessment

UFLC will compile and organize the data prior to facilitating analysis by the NAC. UFLC will utilize the School Reform Initiative Data Driven Dialogue Protocol to guide the NAC through the process of making shared meaning of the data. The protocol includes four phases that "help replace hunches and feelings with data-based facts, examine patterns and trends of performance indicators, and generate root-cause discussions that move from identifying symptoms to possible causes of student performance" (Teacher Development Group, 2002). Once the assessment data are analyzed, the UFLC will work with the NAC to prioritize the needs using a multiple criteria approach. A multiple criteria approach examines each need individually to gauge its importance and feasibility. The priority of each need is considered based on the level of risk it creates if unaddressed.

UFLC will provide the Children's Trust of Alachua County with a Final Comprehensive Needs Report. The report will include a description of the Comprehensive Needs Assessment process that transpired, the collected data with an analysis narrative, the prioritized needs as identified by the NAC, an executive summary, and UFLC's recommendations for specific strategies and activities that address the prioritized needs. UFLC will outline the Flamingo Literacy products and services that offer evidence-based solutions to the identified needs. The resources will include products and services from the UFLC and other evidence-based solutions.

## **UFLC Comprehensive Literacy System**

UFLC has a suite of literacy-focused programs designed to support educators at all levels of the educational ecosystem; instructional leaders, literacy coaches, teachers, and paraprofessionals. The professional learning supports are rooted in the science of reading and







provide educators with the foundational knowledge and skills necessary to provide high-quality literacy instruction. The Flamingo Literacy Matrix, Flamingo Small Group Literacy Instruction, and Literacy Coaching Program are examples of professional learning offered by the UFLC to equip educators with the knowledge and skills to teach reading effectively.

The **Flamingo Literacy Matrix** is an online professional development system built in partnership with Just Read, Florida! and the Florida Department of Education. It is an approved route to the Florida Reading Endorsement and satisfies the Dyslexia 40-hour renewal requirement. The systematic training prepares teachers to effectively teach reading, diagnose issues, and intervene appropriately using evidence-based strategies. Educators in Alachua County Public Schools can participate in the Literacy Matrix even if they have previously earned their Reading Endorsement; the Literacy Matrix provides educators with personalized learning paths based on their individual data results.

reading model developed by the UFLC to support both instructor development and student development. Instructors receive job-embedded support on the evidence-based strategies that comprise the science of reading. These strategies are integrated into one instructional model that is used in conjunction with a comprehensive reading program. After years of research and teacher focus groups, UFLC has identified key components that are necessary and sufficient to develop skilled readers (Lane et al., 2009; Pullen et al., 2005). Several factors, such as the intentional use of student data, an emphasis on grapho-phonemic (letter-sound) information, and the use of a variety of text, distinguish this model from other popular models and improve student outcomes. The model includes daily vocabulary instruction that builds background knowledge and increases comprehension; this is of particular importance for striving readers.

The **Flamingo Literacy Coach Endorsement Program**, built in partnership with Just Read, Florida! and the Florida Department of Education, is an online program created to equip literacy coaches with the skills, expertise, and resources to support educators and improve literacy outcomes for all students. The program is grounded in the science of reading and effective literacy coaching practices as outlined in the Florida Department of Education Literacy





Coaching Definition, Domains, and Standards (FDOE, 2022). This endorsement program also includes a unique online feature: Literacy Coaching Playbooks, a suite of resources for literacy coaches to use in their work with educators. Each playbook provides Literacy Coaches with resources that align with the Big 5 domains of reading development identified by the National Reading Panel Report of 2000, with two separate decoding playbooks to differentiate instruction for early and advanced decoding. The six Flamingo Literacy Playbooks are Phonological Awareness, Early Decoding, Advanced Decoding, Fluency, Vocabulary, and Comprehension. The UFLC developed the Flamingo Literacy Playbooks to ensure that Literacy Coaches have evidence-based literacy content at their fingertips when providing job-embedded support to educators. Additional literacy-focused professional learning programs are available specifically for school district personnel and school administrators.

Tables 1 and 2 included below outline the specific activities, events, and timeline for each phase of the Comprehensive Needs Assessment process.

## Project Background

Since 2020, Peak Literacy has helped K-12 students who are behind in their literacy development to quickly catch up to their peers through short daily reading and math lessons, supported by encouraging volunteer coaches. Our methods are data-driven and use the Great Leaps software, making it easy to track student progress and report outcomes. On average our students see 1.2 years of reading level growth in just 12 weeks.

We partner with schools, parents and after school programs to implement the program in ways that work for parents, students, teachers and administrators.

We believe strong literacy skills are the key to students being able to succeed and gain equity in our society's educational, social and economic systems. Building a strong foundation for lifelong reading and math skills creates a strong foundation for life!



## Alachua County Schools



## **Alachua County**

Peak Literacy was initially started after learning about the achievement gap in Alachua County. This is our home and we want to see it thrive! We believe our program can go a long way toward closing this gap by targeting students who are behind, giving them a way to catch up and take their place as active agents of their own education.


## **Implementation**

Every school is unique and our planning process involves working with administrators, teachers and other stakeholders to determine how our program can be implemented to serve students best. In general, we have three implementation approaches:

- <u>During the School Day.</u> Small groups of students are taken to a dedicated space for 15 minutes during their school day to meet with their tutors and complete lessons.
- <u>After School Program</u>. Students complete their lessons during an an afterschool program; we facilitate with help from staff.
- At Home. Students meet their community tutors online after school from home.

Each method of implementation has benefits and drawbacks, but all can be successful. Hybrid implementations are also possible. The decision ultimately depends on a number of factors specific to the school we are working with.





## Alachua County Schools



## **Our Proposal**

Our desire is to implement Peak Literacy's program at one of Alachua County's elementary schools, singling out 40-50 students who are farthest behind in their reading skills (likely 3rd-5th graders). Assuming we can start working with these children in January, we anticipate an average growth of 1.2 years of reading skills or more by the beginning of April. We will also teach math fact fluency along with reading.

Focusing the program in this way would prioritize helping the children who need it most while bringing the largest possible short term boost to the school's FAST and BEST scores. It will also serve as a pilot program that can be expanded and built upon once its successes are proven.

## **Requirements for Success**

Any successful implementation requires strong buy in from school administrators and teachers to work with our director and volunteers, make necessary student data available, and be responsive to the program's needs.

We also require partners to work with us to cover program costs.

Conversations to add Porter's Community Center and Pineridge Community Center to the Community Navigator's route are under way.
  - ii. Expansion consultant to support growth and sustainability at the new east Gainesville location, One Community Health and Wellness Resource Center and Willie Mae Stokes Community Center in Micanopy, FL.
  - iii. Trust staff are also finalizing contracts for Resource Center staff funding for One Community Health and Wellness Resource Center and Willie Mae Stokes Community Center.
