6. June 2023 Programmatic Award and Expense Report

Member Labarta requested that staff add a column to the report that shows the percentage of expected expensed funds to date per program, and a notation of why they are at that percentage. She also requested that future reports show a closed month of balances, instead of pulling the data in accordance with meeting publishing deadlines.

Motion by Member Cornell to receive the report and make these changes by the next meeting, Seconded by Member Labarta.

Motion was unanimously approved by voice vote.

7. 3rd Quarter Income Statement & Balance Sheet

Member Labarta requested that future reports show a closed month of balances, instead of pulling the data in accordance with meeting publishing deadlines.

Motion by Vice Chair Pinkoson to receive the report with modifications, Seconded by Member Labarta.

Motion was unanimously approved by voice vote.

10. FY23-234 Tentative Budget

Director of Finance Diana Sanchez provided updates to the budget based on current values and board comments from the June board meeting. These included updating the ad valorem taxes, interest rates, funds for capital projects, and for the literacy initiative collaboration in Alachua County.

Member Cornell moved to receive the report, Vice Chair Pinkoson seconded for discussion.

Vice Chair Pinkoson requests to schedule a budget workshop before the next board meeting on August 14, 2023. Members Labarta, Cornell, and Hardt agreed with the need

for further discussion. It will aim to address the strategy of spending funds from the reserved Fund Balance, questioning the spending of non-recurring money on recurring programs, a reasonable balance to maintain and how it will work operationally, the possibility of trending data over time, and the importance of ensuring these decisions are in line with the CTAC Strategic Plan.

# Motion by Vice Chair Pinkoson to 1. Accept this report; 2. Set a meeting and provide presented documents with the most current information; and 3. Ask staff to contact the county property appraiser for the tentative expectations of ad valorem in 2024, Seconded by Member Cornell.

Motion was unanimously approved by voice vote.

Members agreed to hold the workshop directly prior to the next board meeting on August 14, 2023, at 1:15 pm.

11. Final Products of Listening Project (Bonnie Wagner)

CTAC's Research, Planning, and Evaluation Coordinator Bonnie Wagner reported on the developments to further share the results of the listening project back to the community, express gratitude for participants, and incite data into action. One-pagers were created for different audience types (Parents, Youth, and Providers), included an executive summary, and room to incorporate action plans to drive what we do as a Trust.

#### Motion made by Member Cornell to receive the report, Seconded by Member Labarta.

Motion was unanimously approved by voice vote.

12. Early Learning Collaborative (Mia Jones)

Early Childhood Coordinator Mia Jones updated the board on the Early Childhood Learning Collaborative Call-to-Action meeting, the Head Start Summer Bridge contract, Socio-Emotional Development funding, and the next steps for expanding the early childhood learning collaborative system.

# Motion made by Member Cornell to receive the report, Seconded by Vice Chair Pinkoson.

Motion was unanimously approved by voice vote.

13. Recommendation for Award – RFP 2023-01 Afterschool Programming (Kristy Goldwire)

This RFP was released May 12, 2023, with a submission deadline of June 16, 2023. There were eleven applications. These were reviewed and six were found to be responsive and met the criteria to be recommended for funding.

Motion made by Member Cornell, Seconded by Member Labarta to approve staff's recommendation to award the contract for RFP 2023-01 Afterschool Programming, in the amount of up to \$1M and authorize the Executive Director to negotiate and execute agreements with Kids Count in Alachua County, Gainesville Area Community

# Tennis Association, Boys and Girls Club, Girls Place, Deeper Purpose, and Gainesville Circus Center.

Motion was unanimously approved by voice vote.

14. Youth Mentoring Program RFP 2023-02 (Deon Carruthers)

Contract Manager Deon Carruthers presented the overview of the Youth Mentoring Program RFP 2023-02. The release date is set for July 13, 2023, with a submission deadline of August 17, 2023. The allocated budget is up to \$500,000 with each applicant able to apply for up to \$75,000 in funding. The one-year contracts will begin on October 1, 2023. Member Labarta requested that if an applicant offers group sessions (combined with one-on-one or as stand-alone), a documented evidence-based approach to mentoring be included in the evaluation criteria (these may be found online in an evidence-based practice repository). The board also agreed that those who don't meet this criteria may be considered for innovation funding.

Motion made by Member Cornell, Seconded by Vice Chair Pinkoson to approve the release of the Youth Mentoring Programming RFP 2023-02 with modifications as above, to authorize up to \$500,000 in funding, and authorize the Executive Director to appoint a review team of members with subject matter expertise.

Motion was unanimously approved by voice vote.

#### CHILDREN'S TRUST OF ALACHUA COUNTY RESOLUTION 2023-10 YOUTH MENTORING PROGRAM RFP 2023-02

**WHEREAS**, the Children's Trust of Alachua County (CTAC) developed and approved Resolution 2020-12, Procurement Policies; and

WHEREAS, the Trust seeks to fund providers to offer youth mentoring services via oneon-one mentor/mentee matching and character-building group activities to elementary, middle or high school youth. Organizations will recruit, train, screen, support, and supervise adult mentors, who will be matched with youth.

Qualified applicants will focus on supporting pressing community needs, that provide services within a best practices framework, that are collaborative and integrated mentoring support programs with outcomes to reduce juvenile delinquency, truancy, drug abuse, victimization, and other high-risk behaviors.

WHEREAS, the Trust is required to approve the scope of service, minimum qualifications, evaluation criteria, and the review team,

**NOW THEREFORE**, be it ordained by the Board of Children's Trust of Alachua County, in the State of Florida, as follows:

**SECTION 1:** <u>ADOPTION</u> The scope of service, minimum qualifications, evaluation criteria, and review team attached hereto as Exhibit "A" is hereby adopted in its entirety as provided in Exhibit "A" and incorporated herein by this reference.

**SECTION 2:** <u>EFFECTIVE DATE</u> This Resolution shall be in full force and effect from July 10, 2023 and after the required approval and publication according to law.

# SECTION 1: <u>ADOPTION</u> "2.55 VETERANS' PREFERENCE" of the Children's Trust of Alachua County Employee Handbook is hereby added as follows:

#### 2.55 VETERANS' PREFERENCE (Added)

When selecting applicants for initial interviews, education, training, and experience shall be considered along with Veterans' Preference in accordance with Chapter 295, Florida Statutes and Chapter 55A-7, Florida Administrative Code.

- A. <u>Applicants who have indicated Veterans' Preference on their employment application and meet</u> <u>the minimum qualifications listed in the position description will be identified by Human</u> <u>Resources.</u>
- B. <u>Applicants requesting Veterans' Preference will be required to submit the required Veterans'</u> <u>Preference documentation.</u>
- C. <u>Those applicants determined to be eligible for Veterans' Preference will be given special</u> <u>consideration at each stage of the employment selection process.</u>

#### **Summary of Board Meeting Evaluation Surveys**

Per Board Policy 1.15, each meeting Board members will have the opportunity to evaluate the effectiveness and efficiency of meetings and provide suggestions on how to improve and best use time during Board meetings. The following is a summary of the input Board members provided for review by the Board, CTAC staff, and members of the public regarding the most recent Board meeting.

Date of Meeting:	July 10, 2023
Completion Rate:	89% of Board members completed (8 of 9) <sup>1</sup>

#### **Evaluation of Meeting Components:**

Board members rate the effectiveness and efficiency of four meeting components from 1 to 4. A rating of 1 = "*poor*", 2 = "*fair*", 3 = "*good*", and 4 = "*excellent*". All meeting components received favorable ratings of either "good" or "excellent". "Materials Provided", "Meeting Facilitation", and "Presentations" received higher-than-average ratings, while "CTAC Staff" was rated lower-than-average. Appreciation and positive feedback were expressed for staff and the Listening Project communication products. Board members offered specific suggestions and advisement in their "General Comments" regarding fiscal, information management, and outcome measurement.



The Academy facilities consist of two buildings. The main building is a two story forty thousand square foot building which the Academy preschool occupies the first floor. The second academy building is a five thousand square foot modular trailer with six academic and infant care rooms serviced by six Bard wall AC units. In the month of April 2023 one of the eight roof top AC units in the Academy main building failed and cost \$35,000 to replace which drained our capital expenditure maintenance budget and emergency operating reserve for fiscal year 2023. Two weeks ago, one of the Bard wall units in the modular trailer failed forcing the Academy under DCF guidelines to close the modular unit and move the affective children temporarily into the main facility due to the inability to maintain proper room temperatures under DCF guidelines. The blessing we experienced is that VPK classes have just ended for the summer, and we don't need to re occupy the modular building until early August. We have ordered two replacement Bard wall units at the cost of \$16,518 each to replace the current failed unit and to prepare for a second pending failure. (See signed order below). The total cost of both replacement high efficiency units with installation will be \$33,036. If we fail to fund this emergency request the Academy will not be able to re-open the modular unit which anticipates housing thirty VPK students and twenty infants for the fall of 2023. In addition, should we not reopen the modular building the impact of loss income may force the closure of the whole Academy preschool business and could result in fifty-five additional children and families seeking other day care options.

Thus, we are requesting an emergency grant form the Children's trust in the amount of \$20,000 and we will seek to raise the additional \$13,036 from The Family Church congregation which has provided financial support to the Academy when financial difficulties occur. However, as you review our attached 2023 budget you will find we are already projecting a worse case (-\$560,518) loss in 2023 if we fail to increase the number of children, we accept into the Academy preschool by the end of fiscal 2023. Our long-term goal is to become significantly sizable to accept one hundred and fifty children ages infant to VPK age level by end of fiscal 2023 which is obtainable if the emergent modular facility AC repairs can be made and be brought back on line by the start of the fall school year.

What steps have you taken to resolve the need on your own?

The Academy has taken multiple steps to resolve this issue moving forward.

1. For the long term the Academy modular facility has six Bard AC wall units. Replacing two of them will leave four more in need of eventual replacement. We are preparing for a 2024 capital fund raising campaign to raise an additional \$66,000 in congregational donations to replace the aging units.

2. We have signed an AC system maintenance agreement with A+ Air Conditioning service to do routine maintenance on the existing functioning units to extend their usable life.

3. We have negotiated a purchase agreement with A+ for the two new units that we will not have to pay for their purchase price until after thirty days of installation which will give us time to raise the additional \$13,036 needed should we receive the Children's trust grant for \$20,000.

4. Not wanting to do this because it's so difficult to retain quality day care staff but we may lay off several staff members for the summer in hopes that they will return for the fall which may save us \$4000-\$5000 towards the AC purchase should we not receive the Children's Trust grant funding.

5. We are announcing to The Family Church congregation and elders that we are applying for the Childrens Trust grant in the amount of \$20,000 and that we need to raise another \$13,036 from the church members. We hope this excites the membership into contributing generously to the cause.

How has the emergent need impacted your service delivery?

The immediate impact on the Academy daily operations has been minor so far because the VPK classes are off for summer vacation, and we have moved the existing affected infant room over to the main facility. However, we had to delay the immediate opening of a new one year old classroom in the main facility which has affected nine families on the current waiting list for space in the new one year old class. Starting in early August 2023 the planned new operation classroom management structure for the modular facility will be:

i. Infants-3 rooms with 20 total babies (modular facility)

ii. One-year olds-3 rooms with 18 total students (main facility)

iii. Two-year-olds-3 rooms with 30 total students (main facility)

iv. Three-year-olds-3 rooms with 40 total students (main facility)

v. VPK-2 rooms with 2 full classes and one part time class with 30 total students (modular facility)

vi. Total projected number of Academy children for fall (138 children).

Basically, we have sixty days to get the modular facility back up and running or the Academy will be unable to offer VPK classes for the fall and approximately sixty children from infants to VPK will have to find other day care facilities. This may cause significant income losses to the Academy and may force our eventual closure if we can not raise enough donations from the Family Church congregation to offset the losses and reluctantly, we have to lay off our projected thirty-eight fall employees. The emergent grant support from the Children's Trust of \$20,000 will prevent this from happening and we are confident by sharing this community support the Family Church Congregation will rise to the occasion to raise the additional \$13,036 needed to complete the repairs in time.

#### SUCCESS STORIES

Success story shared by Partnership for Strong Families-Family Resource Center

A single mother of one teenager, is a regular visitor at one of our Family Resource Centers During her first visit, she was very quiet, did not interact with other patrons, and was very reticent to share any information with staff about her situation. She was provided with a couple items of ready-to-eat food as she appeared to be unhoused. She eventually began to speak about her life with staff and disclosed that she and her teen son were homeless, living in a truck belonging to a friend, which did not run. She had lost her job and they had no income or natural support system in the area. She has visited the FRC on many more occasions, building trust with staff and opening up about her needs and goals. Throughout her time visiting the FRC, her food stamps have been reinstated, she has received various concrete supports, has received assistance with completing a housing application, and support job searching, including bus passes to attend interviews. Most importantly (according to her) she gained a community, all of whom celebrated with her on June 30th, when she received a job offer! She continues to come to the FRC for various activities and shares with others about her success with others.

# Sunshine Law

## • Florida Constitution, Article 1, Section 24:

– All meetings of any collegial public body of the executive branch of state government or of any collegial public body of a county, municipality, school district, or special district, at which official acts are to be taken or at which public business of such body is to be transacted or discussed, shall be open and noticed to the public...

### Section 286.011, Florida Statutes:

– All meetings of any board or commission of any state agency or authority or of any agency or authority of any county, municipal corporation, or political subdivision, except as otherwise provided in the Constitution, including meetings with or attended by any person elected to such board or commission, but who has not yet taken office, at which official acts are to be taken are declared to be **public meetings** open to the public at all times, and no resolution, rule, or formal action shall be considered binding except as taken or made at such meeting. The board or commission must provide reasonable notice of all such meetings

# Sunshine Law

- Applies to all governmental collegial bodies.
  - Is also applicable to advisory committees created by public agencies are subject to the Sunshine Law even if their recommendations are not binding

## Sunshine Law Meeting

- Communication between two or more members of the same committee
  - Topic: any matter that may foreseeably come before their committee for action
  - Forum or medium: in-person, telephone, email, text,
     Facebook (et al.), third party conduit



## Sunshine Law Requirements

  - Open to public;
  - Reasonable public notice (see law on independent districts;
  - Minutes taken and promptly recorded; and
  - Opportunity for public comment before issues are decided – public participation in decision making process.

- Open to public requirements
  - Within Alachua County (public buildings)
  - No physical or psychological barriers
  - Inaudible utterances
  - Right to record

#### Sunshine Law Notice

- Reasonable notice requirements
  - Name of board/committee (not topics)
    - No agenda needed
  - Location & time
  - Manner of advertisement
  - Lead time special districts have specific requirements



#### Sunshine Law Minutes

- Minutes requirements
  - Written
  - Promptly recorded
  - Includes votes, action & significant discussion

#### Sunshine Law Participate & Be Heard

- Participate & be heard requirements
  - At some point during decision-making process
  - W/i reasonable proximity to official action
  - Subject to reasonable rules of conduct

## Public Records Law

Section 119.07(1)(a), Fla. Stat.

Every person who has custody of a public record shall permit the record to be inspected and copied by any person desiring to do so, at any reasonable time, under reasonable conditions, and under supervision by the custodian of the public records.

Public Records Law What is a public record?

- Content, not the medium
  - Record made or received in connection with official business
  - Used to perpetuate, communicate or formalize knowledge
- Not limited to written documents



Public Records Law What is a request?

- Any sufficient to identify records desired
  - Need not be in writing (telephone, in-person)
  - May not require requester to identify self
- Existing record
  - Does not mandate creation of new record

- Responding to request
  - CTAC Administrative Procedure, "Public Records"

## **Voting Conflicts**

#### Section 112.3143, Fla. Stat.

... any measure which would inure to the officer's special private gain or loss; which he or she knows would inure to the special private gain or loss of any principal by whom the officer is retained or to the parent organization or subsidiary of a corporate principal by which the officer is retained; or which the officer knows would inure to the special private gain or loss of a relative or business associate of the public officer ...

### Voting Conflicts

 If you are present, there is a statutory requirement to vote. Sec. 286.012, Fla. Stat. If you are present, you <u>must</u> vote.

#### EXCEPT

 An individual <u>shall</u> abstain from the vote if there appears to be a conflict of interest under Secs. 112.311, 112.313 or 112.3143, Fla. Stat. (Sec. 286.012, Fla. Stat.)



11. Update of Strategic Plan

#### **PROJECT BACKGROUND:**

In November 2022, The Children's Trust of Alachua County (CTAC) contracted with Seek Higher Ground to complete a strategic planning process that was already underway. Nikki Martin-Bynum and Vashti Rutledge facilitated the process for six months. This resulted in a set of considerations from the Strategic Planning Committee that should be considered when releasing proposals.

#### **PROPOSAL CONSIDERATIONS:**

- CTAC's Board of Directors expressed that literacy and math skills are foundational to Goal 2, All Children and Youth can learn what they need to know to be successful. As such, consider how to intentionally and peripherally encourage programs to contribute to enhancing literacy and math skills. For example, one participant noted, there could be bonus points awarded for mentoring and character-building efforts that contribute to math and/or literacy gains.
- Since there is overlap across goals, each RFP will need to clearly define it's targets for impact. Be prepared to address questions regarding programs and organizations whose services impact several areas. Example: An existing provider asked if physical activity was not being considered because while physical activity aligns with healthy lifestyles it was not explicitly stated.
- Consider holding information sessions to provide opportunities for prospective applicants to understand both the intent of each RFP and what scope of programs or services will align with CTAC goals. Be prepared for questions and challenges for areas no longer aligned with the strategy (ex. food access).
- CTAC will need to develop a strategy to ensure funded agencies represent the diversity of Alachua County including both urban and rural communities. This could include mapping how funding is concentrated throughout the county to ensure all areas are represented.
- CTAC will need to develop a strategy to ensure that services are available for all families prenatally through age 18. The Steering Committee was committed to investing a larger percent of resources in the maternal child health/early learning space for younger children. However, they noted that there also needs to be supports for children of all ages. Staff will have to be intentional to create a balance between younger children and older children.



# **PROJECT BACKGROUND:**

In November 2022, The Children's Trust of Alachua County (the Trust) contracted with Seek Higher Ground to complete a strategic planning process that was already underway. Nikki Martin-Bynum and Vashti Rutledge facilitated the process for six months and offer the following recommendations to support the ongoing work of the Trust.

## **RECOMMENDATIONS:**

### **Community Engagement**

- Messaging progress on the plan to partners, at minimum annually
- Create space and access for parents to provide feedback on plan progress
- Integrate Participatory Grantmaking practices into your grantmaking process

### Convening

Define its role as a "Convenor" - when will CTAC lead versus participate. To align with the plan's commitment to participate strategically with system partners and community members for each goal, CTAC will need to review current staff capacity and possibly make adjustments.

### **Capacity Building**

- Intentionally resourcing BIPOC-led organizations
- Intentionally resourcing grassroots and small organizations
- Investing in additional capacity building

### **Organizational Values**

 Using the Guiding Principles, create Organization Values that uplift the commitment to just and equitable grantmaking. These can also serve to communicate to the public, who the Trust is, since it was noted the current Guiding Principles are difficult for some to understand.

### EXECUTIVE SUMMARY

In November 2018, Alachua County voters approved the Trust referendum by over 61% of the votes. As a Special Independent District with taxing authority, the Trust can levy up to .5 mill, resulting in annual estimated revenues of over \$8,000,000. The Children's Trust of Alachua County was established to provide children's services throughout Alachua County.

Last fiscal year over 18,000 opportunities for children and families resulted from the programs and services planned and funded byth e Children's Trust of Alachua County, more than double the previous year's reach. Following this tremendous growth in reach and impact, The Children's Trust began the process to assess their current impact and better understand the community's needs.

In September 2022, The Children's Trust commissioned a Listening Project to actively solicit the opinions of the community. The Listening Project had three major goals:

- Ensure that the Trust's various stakeholders have meaningful input into the Trust's strategic planning.
- Reveal findings that will allow the Trust to develop priorities and strategies to address the identified needs and gaps while utilizing and mobilizing existing community strengths and resources.
- Maximize the impact of Trust resources in addressing the needs of Alachua County children.

The results of the Listening Project have been incorporated into the Strategic Planning process through the thoughtful consideration of the Steering Committee. The Steering Committee is comprised of members of The Children's Trust Board of Directors, staff, providers, and community stakeholders. The Steering Committee has held regular meetings over the last nine months to review the results of the Listening Project, the Comprehensive Strengths and Needs Assessment, an environmental scan, and other supporting documents to guide their development of the new strategic plan.





The proposal was well written and thought-out on how we can provide much-needed assistance to young people that are struggling to gain their academic footing.

We would like to base our appeal on the following areas:

- A. One reason for our denial was missing documentation in the form of our latest 990 form which is attached and meets the required documents standards. Based on that document the RFP wasn't passed on for consideration.
- B. The Goal of The Children's Trust during this funding period was to create an opportunity to expand funding to support the rural Afterschool programs. Prior to the RFP there was six programs and those six programs only received funding. As a result, there was no expansion of programs at all. The Willie Mae Stokes Community Center would have expanded the number of rural programs funded by The Children's Trust from one to two.

The Executive Director of The Willie Mae Stokes Community Center has reviewed section three of the submission checklist and has provided all the requested documentation to include the attachments and the IRS form 990.

The impact of The Center not receiving the request of \$157, 034.00 will be tremendous. We would once again need to rely on volunteers and reduce the number of young people served. The result would detrimental to the Micanopy area and limit access to afterschool programs.

I would ask that you kindly review our appeal. And please allow our proposal to be reconsidered for funding.

#### **Background:**

Help Me Grow is designed so all children have the best possible start in life by providing free developmental and behavioral screenings. Families benefit as Help Me Grow listens to them, links them to services, and provides ongoing support.

On September 13, 2021, the Trust approved Resolution 2021- 13 authorizing the release of RFP 2021-07 Help Me Grow Alachua. The Trust recommended funding RFP 2021-07 to Children's Home Society of Florida on December 13, 2021. The contract was executed for fiscal year 2021-2022 on February 23, 2023. After several contract negotiations the renewed contract for fiscal year 2022-2023 was executed April 25, 2023. Help Me Grow Alachua was intended to be a 5-year renewal contract with implementation occurring year one. Supports that have been provided in year one and two are:

- Biweekly implementation meetings followed by monthly check in meetings.
- Assisted with sharing and posting job openings with other community partners.
- Worked collaboratively on marketing materials and guide with the Help Me Grow Florida team.
- Held contract review and work plan review meetings.
- Shared resource list, upcoming community meetings, and upcoming community events.
- Technical Assistance and training offered by Help Me Grow Florida
- Resources and team meetings with Help Me Grow Florida and the National Help Me Grow office.

As of August 4, 2023, this contract will not be renewed after September 30, 2023, for the following reasons:

- Leadership and staff changes that affected implementation of the program in year one and year two.
- Key components were never established and implemented such as establishing 211, health care provider outreach, and leadership team.
- They did not meet any of their performance measures in year one and are not on track to meet most of the performance targets this fiscal year.
