### Call to Order – Vice Chair Twombly called the meeting to order at 4:02 pm.

### Roll Call

<u>Board Members Present:</u> Cheryl Twombly – Vice Chair, Tina Certain – Member, Mary Chance – Member, Dr. Kamela Patton - Member, Lee Pinkoson - Member, Hon. Susanne Wilson Bullard – Member.

Board Members Attending Virtually: Ken Cornell – Board Chair, Dr. Nancy Hardt – Member.

A quorum of the Board was physically present. Motion made by Member Certain, seconded by Member Chance to allow Chair Cornell to parcipate virtually due to extraordinary circumstances. Motion passed by unanimous voice vote.

Member Pinkoson moved for approval of the agenda, seconded by Member Certain. Motion passed by unanimous voice vote.

Jamie Bass (Camp Manger, Alachua County BOCC - Cuscowilla Nature Center) gave comment about RFP scoring discrepancies. Vice Chair Twombly asked her comments be tabled until Agenda Item 12.

### **Executive Director's Report**

9. Executive Director's Report

CTAC Executive Director Marsha Kiner provided a recap of the CTAC Open House and Building Dedication on 3/29/2025 and expressed appreciation for all partners, staff members, and board members who contributed to the success of the event.

Introduced the new Parenting Playbook Resource Guide and the Program Handbook that are now available.

Lastly, ED Kiner shared her gratitude to the CTAC team who kept things running smoothly in her absence.

### Presentations

10. <u>BDO Engagement - Internal Controls and Fiscal Infrastructure Assessment</u> CTAC Chief Financial Officer Scott Sumner presented the assessment provided by BDO focusing on high-impact, low effort recommendations from the gap analysis. Some changes are already being implemented, such as separating duties for cash receipts and improving bank reconciliation processes. The assessment cost \$70,000, under the \$100,000 budget. The Finance Committee reviewed many of these items in detail. Board members expressed appreciation for the clear, easy-to-read reports provided by BDO.

### **Old Business**

11. Comprehensive Literacy Needs Assessment Report and Recommendation Overview CTAC Early Childhood Coordinator Mia Jones, joined by Mary Bratsch-Hines and Pam Chalfant from the University of Florida Lastinger Center provided the Board with the literacy needs assessment report that was first requested in May 2023. The report, developed through extensive community engagement, highlights the importance of early childhood education and identifies gaps in literacy achievement across different student groups. Key recommendations include enhancing awareness and coordination of existing resources, providing focused support for families, and expanding professional learning opportunities for educators. Staff requested the Board approve contracting a consultant to develop "Alachua Reads," a centralized hub for literacy efforts in the county. Member Certain expressed opposition to engaging another consultant to the same results. Certain further commented that the school district should have a central role in addressing reading disparities. Dr. Patton made comments to reiterate Member Certain's points and shared concerns about better using the resources that are already available to students and families. Chair Cornell commented in agreement with Member Certain with immense concern for the number of African American students not reading at grade level. ED Kiner explained the literacy plan development is a heavy lift for CTAC staff, and someone is needed to bring the necessary partners together collectively to move forward. Member Pinkoson commented on the K-3<sup>rd</sup> grade reading deficiency as well. Dr. Hardt agreed and stated that a consultant is needed for this educational and social plan. Chair Cornell wants CTAC to focus on age zero to 5 year/olds and the school district to focus on Kindergarten and up. Dr. Patton suggested replacing the terminology

of consultant to contracting someone to be the "backbone" for the collective impact. Vice Chair Twombly suggested a "facilitator"; agreeing that an additional person is needed to do this work. The board supported the overall recommendations, particularly emphasizing the need to focus on African American students and securing funding from various community partners for implementation.

Member Pinkoson moved the Executive Director bring this item back next month with a specific recommendation based on what was discussed and update the Board on the requested facilitator, seconded by Member Certain.

<u>Public Comment</u> – Aldrika Everett (Executive Director, Aces In Motion) commented that the same data is reflected in middle and high school students. It should be considered in the conversation as well. Carla Lewis (Greater Duval Neighborhood Association) commented that community organizations can help address this problem, educate community leaders, and aid in putting those resources back into the community. John Rollins (President and CEO, Motiv8u; Operations Director, North FL YMCA) likened the literacy needs to a vending machine, "If you don't fix the machine, it will stay out of order. Don't put money into a machine that is broken."

Motion passed by unanimous voice vote. The Board also agreed to extended meeting times to cover all necessary discussion items.

12. Recommendation for Award – Summer Camp and Freedom School RFP 2025-01 CTAC Director of Program Operations Belita James presented award announcements and the staff recommendation for the Summer Camp and Freedom School RFP. There were no applications for the new Freedom Schools. The staff recommended funding summer camps at \$1.91 million and one Freedom School at \$80,000, totaling \$2 million. Member Certain advised that she may have misinformed Hawthorne about the Freedom School expansion. ED Kiner responded that no one applied for Freedom School, so staff recommend funding for one that will be identified.

Member Pinkson moved to:

- Approve resolution 2025-03, Summer Camp and Freedom School RFP award recommendation,
- Authorize staff to negotiate and execute contracts with organizations that are within the approved board allocation, and
- Fund one freedom school, not to exceed \$80,000.00.

Additionally, any reserve money that has been saved through negotiations will continue funding subsequent programs in order. Member Certain seconded the motion; motion passed unanimously.

Member Pinkoson further moved that the balance fund all programs that scored up to 70 points for the next three years. Member Certain seconded the motion; motion passed by majority vote (1 dissent - Pinkoson).

### Public Comment

Carla Lewis (Greater Duval Neighborhod Association) voiced concern and the need to understand why her organization is not being funded this year. She also asked about the appeals process. ED Kiner responded that the Funding is in line with the strategic plan and CTAC's goals. The recommendation is based on and outlined in the RFP. ED Kiner stated that it is in the purview of the Board to increase the funding.

During public comment, Jamie Bass (Camp Manager, Alachua County BOCC - Cuscowilla Nature and Retreat Center) expressed her gratitude for CTAC funding received over the past three years and asked for consideration for her summer camp program. James Miller (Executive Director, Mirror Image Leadership Academy) explained why his camp has a shorter duration (4 weeks) and requested board reconsideration.

John Rollins (Interim Operations Director, North Central Florida YMCA) was unable to get an application in on time and requested reconsideration – will not be able to serve his students in Micanopy, Hawthorne and Archer without CTAC funding.

Board Member Comments:

Chair Cornell stated if there is a place to use some fund balance to focus on literacy for African-American students – he is ready to have that discussion.

Member Certain commented to consider an additional allotment for summer camps, as she knew this was going to happen. She also stated that she cannot support a late submission in response to the YMCA. Member Certain asked to amend the motion to have staff bring back a recommendation on funding organizations that meet the criteria versus increasing the allocation.

Member Pinkoson reiterated that when creating the Strategic Plan, everyone knew this day was coming – sacrifices are going to have to be made.

ED Kiner thanked the Board for being thoughtful and hearing the providers. She expected this conversation and believed the Board would go into the fund balance. The Strategic Plan provides direction, but there are times when you may need to go outside of the plan. She stated that there is no time to come back to this subject; the Board must make a decision today.

CFO Sumner shared that fund balance is roughly \$7 million dollars. There should be a five-year financial forecast for where the Trust is headed. Additionally, there needs to be some discussion with providers about how their programs are funded.

ED Kiner further commented that CTAC cannot be the sole funder. Moving forward, providers are going to have to find additional funders for their programs. Ms. Lewis responded that the Trust came to her when it was founded saying it is a way to provide programs, create jobs, and serve more children. She is confused that there are \$7 million dollars in reserves but the Trust is not funding \$300,000.00 for her program this year. As a taxpayer, she will be pusing back.

Dr. Patton thanked the Board for thinking through this item a bit more. She would rather CTAC fund a little less during the year when they have the kids during the day than in the summer when they don't have them and they may get into more trouble.

### **New Business**

### **General Public Comments**

C. Lewis thanked the Board for being fluid and thanked ED Kiner for sharing her thoughts on funding. She will be strategic over the next 3 years on how to get funding. Chair Cornell thanked her for attending and emphasized that Greater Duval is needed.

J. Miller also thanked the Board and staff for the reconsideration. This will make a major difference in the 74 scholars they are serving.

Izzy Brazzel (Gainesville Circus Center) gave thanks to the staff and board members for such a wonderful Open House event. Most of the children who performed were scholarship recipients. They felt engaged not only as circus kids, but also as CTAC kids. They are planning to wear their matching CTAC shirts together soon.





- Sorry for the lengthy meeting, but glad for the discussion. (Twombly)
- A really packed meeting agenda (Hardt)

### Items, Presentations, or other Information for future Board agendas:

- 1. I'd like to learn about national and state campaigns for grade-level reading that have/are successful in increasing 3rd grade reading scores. (Backbone organizations and their models).
  2. I'm interested in learning whether or not other Trusts prioritize zip codes with identified gaps in funding decisions (FL Chamber Gap Map). (Chance)
- Although I attempted to sign on about 15 minutes early, I had a few problems getting to the meeting. I did not have a link at first, and when it came, it did not have me as a panel member so I could not be seen at attendance time or early in the meeting. I sent a text to Scott who had someone put me on as a panel member. Having said that, it is amazing how well zoom works in Europe.

I thought there were some comments to be made about the report on literacy, but the conversation went off the rails a bit and I could not jump back in. Someone mentioned that few teachers were polled. I wanted to find out more about that. I was really struck by the large percentage of students who miss many days of school. I find it hard to blame the school system for that. We need to get to the bottom of it, though, because if children are not in school, how will they learn to read? The social issues underpinning the literacy results were sort of sidelined in the meeting once the discussion turned to weakness in the school system. I tried to express my opinion that we should not be so hard on the school system until our community's social programs support the 0-5 year olds who enter the school system with variable readiness to learn to read. Why don't we have more children in VPK? If I were a single mom with a job or two, a half day VPK program without transportation for my child would not meet my needs. We have discussed this before, but not taken enough action. Yes, the report covered lots of surveys, but I could not help wondering whether we had surveyed the right people. More people experiencing literacy challenges and more teachers trying to deal with them need to be heard. (Hardt)

## **Background:**

**City of Gainesville Community Development Grant:** Following marketing and promotion efforts for the TeensWork Alachua (TWA) program, the City of Gainesville approved a funding application submitted by the Children's Trust. The grant will fund summer internships for 40 TWA unduplicated youth from low- or moderate-income households. Participants will engage in the six-week program with a focus on developing their employability skills. Each youth will be compensated at \$13 per hour, for up to 25 hours per week over a six-week period.

**Lutheran Services Florida**: In FY 2021-2022, the Children's Trust Board designated the Trust as the fiscal agent for the Alachua County Opioid Task Force. The Task Force was created in response to the county's adolescent addiction and overdose rates ranking among the highest in the State of Florida. The task force is charged with raising awareness of the opioid and fentanyl crisis. The county-wide awareness campaign will target smaller, rural municipalities as well as the county's urban core.

Since its inception, the Task Force has leveraged dollars from the Florida Opioid Allocation and Statewide Response Agreement (Opioid Settlement) in Alachua County, via the management of LSF. Funding will be used to implement a full range of marketing strategies to educate Alachua County residents, an awareness campaign that utilizes community leaders in each municipality to identify targeted, unique strategies for communicating with residents in each municipality, social media, radio, television, billboards, and promotional material to assist residents in understanding the dangers and the proximity of this epidemic to Alachua County.

### SUCCESS STORIES

### Kids Count in Alachua County - After School Program Literacy Support Partnership

For the last 5 years, the *Kids Count in Alachua County* After School Program has partnered with UF student volunteers to provide tutoring and literacy instruction.

To date over 80 UF students trained in UFLI curriculum and reciprocal reading strategies have supported Kids Count's After School commitment to impacting the literacy needs of the children they serve. UFLI E 5 Curriculum, is designed to teach foundational reading skills to students, particularly in kindergarten through 2nd grade. The curriculum is structured with detailed lesson plans and various resources and activities to guide teachers through the various stages of learning.

To break down what this has meant for Kids Count participants this year: Since January 2025, UF student volunteers have dedicated close to 900 hours of one-on-one reading, tutoring and literacy support. Additionally, Kids Count Alachua was selected this year to pilot the reintroduction of the America Reads program through UF which included an additional 6 paid tutors that received supplemental training from the UF College of Education / UFLI on implementing the curriculum and utilizing resources, activities and games that support instruction and practice.

Kids Count's Program Director shared a story about two little boys, both currently in foster/kinship. As the year has progressed it has been noted that the boys have been turning to reading as their preferred method of calming down when they feel escalated. They have a wide range of tools to choose from (coloring, sensory toys, sitting with a teacher), but for the last several months they have been choosing to read!

### **Background:**

The Sunshine State Early Childhood Information Portal (The Sunshine Portal) is a comprehensive resource for early childhood data in Florida. The Sunshine Portal is a pioneering Early Childhood Integrated Data System designed to provide vital information from across the early childhood mixed delivery system. This data system includes information from health, education, financial, and social support sectors. The Early Childhood Policy Research Group (ECPRG), in collaboration with state and local agencies, leverages this data system to conduct research to enhance the well-being of young children and families across Florida. Through the Sunshine Portal, the ECPRG communicates research findings, providing in-depth data and visualizations at the community level. These insights into the lives of children and families are used by local, state, and national early childhood stakeholders.

Today, Dr. Herman Knoph from the Anita Zucker Center for Excellence in Early childhood Studies, will present on the Sunshine Portal and the Florida Index of Child Care Access (FLICCA) 5.1 map.

### Item: Innovation for Impact Grant Policy 6.80 (D) (formerly known as the Mini Grant)

### **Requested Action:**

The Board is asked to approve policies and procedures for a Special Funding opportunity— Innovation for Impact Grant (Policy 6.80), to be included in the FY 2025–2026 budget.

### **Background:**

In FY 2024–2025, the Board authorized staff to allocate \$200,000 to pilot a Mini Grant initiative designed to support local organizations proposing creative and impactful projects that benefit children and families in Alachua County.

To date, the Children's Trust has awarded a total of \$50,000 to three organizations:

- 1. Swampbots Robotics Program
- 2. Dance Alive Let's Dance (Classes for children with special needs)
- 3. Mirror Image Leadership Academy *Evolving Leaders Academy*

Based on the pilot's initial success and community interest, staff recommends the Board approve continued support for this initiative under the newly named Innovation Grant. This funding will broaden the range of programs supported by the Children's Trust and encourage innovation in service delivery.

The total allocation for FY 2025–2026 will be presented to the Board during the upcoming budget planning process. Staff will also provide a performance review of currently funded providers before the close of the current fiscal year.

Children's Trust of Alachua County Innovation for Impact Grant Policy 6.80 (D)

- 1. Conditions for use. The Innovation for Impact Grant (formerly known as the Mini Grant) provides funding for local organizations to launch creative and impactful initiatives that benefit children and families in Alachua County. Grant funds can be used to create, enhance, or expand direct services within the identified areas of focus. Prospective applicants must have an annual operating budget of less than \$1 million. Grants of up to \$20,000 will be awarded to help expand the range of programs supported by the Children's Trust. This funding is limited and competitive, awarded on a one-time basis per fiscal year, and subject to availability. The denial of any request shall in no way be construed as a reflection of the project submitted or the agency involved.
  - a. Applicants must receive approval from the Executive Director or designee before gaining access to the Innovation for Impact Grant application.
  - b. Applicants must submit and complete an application, scope of work, and budget form on the Children's Trust Services and Activities Management Information System (SAMIS). Additional documentation, as outlined in SAMIS, may also be required.
  - c. Innovation for Impact Grant funds may not be used to correct prior contractual or service errors, nor make the applicant financially whole.
  - d. The maximum award amount is \$20,000.
- **2. Review.** Applications and all supporting materials will be reviewed by the Executive Director or designee.
  - a. Applicants cannot request funding for active Requests for Proposal (RFP) or currently funded initiatives.
  - b. Proposed services must align with the Children's Trust <u>2023-2026</u> <u>Strategic Plan</u> goals.
    - i. Children and youth are healthy and have nurturing caregivers and relationships.

- ii. Children and youth learn what they need to be successful.
- iii. Children and youth live in a safe community.
- c. Projects must be innovative and creative, offering new approaches or solutions.
- d. Applicants should be prepared to present their proposal and budget in a joint meeting with the Children's Trust's Program Department and Fiscal Department.
- e. Current or past funding from the Children's Trust of Alachua County is not a determining factor for this special funding category.
- f. Applicants must have support from both their board of directors and senior leadership.
- g. Applicants must be qualified to conduct business in the state of Florida for the duration of their service period.
- **3. Evaluation.** The Executive Director or designee will determine whether the proposal meets all eligibility and application requirements. The Executive Director may consider other criteria in making a recommendation for funding so long as the criteria are explicitly stated.
  - a. Evaluation considerations may include:
    - i. Urgency and significance of the issue within Alachua County
    - ii. Existing services or providers addressing the issue or providing the service.
    - iii. Availability of other funding sources
- 4. **Recommendations.** The Executive Director or designee has the authority to approve or deny all requests. All applicants will be notified in writing of the funding decision. Approved grants will be reported monthly to the Children's Trust Board via the consent agenda.
- **5. Contracts.** Approved applicants must use the Children's Trust standard contract for services.
  - a. Applicants will be required to have current liability coverage prior to contract execution.
  - b. Applicants must register with and use the U.S. Department of Homeland Security's E-Verify system to verify the work authorization status of all new employees prior to contract execution.

### **Requested Action:**

- 1. The Board is asked to allow staff up to 90 days to work with the Community Foundation along with the Center for Non-Profit Excellence to coordinate next steps in the creation of the comprehensive literacy plan and activities as recommended during the joint meeting with the BOCC.
- **2.** The Board is asked to invest \$550,000.00 as an initial investment for the CTAC community literacy initiative.

### **Background:**

Since the completion of the Comprehensive Literacy Needs Assessment report, The Lastinger Center for Learning has presented an overview of the report and recommendations at two meetings. The following motions were made from those meetings:

April 7<sup>th</sup> CTAC Meeting: Member Pinkoson moved the Executive Director to bring this item back next month with a specific recommendation based on what was discussed and an update on the requested facilitator.

April 21<sup>st</sup> Joint CTAC/BOCC Meeting: The County Commission earmark a budget of at least \$250,000 this year from the County to partner with the Children's Trust and the Non-Profit Center for Excellence to work with key literacy organizations, stakeholders in the community, and the School Board to develop a plan for implementation and evaluation of this reform based on recommendations in this needs assessment. Bring back to the Board within 90 days what a map of that plan is and a formal budget by the end of the budget cycle so that if there is more money needed or if there is other funding needed, we can allocate it before the end of the budget cycle. 2. Write a letter to the School Board asking them to adopt the needs assessment and recommendations in this report.

A presentation on the Comprehensive Literacy Assessment Report is scheduled with the Alachua County School Board Members on May 20, 2025. At this meeting, the Children's Trust staff will share the motions made at the other board meetings and next steps.

### **Update**

1. The Children's Trust staff reached out to the Comprehensive Literacy Assessment Committee members in March and April for feedback to start planning for phase 2 of developing a literacy plan. The Comprehensive Literacy Assessment Committee was provided with the final assessment report. They were asked to review the assessment and recommendations with their organization and leadership team in the next 30 to 60 days.

2. A hard copy of the report was provided to CTAC board members, School Board members, the Library District, and BOCC board members. The report has been placed on the CTAC website and will also be placed on the Lastinger for Learning website. The link has already been shared throughout the community. At the League of Cities April meeting, ED Kiner also informed the municipalities that the literacy needs assessment had been completed and there will be opportunities for collaboration with all of the Literacy Partners.

- 1) Receive information on performance improvement plan process
- 2) Approve the following actions
  - Implementation of Youth Mentoring plan
- 3) Authorize staff to:
  - Reduce contract award amounts, terminate contracts and increase funding to providers deemed by Trust staff as having capacity to expand their services.

### **Background:**

In FY2025, the Children's Trust enhanced its performance and fiscal monitoring processes to include mid-year evaluations of program performance and expenditures. This new approach allowed staff to create targeted improvement plans and propose contractual or budgetary changes when necessary.

Programs were assessed in four key areas: fiscal management, service delivery, data quality, and performance metrics. Each area was reviewed by the appropriate department, resulting in recommendations for budget reductions, performance improvement plans and, where applicable, contract terminations. The funds made available through these actions are eligible for reallocation to selected providers.

Additionally, in 2023, the Trust launched a Youth Mentoring Program RFP, awarding two-year funding to selected providers focused on recruiting, training, and supporting mentors for one-on-one and group mentoring. However, one-on-one mentoring implementation has proven difficult, with most providers falling short of performance targets. Youth Mentoring is an important area identified in our strategic plan, staff have developed a plan to improve program quality and effectiveness.

## Youth Mentoring Plan

April 25, 2025

### Why Mentoring?

# 1) Youth mentoring was an area of focus identified in our Strategic Plan per youth, parent, and community input gathered during the Listening Project (2023).

Per data collected from Alachua County youth, 20% surveyed said they don't have at least one person to talk to when they have a problem. 28% of youth surveyed said they felt sad or hopeless for 2 weeks or more in the past year.

On-going solicitation of youth perspectives reveals that among youth receiving group-only mentoring via our mini-grant, 71% were interested in having one-on-one mentoring experience. Reasons youth enrolled in CTAC funded mentoring programs included: a desire for belonging or connection, to learn skills, receive guidance, personal growth, interest in the program focus (academics, athletics, etc.), and because the program was recommended to them.

2) Mentoring is an effective practice in achieving outcomes aligned with key indicators in the Trust's strategic plan. Mentoring demonstrated as effective or promising in areas of high need in Alachua County including youth arrests, chronic absence, high school graduation, and youth social-emotional wellbeing.

Community Level data for youth in Alachua County collected reveal that:

- 16% did not graduate from high school within 4 years (2024)
- **510** youth were arrested (2022-2023).
- 30% felt sad or hopeless for 2 weeks or more in the last year (2024).
- 30% of youth were absent from school 10% or more days (2022-2024).

Meta-Analyses support an evidence-base ratings for mentoring as effective for reducing delinquency outcomes and promising in reducing the use of alcohol and drugs and improving school attendance, grades, academic achievement test scores, social skills, and peer relationships. <u>Practice Profile: Mentoring for Youth Development | CrimeSolutions, National Institute of Justice</u>


### **Approach Taken**

3) Mentoring programs are best positioned to demonstrate positive youth outcomes when meaningfully structured, purposeful, and regularly assessing program implementation/quality.

Best practices for youth mentoring have been codified by MENTOR. <u>Elements of Effective</u> <u>Practice for Mentoring | Enhance Your Mentoring Program</u> Program activities required of CTAC funded programs included:

- Recruit, train, and support mentors.
- Recruit and match youth with mentors.
- One-on-one mentoring sessions (average of twice a month).
- Group mentoring sessions.
- Parent and family involvement.

## 4) Funded mentoring programs struggled to provide, track, and ultimately demonstrate program activities as contracted.

Providing one-on-one mentoring has proven difficult for all programs. Providers indicated difficulty in getting in contact with mentors and tracking mentor-mentee contacts.

Some of the funded programs also indicated difficulty recruiting and retaining mentors.

16. Provider Highlight – DJ Elo



Children's voices and laughter fill the community room of Oakview Apartments as they file in for an experience like no other.

Enter DJ E-Lo.

Eric Lopez, a professional DJ known as DJ E-Lo, spends his time teaching the children of Alachua County how to DJ.

The session starts with a slew of DJ facts, specifically about how DJing can be both a hobby and a career. DJ E-Lo rattles off names of several famous DJ's along with their salaries as gasps are heard around the room.

"Who thinks it's important to make money?" He asks.

All hands shoot up into the air.

"How do people make money?"

A chorus of voices follows as they reach a consensus. Their answer? Get a job.

Now comes the real heart of DJ E-Lo's mission as he launches into a conversation with the kids about how they can do anything, and they can do it as a job.

One child says she likes to do hair and nails. Another says he likes cars. Each one is affirmed that they can turn their interests into a job, they just have to work toward it.

"I'm hoping that they get the message that they can become bigger than they are. They can do whatever they want to do," DJ E-Lo says "It takes a little effort, but there's really nothing that they can't do."

As the session continues, the children choose DJ names and are given tablets with DJing software to practice on. DJ E-Lo teaches them how to find the beat of a song, and how to use a mixer on the app. He goes around the room one-byone and allows each child to showcase what they have learned and praises them for their attentiveness and abilities.

They all leave with smiles and the promise of a DJ party when they return for the second session the next day.

"It's about more than just DJing."

DJ E-Lo hopes to not only equip the children in these enrichment sessions with the skills to DJ but also to empower them to work toward their dreams. He says that most people do not realize how useful DJing can be, citing that older kids can use DJing to bring in extra money even if they don't choose to do it full-time.

The bigger message is loud and clear: "Don't be afraid to go for it, you won't be able to do it if you never try."

DJ E-Lo's "Let's DJ" enrichment sessions and many others are free to book for youth-serving organizations through a partnership with the Children's Trust of Alachua County. Request a session from a CTAC-funded enrichment provider <u>here</u>.

### **Background:**

Newborn RN Homevisiting Program is one of Children's Trust contracted community partners who focus on maternal health.

**Newborn RN Home Visiting Program** is a free program offered to all Alachua County women who give birth in the county. It is administered by NCFL Healthy Start. Within a week after baby is born, a registered nurse or midwife visits mom and baby at home to see how they are doing, share information and connect them to services and resources. A registered nurse or midwife will provide a physical and health assessment on baby and mom, help with breastfeeding and nutrition, show how to care for baby, share infant safety tips, discuss family planning options and connect families to local resources.

# Newborn Home Visiting Progra Item 18. October 2024 – March 2025

Mom was using a borrowed bassinet with parts missing and an incorrectly sized mattress. The mattress was not flat. The bed also had stuffed toys in it and loose blankets. Mom was educated about the danger of having loose items in the bed and was given a pack-n-play and sleep sac to replace the unsafe bassinet and loose blankets.

A teenage mom was co-bedding with her baby or letting the baby sleep in a swing. She was given a pack-n-play. Additionally, the Fisher Price swing had been recalled, so mom was educated about the danger of using it.

Mom was visited whose infant had a G tube for feeding. Mom was uncertain as to how she was supposed to feed the infant correctly. The RN contacted the NICU at the hospital to find out the correct information regarding this and then was able to teach mom the correct technique for feeding.

We have had 16 moms presenting at visits with elevated BP's. In all these circumstances the OB provider was notified and some of these moms were immediately readmitted to the hospital.

We identified 19 moms with high mental health risk and were connected to support services.

457 families have been linked to community supports and services.
