Discussion Items

1. Committee Communication

Member Kristy Goldwire reminded the committee that this virtual meeting would not contain any action items. The format is like a workshop there will be no items to vote on. Member Goldwire discussed the overall rules regarding committee communication reminding members that they should not discuss the business of the committee outside of a meeting with another member.

2. Strategic Planning Consultant Update

Member Kristy Goldwire informed the committee that Cathryn Raymond will no longer be the strategic planning consultant for the group. CTAC staff has identified a new consultant Nikki Martin-Bynum with Seek Higher Ground, and she has been selected to fill the role. Nikki has experience working with CSC's, coaching, and facilitating meetings. Member Marsha Kiner agreed that Nikki comes highly recommended. Committee Chair Twombly spoke highly of Cathryn and the work product that is currently in place that she is leaving behind. Chair Twombly told the group that Catherine is available for questions and asked Member Goldwire when the new consultant is scheduled to start. Member Goldwire advised that the contract would begin November 1st pending board approval.

3. Listening Project Plan Activities & Timeline

Dr. Prieto the consultant leading the project introduced herself and the primary people helping her with the work on her team. Dr. Prieto provided a visual to show the work that has been completed since the project plan began. The listening project input plan was discussed. Dr. Prieto gave a general update to the group on how the project is going. To date, 8 key informants, 9 trust staff interviews, and 30 providers surveys have been received. The partner survey will launch later today 10/17/22.

Member Candice King asked to whom she should send questions. She also asked about revisions to the flyer that were discussed in the CTAC board meeting. CTAC staff member Bonnie Wagner explained that the changes were not made because the flyer was already distributed. Wagner discussed the items that the group would see in the future.

4. Strategic Planning Activities & Timeline

Bonnie Wagner reviewed with the group the Strategic Planning activities and timeline that were developed by Catherine Raymond. Wagner went over the upcoming events and schedule that the steering committee previously agreed on. The strategic planning consultant will lead the discussion and meetings outlined unless they would like to make changes to the schedule.

Open discussion

Chair Twombly asked the group how they would like to receive updates in the future. Bonnie Wagner reminded the group that their feedback is very important and the more involved the committee is the better the project will be. Member King asked for the updates in an email. Member Papa agreed that email communication would be good. Member Goldwire reminded the committee to be mindful of replying and adding people to the email communications.

CTAC Staff member Bonnie Wagner advised the group that she would send an email to the steering committee after the meeting was over to show them the information that would be posted on the webpage. Wagner informed the group that she along with others on the CTAC team have developed a communications plan that will be sent to the community in various ways.

10. Executive Director Contract - M. Kiner

Chair Labarta noted the incorrect start date on the ED's employment contract and requested the Board approve the change from October 3rd to October 1st, 2022.

Executive Director's Report

11. ED Report

ED Kiner reported her first month with the Trust has been very productive with meetings with community members, the UF Homecoming Parade, and the Lights on Afterschool event. She thanked the board members and staff for their assistance and participation. Member Cole-Smith thanked her for keeping the board updated, and Member Cornell reported a positive response from the community for her efforts.

12. Board Meeting Schedule for 2023

The schedule of board meetings for 2023 will fall on the second Monday of each month with the exception of the March meeting being held on the 20th, and the April meeting being held on the 3rd, due to spring breaks.

Motion made by Member Pinkoson, Seconded by Member Cornell to approve the 2023 Board Meeting Schedule with noted modifications.

Motion was unanimously approved by voice vote.

13. Children's Trust Seeking Applicants for Board of Directors

ED Kiner reported that two of the board member's terms were ending in January 2023. The County has requested applications, has currently received two, and the closing date will be November 18th, 2022.

Committee Updates

14. Steering Committee (Cheryl Twombly) Listening Project Update (Bonnie Wagner)

Committee Chair Twombly reported the last meeting of the Steering Committee took place on October 17th, 2022. Bonnie Wagner reported on the various parent, student, and community listening sessions and their locations across Alachua County.

Motion made by Member Pinkoson, Seconded by Member Cornell, to approve the contract of Nicole Martin-Bynum from Seek Higher Ground, LLC to act as consultant for the Trust's strategic planning project.

Motion was unanimously approved by voice vote.

Presentations

15. Children's Defense Fund Freedom School – Program Overview (Belita James)

Dr. Coleman-King and Dr. Brown gave an overview presentation of their Trust-funded CDF Freedom School. The Trust approved \$60,000 for FY 21-22. Staff recommended that the Board approve funding of \$110,000 for the FY 22-23.

Motion made by Member Cornell, Seconded by Vice Chair Certain, to request that staff look at the FY 21-22 carry-forward funding and then bring back recommendations to the Board regarding the funding of the FY 22-23 Freedom School.

Motion was unanimously approved by voice vote.

16. Youth Development Capacity Building Collaborative (Deon Carruthers)

Contract Manager Deon Carruthers gave a presentation on the evaluation of the YDCBC program. He reported that the participating afterschool and enrichment providers received training to improve organizational capacity, were supported with capacity building funding, implementation support, and best practices for coordination of services. Over 90% of the capacity building goals were completed by the providers, self-assessments showed an increase in high-quality standards, and 100% of providers reported being satisfied or very satisfied with the collaborative activities.

New Business

17. Children's Trust By-Laws - Succession Planning

The Board asked Atty Swain to update the Trust's by-laws to modify the previous practice of annual nominations for all Board Officers (Chair, Vice Chair, and Treasurer) to a succession model. The following text was added: At the annual meeting of the Trust, the Vice Chair shall assume the office of the Chair and the Treasurer shall assume the office of the Vice Chair. At that meeting, a new Treasurer shall be elected by the members of the Trust. Nominations for the office of Treasurer shall be taken from the floor for this position and voted upon at the same meeting.

Motion made by Vice Chair Certain, Seconded by Member Cornell to adopt these changes into the Children's Trust of Alachua County By-Laws.

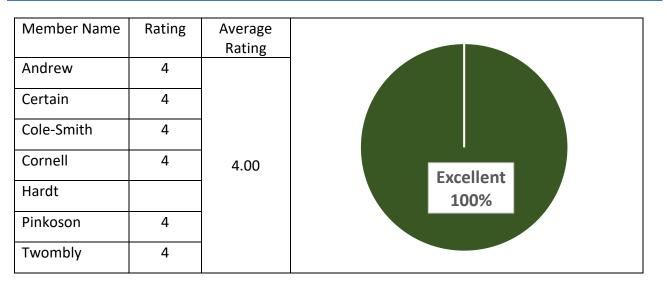

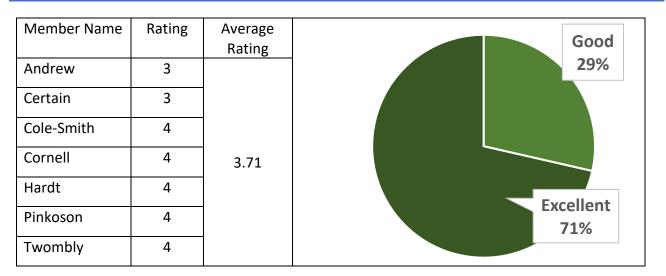

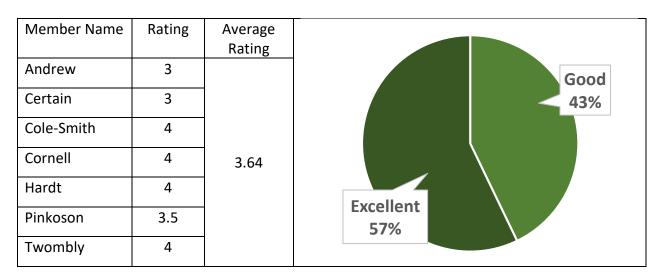

We were able to get six (7th-grade students) their TDAP shots. The school nurse was having difficulty reaching families, and the Wellness Coordinator stepped in and helped each student with their appointments, allowing them to stay in school and not miss days.

The Early Learning Coalition-Transformative Professional Development

During a debrief session, a teacher stated she felt every teacher should go through the coaching program. She stated that it helped her understand what she was doing well in, as well as areas she needed to work in with the support of her coach. Secondly, at the end of November, we were able to schedule Director Orientation meetings with the two sites we had on the waitlist for coaching. Background:

The Listening Project is an opportunity to help us build better partnerships and receive great insights on how to build a better system for children. Our goal is reaching everyone who has thoughts on how to improve the lives of children in Alachua County and provide them an opportunity to be heard and partner with us.

Since the last Board meeting, a shortened version of the parent and youth surveys have been developed and are in use. Prismatic and Trust staff have attended several community events to encourage survey participation including – Newberry Thanksgiving Fest at the MLK Center, Miracle on Main Street event at Trinity United Methodist Church, Pine Meadows Health Fair with the Gainesville Housing Authority, and a Rural Women's Health Project event at Highlands' Church.

Trust staff developed a <u>Listening Project website</u> to provide an overview of the project as well as provide the most up-to-date information on activities and opportunities to be heard. CHILDREN'S TRUST OF ALACHUA COUNTY RESOLUTION 2022-17

ADOPTION OF CHANGES TO THE EMPLOYEE HANDBOOK

WHEREAS, the Children's Trust of Alachua County Adopted an Employee Handbook through Resolution 2020-8; and

WHEREAS, the Children's Trust of Alachua County desires to make changes to the Employee Handbook;

NOW THEREFORE, be it ordained by the Board of Children's Trust of Alachua County, in the State of Florida, as follows:

SECTION 1: <u>AMENDMENT</u> "3.20 Weather Related Closings" of the Children's Trust of Alachua County Employee Handbook is hereby *amended* as follows:

AMENDMENT

3.20 WEATHER RELATED CLOSINGS

It is our policy to consider the safety of our employees and those we serve when making decisionsregarding remaining open during periods of inclement weather. Where extraordinary circumstanceswarrant, we will close the facility. During periods of adverse weather, employees are encouraged to-(listen to radio broadcasts, contact their manager, etc.) find out if their work location is closed on agiven day. Our decision to close will be made by 7:00 a.m. on the day of the closing. If the facilityremains open, but you are unable to report to work, you should follow our standard procedures fornotification of an unscheduled absence.

If the facility remains open, employees who report to work will receive their normal pay for the day. Those not reporting to work on a facility open day, will be required to use any available paid timeoff for the missed day. Employees will receive their regular pay for the day of closure.

Even if a facility is closed, there may be key positions that will need to report to work. Individuals in those positions will be notified by management with the details of the assignment. Employees who are required to work when a facility is closed will receive their normal pay for the hours worked.

3.20 EMERGENCY CLOSURE

It is the policy of Children's Trust to maintain essential business services and operations during any emergency incident or situation while providing for the protection of life, health,

and safety for all employees and the public.

An **incident** is an occurrence, either caused by humans or a natural phenomenon, which requires or may require action by emergency service personnel to prevent or minimize loss of life or damage to property and/or the environment.

Where such extraordinary circumstances warrant, the company may close its non-essential operations. The organization may follow the operating status of Alachua County during inclement weather scenarios/emergency closures; however, management will make the final decision whether facilities and operations will be open or closed and communicate it to the employees. All employees will be notified by 7:00 a.m. on the day of closure.

If the facility and operations are announced to be closed on a given day due to an emergency incident or situation, employees will be paid administrative leave for the days of closure.

If an employee is unable to work or elects not to work when facilities are open during such emergency incidents or situations, the employee must advise their manager or supervisor as soon as possible and will be required to use their available paid time off or take leave without pay.

If an early closing is declared during a workday, all exempt employees who arrived at work will be compensated for their normal workday. Non-exempt employees will be paid administrative leave for hours not worked on the day of partial closure.

If an employee is not scheduled to work on a day of emergency closure due to a paid holiday or the employee is out on paid sick, vacation, or personal leave, the employee will be charged with such leave, as was scheduled, rather than paid administrative leave.

Time absent from work due to such incidents or emergency situations is not counted as hours worked when computing weekly overtime.

In the event of such incidents or emergency situations, the organization may allow or require certain employees to temporarily work remotely, if possible. These employees will be advised of such requirement by their manager. Preparations should be made by employees and managers well in advance to allow remote work in emergency circumstances. This includes appropriate equipment needs, such as hardware, software, phone, and data lines.

Consistent with the company's expectations of information security for employees working at the office, telecommuting employees will be expected to ensure the protection of proprietary company and customer information accessible from their home office.

SECTION 2: EFFECTIVE DATE This Resolution is effective as of December 12, 2022.

Background:

Summer Camps & Enrichment Programming: CTAC Summer Camps contracts are scheduled to start April of 2023. Board approved providers have received and completed site profiles for FY23. Contract Managers have started negotiations with a goal to complete negotiation before the end of the year.

The attached presentation provides a summary of summer camp funding awards and includes final rollover amount, specifically for summer programming. Staff recommendations for rollover usage include an increase in funding for Freedom School, professional development trainings for all CTAC funded providers, etc.

New Providers: At direction of the Board, staff have met with representatives from UF Dentistry, Catholic Charities and the Child Advocacy Center to determine the most appropriate funding recommendations for FY23. 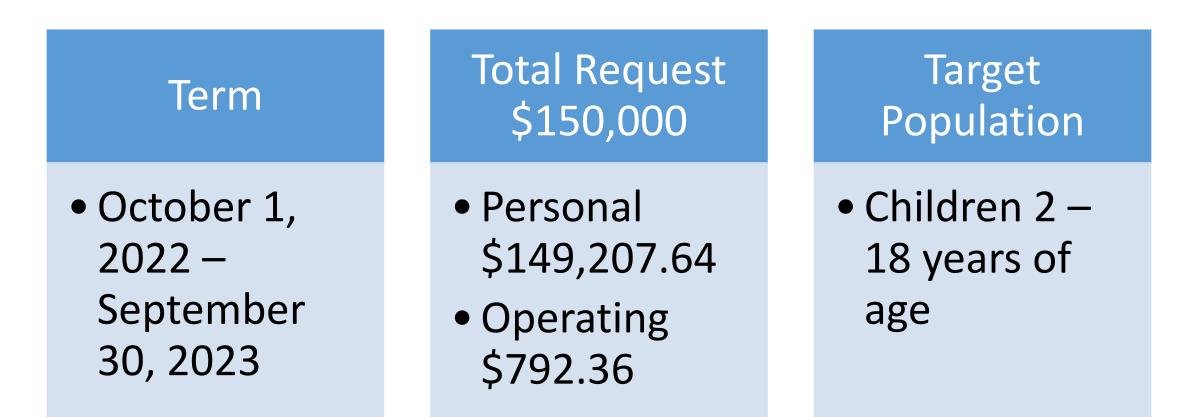
