Topic: Presented By:	American Rescue Plan Act (ARPA) Monies Don Bohn, County Manager Monica Steele, Assistant County Manager
Informational Summary:	Staff is coming before your Board to present the most current DRAFT Funding Concept for your review as updates continue to be made for investing the \$7.8 million American Rescue Plan Act monies. These updates are based on continued conversations with the Board, staff and community stakeholders.
	As previously stated this concept will continue to be modified as tasks are either identified, completed, or found to no longer be necessary at the proposed funding levels.
	To date, of the \$7.9M in funding the County received, \$3.9M has been spent and another \$3.6M has been obligated per the attached DRAFT Funding Concept. An additional \$165,000 is currently set aside for contingency.
	Per the US Department of Treasury's most recent interim final rule, all funds must be obligated by December 31, 2024 and all funds must be expended by December 31, 2026.
