



The City Council is being asked to Authorize the City Manager to execute an amendment to the agreement with Adam's Ashby Group, to increase the not to exceed contract amount to \$150,000, extend the Contract to July 2022, and to further define the scope of services to include additional assistance in managing the City's Community Development Block Grant (CDBG) and other State and Federally Funded grants.					
BACKGROUND/DISCUSSION:					
The City submitted a Request for Proposals (RFP) in June 2019 and Adams Ashby was selected as the Consultant by a single bid award process for \$34,884.00. Due to the applying for additional grants, and being awarded additional grant funds, the need for Adams Ashby 's Services has increased. At the time of the RFP the City had been awarded \$500,000 in CDBG funds, but now has been awarded approximately \$20 million through the program. The contract increase will be paid for out of current grant funds as part of the administrative costs.

#### WHAT IS BEING ASKED OF THE CITY COUNCIL/BOARD:

The City Council is being asked to keep declaration of emergency active and set next review in sixty days.

#### **BACKGROUND/DISCUSSION:**

On March 13, 2020 City Manager Flora, as the Director of Emergency Services for the City of Clearlake, declared in the attached Proclamation by the Director of Emergency Services Declaring a Local Emergency due to the state and federal declaration of the COVID-19/Coronavirus pandemic:

"That conditions of disaster or extreme peril to the safety of the persons and property have within the City that are likely to be beyond the control of the services, personnel, equipment, and facilities of the City"

According to California Government Code Section 8630:

- (a) A local emergency may be proclaimed only by the governing body of a city, county, or city and county, or by an official designated by ordinance adopted by that governing body.
- (b) Whenever a local emergency is proclaimed by an official designated by ordinance, the local emergency shall not remain in effect for a period in excess of seven days unless it has been ratified by the governing body.
- (c) The governing body shall review the need for continuing the local emergency at least once every 30 days until the governing body terminates the local emergency.
- (d) The governing body shall proclaim the termination of the local emergency at the earliest possible date that conditions warrant.

Staff believes there is still a need to restrict unauthorized access to the areas under the Cache Fire Directive #1 and it is in the best interests of the City to have the Council ratify and continue this order until the state of emergency can be lifted.

#### WHAT IS BEING ASKED OF THE CITY COUNCIL/BOARD:

The City Council is being asked to authorize the City Clerk to implement and utilize teleconference accessibility to conduct public meetings pursuant to Assembly Bill 361 (Stats. 2021, ch. 165).

#### **BACKGROUND/DISCUSSION:**

On Friday, September 17, 2021, the Governor signed AB 361. Because the bill contained urgency findings, the law is now in effect. AB 361 allows local agencies to continue to conduct remote ("Zoom") meetings during a declared state of emergency, provided local agencies comply with specified requirements. Absent this legislation, local agencies would have had to return to traditional meetings beginning on October 1, 2021.

Starting October 1, and running through the end of 2023, to participate in remote meetings, public agencies must comply with the requirements of new subsection (e) of Government Code section 54953.

The Council passed Resolution No. 2021-48 on October 7, 2021, which made the necessary findings for all subordinate legislative bodies of the City, such as the Planning Commission, so these bodies can also continue to meet remotely.

#### **Subsequent Remote Meetings**

Any time after the first remote meeting of the legislative body, it can meet remotely if both of the following apply:

- 1. State/local emergency/social distancing. Either:
  - a. "a state of emergency remains active" or
  - b. "state or local officials have imposed or recommended measures to promote social distancing" and
- 2. 30 days. Within the last 30 days (which vote may occur at that meeting) the legislative body has made the following findings by majority vote "(A) The legislative body has reconsidered the circumstances of the state of emergency. (B) Any of the following circumstances exist (i) The state of emergency continues to directly impact the ability of the members to meet safely in person. (ii) State or local officials continue to impose or recommend measures to promote social distancing."

PURPOSE OF REPORT:			

#### WHAT IS BEING ASKED OF THE CITY COUNCIL/BOARD:

The City Council is being asked to provide direction to staff regarding the operation of Syringe Services Programs (SSPs), which have expanded to the distribution of drug smoking pipes and paraphernalia, in the City of Clearlake.

#### BACKGROUND/DISCUSSION:

Late last year, the police department sought feedback on a proposed renewal of the SSP authorization for Community Outreach Matters (COM) in the city by the California Department of Public Health (CDPH). Concerns raised by the community included the impact on our neighborhoods, issues regarding the sites, our youth, and an increase in discarded needles despite the intent to be an "exchange".

This feedback was shared with the CDPH along with a request for the applicant to better address the disposal issues, reduce the distribution sites and engage with service providers like The Hope Center. The city additionally inquired with CDPH regarding whether an environmental impact report was done pursuant to the California Environmental Quality Act (CEQA). COM was ultimately not reauthorized by CDPH and ceased operation in April 2021. A recent change in state law exempted these programs from environmental review, however, during the legislative process, a provision to exempt the providing of these services from being deemed a public nuisance was removed from the final legislation.

Last week we learned that Any Positive Change (APC) was conducting syringe exchange operations in the City of Clearlake and that their operation expanded to include the distribution of glass smoking pipes for drugs, including methamphetamine.

Staff contacted CDPH to inquire regarding the status of APC with respect to the city. Staff learned that APC is not a state SSP, but rather operates under authorization granted by the Lake County Board of Supervisors (Exhibit A – LCBOS Resolution 2018-42). Thus, there was no engagement from CDPH with the city or our community regarding APC typical with a CDPH SSP.

The city obtained a copy of the enabling resolution for a needle exchange from the Lake County Board of Supervisors (2008-42). The authorization refers specifically to a clean needle and syringe exchange program. The resolution requires an annual report regarding the status of the program, including statistics on blood-borne infections associated with needle sharing activity and an opportunity for public comment, including from law

enforcement, so that potential adverse impacts on the public welfare are addressed and mitigated. [ seculi H, I agenda search, an update was last presented on March 6, 2018. The update focused on the needle exchange as well as naloxone, which is now widely carried by law enforcement personnel in Lake County for responding to drug overdoses.

#### Expansion of Safe Smoking Supplies

In January 2020, the CDPH expanded the supplies made available for syringe exchange programs to include "glass pipes, foil and copper wire filters, among other materials" as a harm reduction service. These items support the smoking of methamphetamine, crack cocaine and heroin.

According to material provided by CDPH, they have determined these drug supplies may help individuals avoid initiating injection drug use and may allow people who inject drugs to transition from injection to safer modes of administration. They also believe these "safer smoking supplies" may reduce the risk of respiratory infections and injuries from damaged pipes. The material provided offered no information regarding the potential harm to the public by the increased prevalence of these supplies. The availability of drug ingestion supplies from CDPH varies based on their funding.

CDPH explained that California Health and Safety Code § 121349.1 exempts syringe service program staff, volunteers and participants from prosecution for the possession of "safer smoking materials", including the pipes and related paraphernalia, from any authorized syringe service program in California.

According to data provided from Any Positive Change to the city, they received a large number of pipes at the end of fiscal year 2020/21 from the California Clearinghouse. They indicated prior to glassware dispensing, they averaged 6,500-8,000 syringes. After dispensing glassware, they indicate their dispensing dropped to 3,000-4,000. Data has not been provided regarding the impacts on the program with respect to reducing communicable diseases in the local community nor any local, evidence-based studies conducted over the relatively long term of operation of the original needle exchange as it relates to the communicable disease outcome.

#### Community Input

The Police Department published information regarding this latest development on social media. To date, the article has reached over 41,000 people, had over 18,000 engagements and received over 600 comments. There were a variety of concerns raised as well as information provided from proponents of the program regarding a community benefit. Resoundingly, significant concerns were expressed, including feedback from persons who have recovered from addiction, regarding the harms this expansion can cause. Numerous comments indicated a desire for community members to be able to voice their concerns at a City Council or Board of Supervisors meeting.

#### **Board of Supervisors**

As of the writing of this report, it is staff's understanding that the Board of Supervisors will be taking this item up at their next meeting. It is anticipated they will consider a moratorium and/or amendments to their existing program operation and add to the authorization framework to amongst other things, ensure community feedback is considered with respect to these operations as well as city approval for operations occurring in the city limits. At the time of the Council Meeting, staff will update the Council regarding any action or inaction by the Board regarding this.

#### Authorization in the City

The property owner where APC was conducting their exchange in the city limits severed the relationship and APC's activities are now occurring in the unincorporated areas of the county. Although the county did establish a needle exchange program, the resolution would cover only the unincorporated areas of the county. With

respect to the City, Health and Safety Code §121349 provides that an SSP may be established within action of the City Council or by direct authorization by the CDPH. As discussed earlier, with the non-renewal of COM's SSP, there are no CDPH authorized SSPs approved for operation in the city and the City Council has not authorized an SSP under the authority of §121349.

If APC desired to operate in the City of Clearlake's jurisdictional boundaries, they could seek authorization for such a program through CDPH. In that case, consistent with the law, staff would anticipate an interactive, consultative based process with opportunity for public comment and engagement, consistent with what was experienced with COM's process. Alternatively, they could ask the City Council to authorize an SSP program, in which case staff would need to develop a program framework, policies and procedures, reporting and appropriate oversight. Staff does not recommend the City Council pursue establishing an SSP under it's authority given CDPH's existing program framework.

#### **OPTIONS:**

Staff is seeking direction from the City Council on a path forward. Staff is offering the following options, but also believes that public comment at this meeting along with deliberations by the City Council may reveal other options.

- 1. The Council may decide to not take any legislative action. As discussed, there are no SSPs authorized to operate in the city limits and APC ceased their operation due to loss of the distribution site. If an application for an SSP to operate in Clearlake was submitted to CDPH, the Council could consider action at that time. One consideration, however, is that CDPH would not be bound to accept any of the feedback. Based on prior experience, issues may arise around where distribution sites would be located, including potentially near sensitive areas including, but not limited to, schools, parks and playgrounds. If the Council decided to take legislative action, an emergency ordinance would need to be implemented.
- 2. The Council may direct staff to prepare an ordinance regarding SSPs with respect to public nuisance provisions and land use. The City possesses inherent authority, through the Council, to declare actions and activities as public nuisances. The City has the authority to make and enforcement police, sanitary and other ordinances and regulations, and to enact regulations regarding land use to protect the public health, safety, peace, comfort and general welfare.

Cities across California have enacted ordinances regarding SSPs. The Cities of Biggs, Chico, Marysville, Oroville, Paradise, Santa Ana, Wheatland, Yuba City and Sutter County are a sampling of jurisdictions that have enacted complete bans on SSPs. The Cities of Costa Mesa and Anaheim enacted moratoriums followed by permanent bans.

- a. *Ban:* Enact a ban on needle exchange operations within the City based on land use and public nuisance findings regarding the deleterious effects on the community at large.
- b. Moratorium: Enact a moratorium to provide an opportunity to further study the issue and craft regulations that consider all sides of the issue and provide opportunities to address and mitigate concerns regarding the programs.
- c. Regulatory: Enact an ordinance containing regulatory framework regarding SSP operation within the city. Additional research from the City Attorney would be required to determine the scope of this type of an ordinance. Presumably, the ordinance would focus on land use related issues such as establishing restrictions regarding the operation locations of SSPs.
  - Additionally, although Health and Safety Code §121349.1 prohibits *criminal prosecution* regarding the possession, furnishing or transfer of items provided under the SSP, the Council

# RESOLUTION AUTHORIZING SUPPORT OF ASSEMBLY BILL 547 (AB 547), A SYRINGE EXCHANGE PROJECT TO COMBAT THE SPREAD OF HIV AND BLOOD-BORNE HEPATITIS INFECTIONS

WHEREAS, as of 2001, an estimated 600,000 Californians were infected with Hepatitis C attributable to the sharing of contaminated syringes and over one thousand Californians are infected with HIV through syringe sharing each year. Numerous studies concur that improved syringe access reduces the rate of HIV transmission, without increasing the rates of drug use, drug injection, or crime.

WHEREAS, the rapidly spreading acquired immunodeficiency syndrome (AIDS) epidemic, and the more recent spread of blood-borne hepatitis, pose an unprecedented public health crisis in California, and threaten, in one way or another, the life and health of every Californian; and

WHEREAS, injection drug users are the second largest group at risk of becoming infected with the human immunodeficiency virus (HIV) and developing AIDS, and they are the primary source of heterosexual, female, and perinatal transmission in California, the United States, and Europe; and

WHEREAS, according to the State Office of AIDS, injection drug use has emerged as one of the most prevalent risk factors for new AIDS cases in California; and

WHEREAS, studies indicate that the lack of sterile needles available on the streets, and the existence of laws restricting needle availability promote needle sharing, and consequently the spread of HIV among injection drug users. The sharing of contaminated needles is the primary means of HIV transmission within the injection drug user population; and

**WHEREAS**, Assembly Bill 547 (2005) authorized local cities and counties to have a clean needle and syringe exchange project.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Lake authorizes a clean needle and syringe exchange program; and

**BE IT FURTHER RESOLVED** by the Board of Supervisors of the County of Lake as follows: That the Lake County Health Officer shall present an annual report at a meeting of the Board of Supervisors detailing the status of syringe exchange programs including, but not limited to, relevant statistics on blood-borne infections associated with needle sharing activity and public funding of such programs. Members of the public, local public health officials and law

enforcement shall be given the opportunity to comment on the syringe exchange program at that time to ensure that any potential adverse impacts on the public welfare are addressed and mitigated. A copy of this resolution shall be delivered to the Auditor-Controller, Tax Collector and Health Services Department.

#### SMOKING SUPPLIES FOR HARM REDUCTION

Injection drug use is associated with disease transmission, injury, and substantial morbidity, mortality, and high costs to the health care system in California. Many drugs that are commonly injected – including heroin, fentanyl, and methamphetamine – may also be smoked or snorted, which is a significantly less risky mode of administration for people who are unwilling or unable to stop using drugs.

#### **California Law and Safer Smoking Supplies**

In 2018, California <u>Health and Safety Code section 121349.1</u> was amended in order to expand the scope of materials that may be made available for public health purposes by syringe services programs (SSPs). The law provides that staff, volunteers and program participants,

"shall not be subject to criminal prosecution for possession of needles or syringes or any materials deemed by a local or state health department to be necessary to prevent the spread of communicable diseases, or to prevent drug overdose, injury, or disability acquired from an authorized needle and syringe exchange project entity."

Further, Health and Safety Code section 120780.2 permits the distribution of "other supplies" to syringe exchange programs.

"In order to reduce the spread of HIV, hepatitis C, and other potentially deadly blood-borne pathogens, the State Department of Public Health <u>may purchase</u> <u>sterile hypodermic needles and syringes</u>, *and other supplies*, for distribution to syringe exchange programs authorized pursuant to law (emphasis added)."

The California Department of Public Health (CDPH), Office of AIDS (OA) has determined that safer smoking materials, provided in a harm reduction context alongside health education and other care, may help individuals avoid initiation of injection drug use, and may allow people who inject drugs to transition from injection to safer modes of administration. In addition, availability of safer smoking supplies may reduce the risk of respiratory infections including influenza and tuberculosis, and injuries such as cuts and burns from using damaged pipes. Safer smoking supplies were made available through the CDPH/OA Syringe Supplies Clearinghouse to authorized syringe services programs (SSPs) beginning in January 2020.

People may lawfully obtain and possess safer smoking materials from <u>any authorized SSP in California</u>. State law does not require SSP participants to have a program identification card or receipt for safer smoking supplies materials distributed by an SSP, and SSP participants may lawfully obtain supplies from SSPs located in jurisdictions other than where they live.

What Non-Injection Drug Using Supplies Does CDPH/OA Provide to SSPs? Safer smoking materials made available through the CDPH/OA Syringe Supplies Clearinghouse may include glass pipes, foil, copper wire filters, and other materials, subject to change based on availability and funding. # EVIDENCE FOR PROVIDING SAFER SMOKING SUPPLIES TO REDUCE DRUG-RELATED HARM

**Non-Injection Routes of Drug Administration are Less Dangerous** Injecting more frequently is associated with a greater risk of blood-borne pathogen transmission.<sup>1</sup> Hepatitis C virus (HCV) transmission particularly affects young people who use drugs,<sup>2</sup> who may be at greater risk of infection because of different drug use patterns and less access to prevention services than older people.<sup>3,4,5</sup>

A person's overall drug-related risk is lowered every time they choose to smoke instead of inject. Studies have found that participants who inject drugs are often willing to switch to smoking or other modes of administration when feasible<sup>6,7</sup> and that non-injection routes of administration may pose less risk of overdose.<sup>8,9</sup> Many of the harms of injection drug use, such as endocarditis, skin infections, and vein damage, are injection-specific.<sup>10</sup> In addition to being harmful to individual health, endocarditis, HIV, and HCV are expensive to treat, and place a considerable economic burden on the public health system<sup>11,12</sup> For example, the lifetime cost of treating the approximately 200 injection drug use-related HIV infections that occur in California each year is approximately \$90 million In 2018 California set aside \$70 million with a goal of treating HCV in about 2,000 people that year alone.<sup>13</sup>

**Sharing Smoking or Snorting Supplies May Transmit Disease** HCV has been found on used pipes,<sup>14</sup> and sharing non-injection drug using equipment is associated with HCV infection.<sup>15</sup> Pipe sharing has also been implicated in outbreaks of other diseases, such as tuberculosis.<sup>16,17</sup> As with the risk of other respiratory infections, access to non-injection drug use materials may reduce sharing and the consequent risk of COVID-19 infection: while not yet studied with regard to illicit drugs, the sharing of tobacco cigarettes could be implicated in COVID-19 transmission through salivary droplets.<sup>18</sup>

Lack of access to new pipes is the primary reason drug smokers share pipes and use damaged pipes. <sup>19</sup> People who smoke drugs may also resort to altering and using objects such as soda cans as make-shift pipes. This may introduce additional harmful chemicals from any printing or lining that may be on or in the can. <sup>20</sup> Providing pipes to people who use drugs leads to decreased risks from sharing pipes, using damaged pipes and improvising other objects as pipes. <sup>21,22</sup>

**Increasing Mortality Related to Methamphetamine and Cocaine** There is an urgent need to better engage people who smoke or snort drugs, especially methamphetamine users, in harm reduction services and related care. California has experienced a

significant and alarming increase in deaths related to amphetamines and cocaine in recent years. According to CDPH's drug poisoning surveillance program, <sup>23</sup> in 2018 slightly more people died from amphetamine-related poisonings\* (2,316) than opioid overdose (2,311). Additionally, 33.4% of all opioid overdose deaths also involved amphetamines. Between 2014 and 2018, the California rate of drug poisoning deaths involving amphetamines increased by 99.6%, and African American, Latinx, and Asian-American people had greater rates of drug poisoning deaths than white people.

**People who Smoke Drugs Need Access to Harm Reduction Services** Making pipes and other non-injection drug using supplies available through SSPs can serve as an engagement strategy and bring harm reduction services to people who use drugs, but do not inject. There is a marked decrease of reported drug-related health problems among people who obtain new pipes through SSPs<sup>24</sup> and SSPs serve as a point of entry to other services, including linkage to care and treatment services.<sup>25</sup>

Offering new, non-injection drug using supplies for people who use drugs but who have not previously injected strengthens prevention interventions, including behavioral interventions that are effective in preventing initiation into injection<sup>26</sup>.

Studies have found that SSP participants are more likely to use a condom than non-participant drug users.<sup>27</sup> Crack cocaine and methamphetamine use are associated with risky sexual behavior;<sup>28,29</sup> and SSPs are well-equipped to provide information and education on reducing risky sexual behavior.

#### Conclusion

Distribution of non-injection drug using equipment is an accepted harm reduction practice. Access to new smoke pipes can lead to the reduction of injection incidents among people who inject drugs, which increases their personal protective behaviors. Expanding harm reduction services beyond people who inject drugs is an effective strategy to address our opioid and methamphetamine overdose epidemic. It provides equitable access to care and treatment services, regardless the mode of drug consumption.

#### WHAT IS BEING ASKED OF THE CITY COUNCIL:

The City Council has previously discussed both Lake County's Supervisorial Redistricting Process the California Redistricting Commissions Process for Congressional, Assembly and State Senate Redistricting. The Council is being asked if they want to provide additional input on either process.

As a result of the 2020 Census most political boundaries must be redrawn to adjust districts based on population. This process has been significantly slowed due to the Census being conducted during the global COVID pandemic. In November 2008, California voters passed the Voters FIRST Act, authorizing the creation of the Independent Citizens Redistricting Commission to draw new district lines, taking the job out of the hands of the California Legislature and transferring it to the citizens. In 2010, the VOTERS FIRST Act for Congress added the responsibility of drawing Congressional districts to the Commission.

#### **Supervisorial Districts**

At the October 21<sup>st</sup> meeting the City Council appointed Mayor Slooten to engage directly in the Board of Supervisors process for redefining supervisorial districts. Councilmember Cremer was appointed as an alternate to the Mayor. The Board's next public meeting on redistricting will be on November 2<sup>nd</sup>, so the Mayor will report back to the Council on the progress at that meeting. The County has created five options to discuss on November 2<sup>nd</sup>, which can be found here.

#### **RESOLUTION NO. 2021-47**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLEARLAKE URGING THE CALIFORNIA CITIZENS REDISTRICTING COMMISSION TO COMBINE ALL OF LAKE COUNTY WITHIN THE SAME UNITED STATES CONGRESSIONAL DISTRICT AND TO KEEP ALL OF LAKE COUNTY WITHIN THE SAME STATE SENATE AND ASSEMBLY DISTRICTS

WHEREAS, as a result of the passage of Proposition 20 by California voters in 2010, the California Citizens Redistricting Commission is responsible to establish new District boundaries based on information gathered through the decennial Census; and

WHEREAS, Lake County was split into two Congressional Districts after the 2010 Census, with Lakeport, Kelseyville and the southern part of the County included in the 5<sup>th</sup> Congressional District with portions of Napa and Sonoma Counties; and Clearlake and the northern part of the County included in the 3<sup>rd</sup> Congressional District with all or portions of Colusa, Glenn, Solano, Sutter, Yolo, and Yuba Counties; and

WHEREAS, the current 5<sup>th</sup> Congressional District wraps around the City of Clearlake on three sides, but does not include the City; and

WHEREAS, the criteria of the Commission state, "Districts must respect the boundaries of cities, counties, neighborhoods and communities of interest, and minimize their division, to the extent possible"; and

WHEREAS, the criteria of the Commission state, "Districts should be geographically compact, that is, have a fairly regular shape"; and

WHEREAS, Lake County qualifies as a community of interest based on the definition in the California Constitution, "A community of interest is a contiguous population which shares common social and economic interests that should be included within a single district for purposes of its effective and fair representation. Examples of such shared interests are those common to an urban area, a rural area, an industrial area, or an agricultural area, and those common to areas in which the people share similar living standards, use the same transportation facilities, have similar work opportunities, or have access to the same media of communication relevant to the election process."; and

WHEREAS, the criteria of the Commission and intent of the California Constitution are best accomplished by ensuring the entirety of Lake County is represented in each district rather than being segregated; and

WHEREAS, Lake County is geographically distinct and includes natural features that have created a well-defined and largely homogenous community within its borders; and

WHEREAS, Lake County, and particularly the City of Clearlake, is a region rich in Native American history and accompanying cultural resources. Keeping this region connected under a unified Congressional District will help protect and advocate for their interests; and

WHEREAS, Lake County shares many interests with Napa and Sonoma Counties, including similar agricultural, geothermal and tourism industries, and regional watersheds and water rights; and

WHEREAS, State Senate and Assembly Districts both incorporate all of Lake County as one unit and include all or portions of both Napa and Sonoma County;

WHEREAS, these points of common interest provide strong ties both within Lake County and with our southern neighbors, and long-term relationships among our three counties, making common, effective, and fair representation and advocacy in a shared Congressional District with the entirety of Lake County truly critical.

#### NOW, THEREFORE, BE IT RESOLVED:

The City Council of the City of Clearlake strongly urges the California Citizens Redistricting Commission to rejoin all of Lake County with our neighbors in Napa and Sonoma County within the same United Stated Congressional District, and to keep all of Lake County within our current State Senate and Assembly Districts, to provide the most logical, efficient and effective representation possible.

RE: OPPOSE Placement of Lake County in Visual Congressional District North Coast and Changes to State Senate and Assembly Visualizations

Dear Commissioners:

Our Board is very discouraged to learn Lake County has been included in "Visual Congressional District North Coast" in your Commission's recently published Visualizations, demonstrating hypothetical District-based boundaries.

As you are aware, proposed changes would align all of Lake County with Sonoma, Mendocino, Humboldt, Del Norte and Trinity Counties, as well as a portion of Siskiyou County, for federal representation. Further, proposed boundaries would make dramatic changes to Lake County's State level representation. The total loss of present alignments (Assembly, Senate and Congressional, alike) would be a great disservice to Lake County at what is a critical time.

You will recall, our Board previously submitted a Resolution, filed September 28, impressing on your Commission the vital import of rejoining all of Lake County in the same United States Congressional District with *both* of our neighboring Counties to the South, Napa and Sonoma County. Your proposed visualizations are directly contrary to Lake County's expressed input. We request you rereview that Resolution and reflect our input in your map.

As you will be aware, the agriculture and tourism industries are key facets of the Lake County economy. The southern portions of Lake County offer natural extensions of the cultural and Agritourism-focused opportunities of Sonoma County and the Napa Valley. We want to build on these synergies, and opportunities for Economic Development are enhanced by our sharing common representation. The majority of workforce-engaged residents of Lake County also travel out of the area for work; many to Napa and Sonoma Counties.

Sharing State and Federal level representation with both Napa and Sonoma Counties has been of great benefit to Lake County. Our Board does not appreciate what compels your Commission to change these alignments, and we very strongly urge you to reconsider.
