#### **BACKGROUND/DISCUSSION:**

The city solicited proposals for on-call engineering services to provide various engineering services. Each individual contract has a clause containing a not-to-exceed \$200,000 amount. A proposal was received for Drainage and Stormwater System Survey Services in the total amount of \$274,400.00. Any amounts exceeding \$200,000 are required to be authorized by a written amendment. In order to move forward with this contract, staff is requesting approval to authorize the additional amount of \$74,400.

This project is funded through the Community Development Block Grant for \$500,000, of which \$370,000 has been allocated for this activity.

### Research Report

Dr. Scott reported on arbovirus activity. No West Nile virus (WNV) or other arbovirus activity has been detected in Lake County in 2023.

No arboviral activity has been reported for California and the rest of the nation in 2023.

Dr. Scott reported on adult biting fly activity. In January, *Culiseta inornata,* were collected from the New Jersey Light Trap (NJLT) near Borax Lake and the NJLT in the Reclamation near Upper Lake.

Dr. Scott reported on tick testing. One *Ixodes pacificus* tick that was removed from a Lake County resident has been submitted to the Sonoma County Public Health Laboratory for testing for *Borrelia burgdorferi*. The tick was negative for Lyme disease.

Dr. Scott reported on Clear Lake gnat, Chironominae, and Tanypodinae surveillance in Clear Lake. In the Upper Arm, Clear Lake gnat larvae decreased from 2.82 larvae per dredge in November to 2.75 larvae per dredge in January. Chironominae numbers increased from 5.71 larvae per dredge in November to 6.57 larvae per dredge in January. Tanypodinae numbers increased from 1.50 larvae per dredge in November to 1.79 larvae per dredge in January.

### **Operation Report**

The rain gauge at the LCVCD office in Lakeport received 13.2 inches of precipitation in January 2023. The cumulative rainfall for this season is 21.8 inches.

On January 1, the level of Clear Lake was at -1.61 feet on the Rumsey Gauge, and reached 4.39 feet by January 31.

The January rainfall raised the lake level by 6.0 feet and filled all the treeholes. In addition, some low-lying areas have flooded and hatched *Aedes increpitus* larvae. The lake-associated wetlands have not yet flooded, and the District is continuing to monitor those areas.

No service requests were received in January, which is typical for this time of year.

Dr. Scott and Office Manager Jacinda Franusich attended the California Special District Association's live web event for records management on January 11-12.

District Vector Biologist Michelle Koschik, Dr. Scott, Vector Control Technician Sandi Courcier, and Trustee George Spurr attended the Mosquito and Vector Control Association of California (MVCAC) Annual Conference and Board Meeting on January 29-February 1 in Anaheim, California.

Lake County Water Resources used the District's lab facilities to process water samples they collected following rain events.

The Konocti Christian Academy used the District's conference room for meetings in January.

Dr. Scott attended several webinars and online workshops offered through the California Special Districts Association (CSDA) and other professional sources. Among the webinars Dr. Scott attended were the "2023 Employment Law Update for Public Entity Employers" offered by Meyers Nave Legal Services, and CSDA's webinar titled Brown Act: Come for the Basics, Stay for the Updates.

Dr. Scott's Certified Special District Manager renewal was approved in January by the Special District Leadership Foundation (SDLF), which is affiliated with the CSDA.

In February Dr. Scott will attend the Employer Risk Management Authority (ERMA) Annual Workshop and Board Meeting in Napa, California. In addition, Dr. Scott and Office Manager Jacinda Franusich will attend the Vector Control Joint Powers Agency Annual Workshop and Board Meeting in Santa Cruz, California.

District field and laboratory staff will attend the American Mosquito Control Association's Annual Conference in Reno, Nevada on February 27-March 3, 2023.
