WHEREAS, Cohoctah Township previously authorized a millage for roads and that millage expired in 2026;

WHEREAS, the Township desires to ask voters to authorize a millage of 1.5 mills (\$1.50 per each \$1,000 of taxable value), of which 1.4677 mills is a renewal of the previously authorized millage that expires in 2026 and .0323 mill is new additional millage, against all taxable property in the Township for a period of four (4) years, 2027 through 2030, inclusive, for the purpose of constructing, preserving, improving, repairing, controlling dust, and maintaining roads in the Township;

WHEREAS, the Township has determined that the request for a millage is in the best interests of the public health, safety, and welfare of the Township residents; and

WHEREAS, the Township has determined that it is the best interests of Township residents to request that such millage request be placed on the ballot at the August 4, 2026, election.

**THEREFORE**, be it resolved by the Board of Cohoctah Township, Livingston County, Michigan, as follows:

1. The Township Board certifies and resolves to present to the electors of Cohoctah Township at the August 4, 2026, election a proposed millage amount of 1.5 mills as described in the ballot language attached as Exhibit A; and
2. The Township Clerk is authorized and directed to promptly submit this resolution along with the ballot language attached as Exhibit A to the Livingston County Clerk for inclusion in the ballot at the August 4, 2026, election.
3. The Township Supervisor is authorized to make any typographical or non-substantive changes to this Resolution or the ballot language attached as Exhibit A.
4. All resolutions and parts of resolutions, insofar as they conflict with the provisions of this Resolution, are hereby rescinded.

**ROAD MILLAGE PROPOSAL**

Shall Cohoctah Township, Livingston County, Michigan, be authorized to levy a millage annually in an amount not to exceed 1.5 mills (\$1.50 per each \$1,000 of taxable value), of which 1.4677 mills is a renewal of the previously authorized millage that expires in 2026 and .0323 mill is new additional millage to restore the millage rate lost as a result of the Headlee Amendment millage reductions, against all taxable property in the Township for a period of four (4) years, 2027 through 2030, inclusive, for the purpose of constructing, preserving, improving, repairing, controlling dust, and maintaining roads in the Township? The estimate of the revenue the Township will collect in the first year (2027) if the millage is approved and levied by the Township is approximately \$259,000.
