CITY OF COLUMBIA FALLS CITY COUNCIL REGULAR MEETING MINUTES HELD APRIL 1, 2024

Mayor Barnhart called the meeting to order at 7:00 p.m.

<u>ROLL CALL</u>: Councilor King, Councilor Lovering, Councilor Piper, Councilor Robinson, Councilor Shepard, and Mayor Barnhart. Absent: Councilor Price.

Also present: City Manager Nicosia, Public Works Clerk Sobczak, City Attorney Breck via Zoom, and Police Chief Peters.

PLEDGE OF ALLEGIANCE

<u>APPROVAL OF AGENDA</u>: Robinson made motion to approve the agenda, motion seconded by Piper. Motion carried with all present voting in favor.

<u>CONSENT AGENDA</u>: Councilor Piper made motion to approve the consent agenda noting all claims appeared to be in order, seconded by Councilor Lovering with Council voting as follows. Ayes: Robinson, Shepard, King, Lovering, Piper and Barnhart.

Approval of Claims - \$106,038.31 - April 1, 2024 Approval of Special Payroll Claims - March 28, 2024 - \$1,537.69 Approval of Payroll Claims - March 29, 2024 - \$172,590.23 Approval of March 18, 2024, Regular City Council Meeting Minutes Approval of Memorandum of Understanding - Flathead County EMS and City of Columbia Falls - Non-Transport Agencies (QRU) and authorize City Manager to execute. Approval of Records Destruction Request

VISITORS/PUBLIC COMMENT (Items not on agenda)

Darin Fisher, 303 3rd Avenue West, Columbia Falls. Mr. Fisher noted that he received professional assistance from Police Officer Stufflebeem. Columbus Park is being used a lot immediately after the nets were put up and the courts were opened. It was great to see the courts open as soon as the weather permitted. Lastly, he had a good interaction with the Water Department when his meter was not working, in 20 minutes it was replaced.

PRESENTATIONS:

5 Year Pin - John Paliga - WWTP Operator 2

Mayor Barnhart presented a 5-years of service pin to John Paliga in the Sewer Department.

Fish, Wildlife & Parks - Justine Vallieres, Bear Conflict Management Specialist and People and Carnivores -Ryan Wilbur: Update on Mitigating Conflict/City Partnership

Justine Vallieres presented a power point on Bear Conflict Management recapping last year in Columbia Falls. She showed recorded collared bears in a 10-to-15-year window in the Flathead Valley, Columbia Falls and surrounding areas showing the area is a funnel for bears moving down the Flathead River. The goal is to mitigate human-bear conflicts such as managing attractants and enforcement of ordinances. Vallieres sought feedback on the effectiveness of the ordinance and Chief Peters answered that there were no reports of grizzly bears and only a few reports of black bears. Mayor Barnhart mentioned that the changing of garbage pickup time on the east side of town seems to have helped the problem a lot. Mayor Barnhart also about the

chances of a grizzly bear encounter at River's Edge Park. Vallieres said that it is minimal since bears are primarily active at night, especially in public places. Councilor Lovering was wondering if there are packets available for vacation rentals. Vallieres said they are available from People and Carnivores.

Ryan Wilbur, People and Carnivores, continued the presentation with another power point and passed out examples of the packets that are available to the Council. The packets are helpful reminders of the ways property owners or renters can mitigate attractants for wild animals. Wilbur went over bear behavior, attractants, and the tools that People and Carnivores have available for the public such as education and resources, garbage management, and the packets. Wilbur then asked if there were any questions. Lovering asked if they have reached out to property managing companies? Wilbur said not yet but he is interested in doing that. Wilbur continued with his presentation going over his attractant assessment in Columbia Falls. He has worked with the City and has helped increase the amount of bearproof trash cans in the parks. He finished by asking if there were any more questions. Lovering asked how much they work with the schools. Wilbur said that they have not tapped into the schools, but they would like to start thinking about creating an educational kit for students. Nicosia reminded Council that they had put funding in the budget to work with Ryan Wilbur's group therefore the City has been working with them on increasing the bear proof trash cans in the parks and Wilbur performed the attractant assessment to help identify the problem areas.

UNFINISHED BUSINESS:

Amended Call for Bids - WWTP Phase 2 Project

Nicosia said that during the pre-bid meeting for this project the contractors present requested another week before bid opening, so bid opening would be on April 16th, 2024. This requires the City to advertise the bid opening one more time to meet the statutory requirements for advertising and bid openings. Nicosia is recommending a special Council Meeting on April 22nd to award the bid so the project will remain on time. Nicosia is seeking a commitment from the Council for a special meeting on the 22nd of April at the regular meeting time of 7:00 PM. Councilor King made a motion to amend the call for bids to April 16th, 2024, and to schedule a special meeting on April 22nd to award the bid, motion seconded by Councilor Lovering with Council voting as follows. Ayes: Robinson, Shepard, King, Lovering, Piper and Barnhart.

Railroad Street Park/Affordable Housing Discussion

Nicosia reported that the City Council set a priority goal of working on affordable housing during this fiscal year. Council requested City staff to evaluate all city-owned properties for the possibility of building affordable housing, in partnership with NW Montana Land Trust and Habitat for Humanity. Nicosia noted the City Council requested staff to review the property owned by the City on Railroad Street, currently used as a ball field. Nicosia noted that the property was deeded to the City by MT DOT (1978) and is not dedicated parkland. Nicosia reported that she has talked to SD #6 Athletic Director and the Baseball Association President and there are alternate locations for the baseball field currently utilized by t-ball or rookie league. Nicosia reported that any development proposal must go through a planning process whereby applications for growth map amendment, zoning and subdivision approval will be submitted and will go in front of both the Planning Board and Council. Nicosia noted that in the Title 17 Subdivision Regulations, there must be 11% open space or cashin-lieu. 11% in this case is almost a standard city lot, 6,255 square feet; therefore, part of this acreage is required to be parkland. Nicosia said unfortunately there has been considerable misinformation about this proposal. The City is not putting in apartments for the homeless, that was never the goal, the goal is these units will be affordable, single-family homes. The City does not own other parcels of land that are not used for facilities or dedicated park land. The Northwest Community Land Trust found and purchased the most affordable city lot they could find in the fall of last year and a lengthy analysis is required, by the State before

the City can use the HOME program income to reimburse the Land Trust for that single lot. The money set aside for affordable housing must be used in Columbia Falls and the City has been hard pressed to find a place where it is usable. With respect to Railroad Street Park, an irrigation system was installed in the park in 2020 but a majority of that system will be reused. The goal of tonight's agenda item is for the Council to determine if they want to move forward with this project, knowing that a complete planning process is required.

Mayor Barnhart asked for public comment on the proposal.

Mary-Beth Morand, Executive Director of Habitat for Humanity Flathead Valley, stated that they build nice, affordable houses that are not just given away. Anyone who wants to purchase a house must qualify and jump through all the hoops. Most of their homeowners are middle class that have slipped through the cracks in the current housing market. There are other housing programs for low-income people, Habitat is not that. People can no longer "flip" Habitat houses, equity is capped, and Habitat gets the first right of refusal. They build attractive, energy-efficient houses, there is a current build project in Somers if the Council is interested in seeing examples. Habitat wants to boost communities and build for keeps, making houses that are permanently affordable. 60% of people living in Habitat houses are children so they are very happy to have plenty of green space for a safe place to play.

Darin Fisher, 303 3rd Ave E Columbia Falls. He is an advocate for green space and an advocate for affordable housing in town. He was on the Parks Committee when the irrigation system was installed at this park. The installation was for cost saving since employees did not need to pull hoses and set up sprinklers. He noted the announcement that Pyramid Lumber in Seeley Lake is shutting down due in a large part they could not find employees since employees could not find a house.

Shirley Folkwein, 285 Shooting Star Drive, Columbia Falls, speaking for the Flathead Neighborhood Association. Painful to think that a neighborhood is losing a park, but their mission statement says that they support sensible housing, and this is a good idea to put these two organizations together to find a solution for affordable housing.

Mayor Barnhart asked the Council for their thoughts.

Lovering stated that she would love to move forward on this project. Believing they all understood that when this comes forward and a formal application there is a desirability in green space around homes. She believes this is a homerun.

Shepard stated it is an issue when teachers retire, and they cannot get any new teachers to replace them since there is no affordable housing in this town. This will degrade our education system. Based on current statistics we could be looking at 30,000 more people in the Flathead Valley within 10 years. There are not support systems for this. It is time to do something about this. He supports this project.

Robinson stated that she is in favor of moving forward and there can be some greenspace on this lot with housing on the rest. The baseball situation seems to be taken care of satisfactorily. Change is hard but will happen and she is hoping that a compromise can be reached.

King noted that while she hates to give up a park she also does not like how families are moving away because they cannot afford to live here. The Council must do something to help our families. She is pro sport and pro

housing, and this is actually an affordable housing project, this is what she and the council have been striving for with the goal of affordable housing. We have other areas where we can put a baseball field but there are not other areas to put housing.

Piper agrees there are other places to put a baseball field, especially in the massive soccer fields at the Jr. High. To nurture baseball teams, you need to start them young, in tee ball, which he has coached, they do not need much of a field for tee ball, if you have a backstop. The City rarely gets these opportunities and he believes this project needs to go forward.

Mayor Barnhart said the undeveloped street to the west is 70 feet wide. His thought is to use the first proposed lot and the undeveloped street to give us two lots and develop two single family houses. He has worked with Habitat for 40 years and is a proponent of affordable housing, but he would like to see this reviewed again. Another point noted by Mayor Barnhart is that Columbia Falls does not have housing for employees, and we should rethink the housing situation. In Kalispell there are many apartment buildings, Columbia Falls employees could live in Kalispell and commute to Columbia Falls. There are lots of different ways to look at this, he does not want to lose the green space. He would like to see this green space developed with more parking and irrigation to make it a more usable community park. He does not think baseball is an issue and has been solved but he does not want to lose an existing park.

Shepard asked how many parks the city has. Nicosia answered that there are 14 parks on the City's map. Shepard responded saying there isn't another City that has that many parks. This park has been underused for many years.

Robinson asked about lot size for a Habitat home. Morand answered that she is not sure on the Railroad Street property but using the undeveloped road as a park she believes they could easily get 6 bungalows with enough yard space and garages. Robinson, what is the square footage? Morand, two-bedrooms are about 1300 square feet and three-bedrooms are about 1700 square feet including the garage. Robinson stated that she does not want to postpone this, the longer it is postponed the more time everything will take and there is a lot of hoops to go through.

Nicosia said that the City can start by vetting it through planning. Most lots in the City are platted at 50 feet wide, decades before zoning; the CR-3 zone sets a minimum lot width at 80 feet and all of the setbacks must be met even if a lot is unconforming. The City Planner can meet with Habitat and pencil out a conceptual subdivision design based on the consensus of the council to provide housing and green space.

Shepard asked about the Mitchell Way lot sizes. Nicosia answered that they are CR-5 zoning with townhouses and are small lots with the required green space in the northwest corner. Morand said it would not be a problem for Habitat to bring forward a design. She stated there was a lesson learned from Mitchell Way about storage space and green space as well as parking. Nicosia the City can look at what is proposed here based on this discussion and will bring forward a plan. Barnhart noted that alternatives need to be looked at as well.

Award Bid - WWTP Scum Pump and Controls Project - Highgrade Construction - \$109,788

Nicosia reported that this is one of the projects with HB 355 funding. City staff recommends Council award the bid to Highgrade Construction for \$109,788. Lovering made a motion to award bid to Highgrade Construction for \$109,788, seconded by Shepard with Council voting as follows. Ayes: Robinson, Shepard, King, Lovering, Piper and Barnhart.

REPORTS / BUSINESS FROM MAYOR & COUNCIL

Piper began by asking when the volleyball net would be going up at Columbus Park. Nicosia answered they will get the net up ASAP.

King reported that April 6th is the Falls Community cleanup day.

Shepard said the City needs to fill in potholes especially the one next to Mike's Conoco. Nicosia said the coldmix does not stay in place as long but as soon as the temperature is warmer the hot-mix will be used. Shepard talked about the deer in town and how a mountain lion was filmed taking down a doe and the neighbor might be feeding them. Vallieres mentioned that feeding wildlife is illegal and if seen please report it to a Game Warden.

Mayor Barnhart wondered when the bathroom at Columbus Park would be opened. Nicosia is not sure what was being worked on at that bathroom, but it should be open soon, noting there is no heat at that bathroom. Barnhart then mentioned that Nicosia had said that they are working on getting the River's Edge bathroom back open after freezing in the winter. He was hoping that when it is back operational after repairs that they can post that. Nicosia said that it was not posted online but a sign can be posted on the door and a seasonal use sign can be posted at Columbus Park. Barnhart then mentioned that Parkside Credit Union is beginning construction and wondered if a light will be installed. Nicosia said that it is DOT's call but has not heard anything on their decision and analysis. Nicosia noted that during the Urban Transportation Coordination Meeting that intersection was discussed as it is dysfunctional. Barnhart said every time we mention that the intersection is our priority at those meetings they do not seem to respond. Nicosia said the City will follow up. Barnhart asked when they plant fish into the pond at River's Edge. Nicosia said she does not know but they contact the City when they do, she will ask. Barnhart then mentioned that we really need to get the word out for the need for a 5th member on the Planning Commission. Nicosia said an individual reached out this weekend and it should be on the next Council meeting agenda.

Lovering asked about the box in Columbus Park, noting it is open and wires exposed. Nicosia said that it is a CenturyLink Lumen box, they have been notified multiple times and they do not care that it is open.

CITY MANAGER REPORT

Nicosia said the City staff submitted 4 separate House Bill 355 applications, the Wastewater Treatment Plant, Meadow Lake Flow Meter, Water Fire Hydrant replacement and the Veterans Dr Bike Path repair. Nicosia will be meeting with Sandry Construction and the EDA project engineer as Sandry has requested to be released from the contract due to the delay of another year due to the BNSF/MT DOT signal project. EDA is willing to work with the City and it would be ideal if the same contractor accepted the change order. BNSF would not give us the sidewalk easement and EDA will not reimburse without the easement, but their legal department reviewed the letter from BNSF stating that they will give the City an easement so EDA will release funds. The good news is there is movement towards completion. The RAISE Grant Request for Engineering Proposals will

be sent to the project point person for approval and next step is to call for engineering proposals. Historically City Officials and Public Works Committee will review proposals to select an engineer. There has been quite a bit of talk about property tax increased and she has heard from some taxpayers that they have gone up 50%. There was a glitch in the Property Tax Assistance Program that they are not fixing until 2024. If your income qualified you got 80% of the taxable value, but it was limited to the first \$200,000 of your property. Many people's property valuation had gone above that with the two-year reappraisal, and they were taxed more even though the City and County reduced mills. The community members that were most affected were the ones who qualified for the income-based reduction. The Department of Revenue, for the 2024 year, will have that deduction go up to the first \$350,000. Unfortunately, it will not be fixed until next year. Nicosia reported that Police Chief Peters is retiring in August. The City will be speaking at the next Chamber Meeting and the Mayor and Council members are invited as well. The meet and greet for the City Manager candidates is scheduled for Tuesday night from 6 to 7 with interviews the next day.

MISCELLANEOUS REPORT

Police Chief Peters stated that his retirement is not for negative reasons but is all for positive reasons. This position was a challenge, but it was the most fun he has had in law enforcement. The department is in a perfect place right now for someone new to come in and put the finishing touches on. There will be 10 officers on the road upon completion of training. Chief Peters is very proud of his department and thanked the Manager and Council for their support.

Councilor Piper motioned to adjourn, seconded by Councilor Lovering and the meeting was adjourned at 9:17 p.m.

AGREEMENT FOR TEMPORARY CONSTRUCTION EASEMENT

THIS AGREEMENT, made and entered into this _____ day of _____, 2028; by and between the City of Columbia Falls, 130 6th St West, Columbia Falls, MT 59912, hereafter referred to as the City, and the Nagle Family Trust, hereafter referred to as the Owner.

WHEREAS, the City is in the process of adding concrete sidewalk, curb, and gutter within the established City right-of-way on 2nd Street West in Columbia Falls, Montana, fronting the property owned by the Owner herein;

WHEREAS, the parties hereto desire to mutually agree upon the conditions, requirements and understandings for the establishment of a temporary construction easement as shown in the attached Figure Number 3 upon the property of Owner;

NOW THEREFORE, for and in consideration of the mutual covenants contained herein, and other good and valuable considerations, the parties agree as follows:

1. The Owner does hereby grants to the City, its agents, contractors, or assigns permission to enter upon Owner's real property for purposes of constructing new concrete sidewalk, curb, and gutter; asphalt paving; concrete approach aprons, and other improvements as shown in the attached figure.

2. **WORK TO BE ACCOMPLISHED**: The City shall exercise the permission granted herein by removing existing asphalt driveway pavement, removing existing fence, and excavating within existing vegetated lawn areas in accordance with the uniform codes of the State of Montana and local jurisdiction. The disturbed property will then be reasonably restored as shown on the attached figure. Where shown on the attached figure, gravel surfacing shall be placed to a depth of 6 inches and topsoil shall be placed to a depth of 4 inches for restoration purposes. Topsoil areas included in the restoration shall be seeded.

3. **WARRANTY**: The City shall warrant to the Owner, his/her heirs, successors and assigns, for a period of two years following completion of the work described in paragraph 2 herein, that said work has been done in a workmanlike manner and that the Owner's property had been restored to at least its prior condition. It shall be the responsibility of the Owner to notify the City of any settling or other problem during the warranty period. Upon conclusion of said two year period, the City shall have no further responsibility or liability with regard to the work accomplished.

4. **LAYOUT OF THE TEMPORARY CONSTRUCTION EASEMENT**: The proposed temporary construction easement shall be established as shown on the attached figure.

5. In the event legal action, including litigation, is undertaken to interpret or enforce any aspect of this agreement, the prevailing party shall be entitled to attorney's fees and court costs.

6. Any modifications of this agreement or additional obligation assumed by either party in connection with this agreement shall be binding only if evidenced in writing signed by each party or an authorized representative of each party.

7. This Agreement shall be construed, interpreted and enforced in accordance with and shall be governed by the laws of the State of Montana applicable to agreements entered into and wholly to be performed therein. In the event of any conflict between any provisions hereof and any applicable laws to the contrary, the latter shall prevail, but this Agreement shall be deemed modified only to the extent necessary to remove such conflicts.

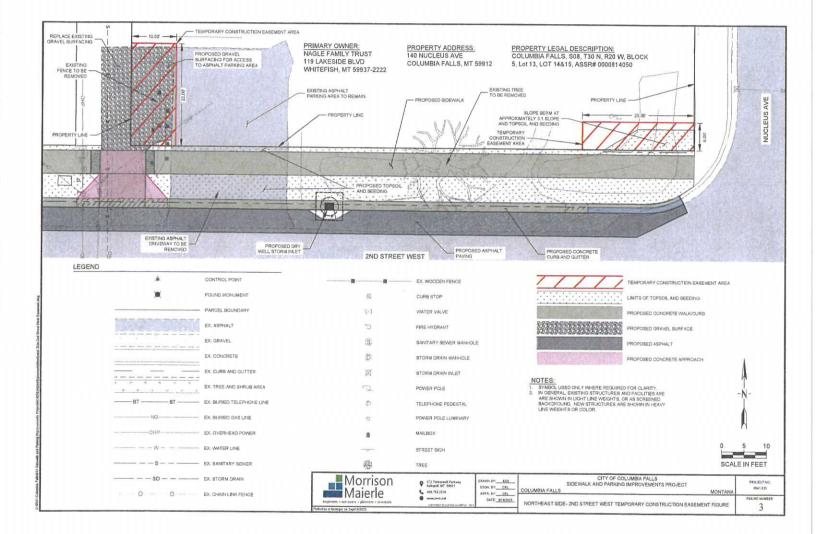

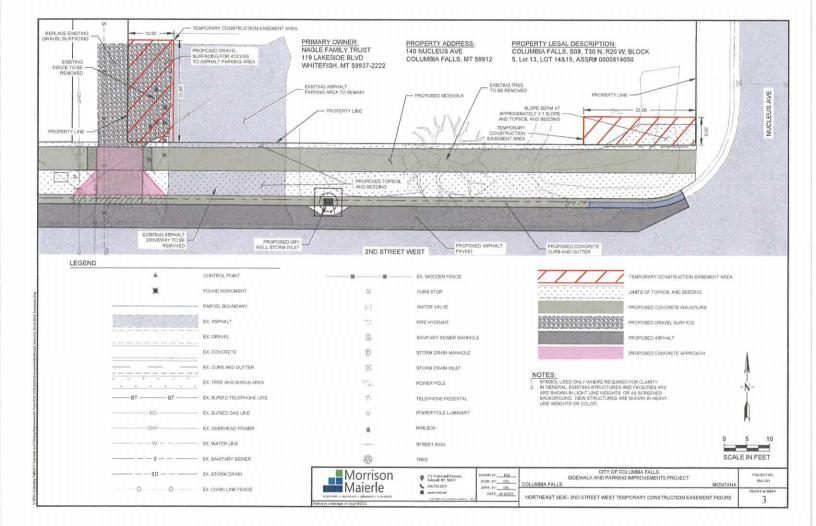

Good Afternoon

First off, I want to thank Susan Nicosia for taking the time to speak with me the other day regarding this commission; her insight and thoughts were very helpful in solidifying my decision to apply and to hopefully assist in the growth and development plan for the city of Columbia Falls.

As an (almost) lifelong resident of Columbia Falls, as well as having both a family and businesses that operate in the city, I have a very vested interest in both the past as well as the future of our town. We have come to a unique time frame where we have already experienced significant change and are on the cusp of even more. I believe that the right individuals and insight can help guide our town to help maintain its character, integrity, and unique lifestyle while still moving forward with a growth mindset.

RE: Manager's Report

- 1. The EDA meeting held to discuss the 12th Ave West completion was productive. The City will complete the contract change documents and release Sandry Construction from the remainder of the project, the paving at the RR crossing and the RR ROW sidewalk completion, an estimated \$67k on the current project documents.
- 2. The Parks Department had to order poles for the Volleyball pit at Columbus Park so the installation of the net has been delayed. Additionally, tragedy struck the River's Edge Park bathroom sensors (contractor vehicle caught on fire), so new sensors are enroute. Porta potty folks moved the park porta potty to the river location despite being told to keep in place.
- 3. The County's switch to the new tax system resulted in tax and assessment collections being reported in the wrong fund/type. Therefore, the Finance Director and I have held off submitting a financial report to Council as they revenues funds and sources must be corrected.
- 4. The City erred on the Sidewalk and Parking Improvements Project. There was not a public open house to review the project with the property owners before work began. I have corrected this serous oversight, and the City is holding an open house on the evening of April 17th at 7:00 PM in the Council Chambers.
- 5. Bid opening for the WWTP Project will be Tuesday, April 16th, 2 pm. There were 5-6 contractors at the pre-bid meeting so we are optimistic that we will get several bids.
