Discussion regarding a vehicle lease program with Enterprise

Amundson opened this discussion by sharing that between the Utility, Public Works, Police and Fire Department staff and himself we have created a master fleet list and shared it with Enterprise. They have done some analysis and looked at how their program would fit into our fleet. This is primarily non-CDL vehicles. There are some positives and some items of concern. It ultimately comes down to a financial decision. We currently buy our vehicles through borrowing, through our CIP Plan. This would change that to an annual leasing, or budgeted item. Council members questioned costs, future expenses involved, maintenance, vehicle add-ons, and whether or not the city could handle a similar program itself. Also, whether or not the program would work with what the Police Department would like to move forward with: the "take a vehicle home" plan.

Amundson has asked Ehlers to share their thoughts on this opportunity, as well. Further discussion can take place during the budget review process.

3. Discussion and review of Task Order No. 2404 with Ruekert and Mielke related to the Udey Dam. Amundson shared that the city has received notification from the Wisconsin Department of Natural Resources with their concerns regarding recent flooding and how it has impacted the Udey Dam. We have been asked to complete a safety inspection. Ruekert-Mielke has been asked to create this task order. Committee agreed to move forward to the next regular Common Council meeting on 10/01/2024 for a vote.
