Item Title: Consider and take action regarding tree border concerns in the City of Columbus

Detailed Description of Subject Matter:

I've recently fielded concerns and have noticed violations within the tree border. I've included ordinances related to the Tree Border below and would like to have a discussion regarding this issue with the committee.

Sec. 106-66. - Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Tree border means and includes any publicly owned land abutting the traveled portion of a public street or alley in the city.

Sec. 106-39. - Planting of public **trees** and shrubs.

(a) **Tree planting program.** The city forester, using the Arboricultural Specifications Manual for the City of Columbus and with the advice and approval of the beautification committee, shall recommend to the common council a program for **tree** planting, care, and protection for public **trees** and shrubs. The council shall also encourage the planting, care, and protection of **trees** and shrubs on private premises within the city.

(b) **Unlawfully planted trees.** **Trees**, plants, or shrubs planted within the **tree border** without the authorization and approval of the forester may be removed. The abutting owner shall be notified in writing, listing the unlawfully planted **trees**, plants, or shrubs stating that they will be removed and when.

Sec. 106-67. - Parking of vehicles, placing of signs and storage of goods or merchandise restricted.

No merchandise, goods, materials, equipment, signs or vehicles shall be stored, placed, left or parked on any **tree border** or other public place within the city except as follows:

(1) Materials customarily removed by the city may be placed on the **tree border** a reasonable time prior to the anticipated pickup by the city.

(2) Motor vehicles may be parked on the **tree border** to facilitate snow removal in the city after first securing the permission of the chief of police.

(3) Motor vehicles may be parked on the **tree border** in public parking stalls clearly designated by the public works department at the direction of the common council.
