### Upcoming Programs

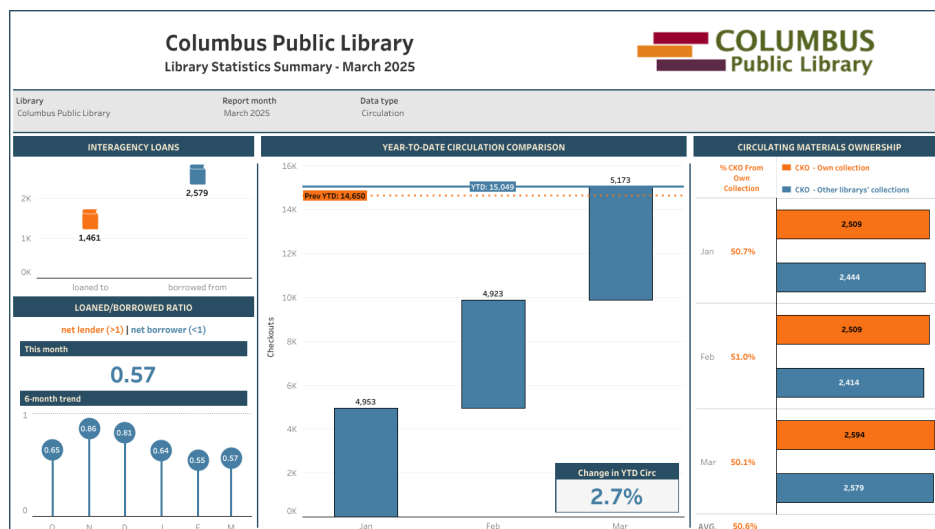

## PERSONNEL:

Madeline Kraus was sworn in on April 28, 2025 as the newest full time police officer. Officer Kraus graduated from the Madison College Police Academy in 2024 and has worked part time for the Fall River Police Department. She began her field training on April 30, 2025 with a training officer for the next 2-3 months.

The vacant Sergeant and remaining Officer vacancies have been posted for some time. Two (2) applications have been received from very experienced officers. Both of those applicants had been terminated by other, larger departments. cursory reviews were done and I deemed both ineligible to continue on in our process. The postings were renewed.

## COMMUNITY EVENTS:

On April 26, 2025 I staffed the spring National Drug Takeback event at the Columbus Police Department. On that day we collected 38 pounds of drugs and packaging. Since the fall 2024 drug takeback event, we collected another 156 pounds in our secure lobby drop box, which is accessible 24/7. Total weight was 194 pounds. The drugs collected were turned over to the Wisconsin Department of Justice on April 28, 2025 at the State Patrol Headquarters in De Forest for incineration.

National Night Out is only 3 months away and will be on August 5, 2025 from 5:30 p.m.-7 p.m. Our committee of staff have already met and assignments given.

## TRAINING:

All sworn staff attended firearms training at the Juneau range.

Officer Knoll attended the 3-day Wisconsin Department of Justice Training and Standards Bureau IDC (Instructor Development Course) class at the Columbus location of Madison College's Law Enforcement Training Center. This class is a requirement for any law enforcement officer to attend and teach a law enforcement skill/discipline at the instructor level. It includes formulating a lesson plan, training methods, testing, and other skills associated with teach a class to Wisconsin training standards. Officer Knoll will be attending 2 instructor level disciplines in the next few months and subsequently be credentialed as an instructor in them.

Lieutenant Ward and Administrative Manager Kellar attended a 2-day (virtual) training on WIBRS reporting. WIBRS stands for Wisconsin Incident Based Reporting System and is the required state system for collecting statistics from law enforcement agencies. We are required monthly to electronically report crime statistics to the state thru a WIBRS portal. While it may sound pretty straightforward, it is very complex and reportable incidents have a subsequent spider web of questions associated with them.

## TRAFFIC ENFORCEMENT/CITATIONS:

During the month of November officers issued 93 traffic citations, 134 warnings and 52 ordinance citations.

## MATTERS OF INTEREST:

A road rage incident occurred which culminated with the driver of 1 vehicle pointing a pistol at the other. An arrest was made and criminal charges were issued.

We also had a separate road rage that happened involving 2 motorists near the school during the morning drop off time. One driver misinterpreted what he saw another vehicle do, and began yelling, blowing his horn, and squealed his tires to make a u turn and began following the other party at a high rate of speed to get her license plate number, which caused her fear. A citation for Disorderly Conduct 4<sup>th</sup>+ offense was issued to one of the parties.

Officers were called to a pharmacy reporting they had filled a prescription they later found to be fraudulent. It was written on a prescription pad of a doctor who left the clinic he was working for in September 2024. During the course of this investigation, it was also discovered this same prescription pad was used to obtain a fraudulent prescription in Whitewater. That incident remains under investigation.

An elderly person who was on her computer received a pop up on her computer. When she tried to X out of it, a popup with a phone number to call for 'help' popped up. She called it and the person on the other end claimed to be from the Social Security Administration. She did provide personal identifying information that puts her at substantial risk of identity theft. She was provided steps to take to monitor the situation.

An elderly person was notified that a false check of hers in the amount of \$65,000 was attempted to be cashed in Fond Du Lac. She banks in Columbus but resides out of the city. She was referred to her local agency.

An elderly person was not able to access their streaming service to watch TV. He elicited the help of a neighbor, who went online to try and resolve. They believed they were connected to the streaming service, but in fact it was an extremely close web address, but not the legitimate streaming service. In the end, they were defrauded out of \$100d before realizing it was not the legitimate site.

A resident of Columbus was searching online for an apartment to rent. She found one posted in De Forest and communicated with the 'landlord.' In total she sent him \$3005 for first and last months rent, a pet fee and other miscellaneous fees. The post was a fraud and no documents were received. He also told her he was mailing the keys, which on its own is suspicious. She paid the funds through PayPal and the appropriate complaints to them are pending, awaiting their investigatory process.

A 51-year-old Beaver Dam male was arrested for Domestic Disorderly Conduct and Stalking following an investigation. He was taken into custody on our request as he lives in rural Dodge County and was not at the scene of the incident in Columbus when we handled the initial investigation.

Officers and other first responders were dispatched to a report of a 24-year-old male who had committed self-harm. On arrival he was located with substantial cuts on his arms and had lost a life-threatening amount blood. He was taken to a Madison hospital for surgery and had his mental health needs assessed.

The department investigated a report of child abuse against a 15-year-old male by his step dad. There was not enough information to support an arrest. The report has been reviewed to the Columbia County District Attorney's Office for charging review, as well as Social Services for any services they can offer the family.

A citation was issued to a 36-year-old man for theft following an investigation into missing monies from coin laundry machines located at an apartment complex.

A 24-year-old male from Stoughton was cited for theft following an incident at a convenience store. A customer had set purchased items, that were in a bag, down to do something else, and left the store without them. When he returned, the items were gone. Store video showed a license plate of the vehicle the suspect left in, which identified him.

Council President Finkler called the meeting to order at 6:30pm. Members present included: Mayor Joe Hammer, Council President Molly Finkler, Alderperson Michael Lawson, Alderperson Marcus Meier, Alderperson Trina Reid, Alderperson Amy Roelke, and Alderperson Ryan Rostad.

### Notice of Open Meeting

Noted as posted.

### Approval of Agenda

Motion made by Alderperson Rostad, Seconded by Alderperson Meier to approve the agenda. Motion carried on a unanimous voice vote.

### Committee Minutes for File

### Public Comment

Mayor Proclamation honoring the Columbus Archery Team:

Mayor Hammer read and presented a Proclamation declaring May 10, 2025 Columbus Archery Day in honor of the Columbus Archery Team achieving an historic sweeping victory at the 2025 NASP Wisconsin State Bullseye Tournament and securing their placement in the National competition on May 10, 2025.

John Trava - 321 N. Spring Street - spoke in favor of the city allowing chickens and asked members to consider changing municipal code to allow for an increase in the number of chickens allowed based on lot size and neighbor proximity.

### New Business

#### 3. Discussion regarding Chicken Ordinance, Sec. 14-19 of the Municipal Code:

Alderperson Roelke brought this discussion to the meeting regarding the possibility of amending the chicken ordinance to allow for residents to own more than four hens. Chief Weiner shared his recent experience in dealing with residents who also have roosters on their property, or who have not submitted their application for a license. He has reached out and heard back from thirteen other area municipalities and the average number of allowable hens is four, with no roosters. Alderperson Lawson asked if any of those municipalities based the number of chickens allowed on lot size. Weiner replied there were none. Several options were discussed by members with the decision to leave the code as is with the exception of increasing the number of allowable hens from four to eight. Committee members agreed to move forward the revised Ordinance to the May 20, 2025 Common Council meeting.

**4. Consideration and possible action regarding referring ordinance review of 114-95 Outdoor Storage of Vehicles:**

Aldersperson Meier brought this item to this meeting agenda. After a brief discussion, members agreed to move to the Plan Commission for review.

**5. Consideration and possible action regarding referring ordinance review of Chapter 18-571 through 18-580 Property Maintenance:**

Kornmann shared that the Property Maintenance section of the municipal code is in Chapter 18, the building code. The maximum lawn height is currently at twelve inches which is not necessarily the standard the city should have. In addition, there are other parts of this chapter needing review. This chapter is not part of the zoning code and therefore not part of the zoning re-write. He is suggesting that the Plan Commission can provide a review and possible revision of the entire chapter, or smaller section as directed by Council. Amundson reiterated that Chief Weiner and Kornmann should work together on a blight presentation for the CDA. After further discussion, members decided to forward the blight portions to the Community Development Authority (CDA), and the lawn height issue to the Plan Commission for review.

**6. Discussion of Electronic Cigarettes/Vaping Ordinance:**

Chief Weiner presented a draft copy of an ordinance regulating electronic smoking devices and electronic smoking device paraphernalia to committee members which will allow our Police Department to be more efficient with guidance in dealing with this issue. Aldersperson Meier asked if there is a penalty included for anyone selling to someone under the age of 21 years old. Members agreed that the penalties should include Sec. 66-180 (g) and perhaps be increased. Attorney Johnson will amend with the changes discussed including the ability to enforce the ordinance with the retail outlets that sell these products, and focus on one set of penalties for violators and one set of penalties for sellers with the enhancer. Members agreed to move forward to the May 20, 2025 Common Council meeting. Attorney Johnson will prepare an ordinance for review by council.

**Adjourn**

Also, the Police Chief or their designee should act as legal custodian for all the records of the City of Columbus Police Department, except for personnel records which should be kept by the City Human Resources Administrator with the other city employee documents.

Unless otherwise prohibited by law, the City Clerk or its designee shall act as the legal custodian for the City Council and for any committee, commission, board or other authority created by ordinance or resolution of the City Council. The Police Chief or its designee shall act as legal custodian for all records of the City of Columbus Police Department, except the City Human Resources Administrator, or its designee, shall be the custodian of records for personnel records of Police Department employees.

- (c) For every authority not specified in subsection (a) or (b), the authority's chief administrative officer is the legal custodian for the authority, but the officer may designate a staff employee to act as the legal custodian.
- (d) Each legal custodian shall name a person to act as legal custodian in the custodian's absence or the absence of the custodian's designee.

2. The first sentence of Sec. 14-19(2) is amended to now read as follows:
  - (2) The keeping of up to 8 chickens is conditioned upon the following:
3. 14-19(c)(1) of the City Code is repealed in its entirety and recreated to now read as follows:
  - (1) Any person who keeps chickens in the City shall obtain an annual license prior to July 1 of each year or within 30 days of first acquiring chickens.
4. **Severability.** Each section, paragraph, sentence, clause, word, and provision of section 14-19 is severable, and if any such provision shall be held unconstitutional or invalid for any reason, such decision(s) shall not affect the remainder of the ordinance nor any part thereof other than that affected by such decision.
5. **Effective Date.** This Ordinance shall take effect immediately upon its passage and posting as required by law.

### Detailed Description of Subject Matter:

The use of electronic cigarettes, also known as vape devices, has increased substantially in recent years. It is becoming popular among teens and those under 21 years of age. Not only are we seeing devices and flavored vape cartridges, but we are also seeing them that contain nicotine and THC, the active ingredient in marijuana.

We have been citing those underage found in possession of the devices or cartridges under different provisions of current ordinances that aren't specific to these devices and are not the best fit. This ordinance appropriately and directly addresses the electronic (vape) devices and paraphernalia. This ordinance will not result in a substantial increase in citations. The ordinance was modeled after one currently being used in another community.

City Attorney Johnson has reviewed this request and created a draft ordinance.

The Common Council of the City of Columbus, Columbia County, Wisconsin does hereby ordain as follows:

1. Sec. 66-180, Regulation of Electronic Smoking Devices and Electronic Smoking Device Paraphernalia, is created to read as follows:

**Sec. 66-180. - Regulation of Electronic Smoking Devices and Electronic Smoking Device Paraphernalia.**

- (a) **Purpose and authority.** Section 66-180 is adopted for the purpose of protecting the public health, safety, comfort and general welfare of the people of the City of Columbus. This section is adopted under the authority of Wis. Stats. §101.123(4m).
- (b) **Definitions.** Except as set forth below, the definitions of Wis. Stats. §101.123(1) are hereby adopted. In this section:
  - (1) Electronic smoking device means any product containing or delivering nicotine or any other substance intended for human consumption that can be used by a person to simulate smoking through inhalation of vapor or aerosol from the product. "Electronic smoking device" includes any component part of such product whether or not sold separately. The term shall include such devices whether they are manufactured as electronic cigarettes, electronic cigars, electronic pipes or any other product name.
  - (2) Electronic smoking device paraphernalia means cartridges, cartomizers, e-liquid, smoke juice, tips, atomizers, electronic smoking device batteries and chargers and any other item specifically designed for the preparation, charging or use of electronic smoking devices.
  - (3) Retailer means any person who sells, offers for sale, or does or offers to exchange for any form of consideration, electronic smoking devices or electronic smoking device paraphernalia. "retailing" means the doing of any of these things. This definition is without regard to the quantity of the electronic smoking devices or electronic smoking device paraphernalia sold, offered for sale, exchanged, or offered for exchange.
  - (4) Self-service display means the open display or storage of electronic smoking devices or electronic smoking device paraphernalia in a manner that is physically accessible in any way to the general public without the assistance or a retailer or employee of a retailer. A vending machine is a form of self-service display.



- (5) Smoking has the meaning given in Wis. Stats. §101.123(1)(h), and also includes use of an electronic smoking device which creates an aerosol or vapor, in any manner or in any form or the use of any oral smoking device.
- (c) **Prohibition on smoking in city buildings and property.** No person may smoke within any portion of any municipal building in the city or any access corridor leading thereto or any municipally owned vehicle. Building is defined as any structure having a roof supported by columns or walls and all park shelters.
- (d) **Prohibition on smoking in smoke free places.**
  - (1) The provisions of Wis. Stats. §101.123 relating to the prohibition of smoking in various enclosed places, are hereby adopted and made part of this Code by reference.
  - (2) No person, employer or nonprofit entity shall knowingly permit smoking in an area under the control of that person, employer or nonprofit entity and in which smoking is prohibited by law.
  - (3) No person shall use an electronic smoking device on school grounds or in school buildings.
- (e) **Prohibition on possession by underage individuals.** Possession of an electronic smoking device or electronic smoking device paraphernalia by an individual under the age of 21 is prohibited in all places within the City of Columbus.
- (f) **Prohibition on possession by underage individuals on school grounds or in school buildings.** Possession of an electronic smoking device or electronic smoking device paraphernalia by an individual under the age of 21 is prohibited on school grounds or in any school building.
- (g) **Retailing requirements and regulations.**
  - (1) No retailer shall sell, give or furnish an electronic smoking device or electronic smoking device paraphernalia to a person without first examining identification to confirm that the recipient has attained the age of 21.
  - (2) **Sale to underage prohibited.** It shall be a violation of this section to sell, give or furnish, or cause to be sold, given or furnished, an electronic smoking device or electronic smoking device paraphernalia to a person who is under the age of 21 in any place within the City of Columbus.
  - (2) No person, motivated by an economic or a business purpose, shall engage in the non-sale distribution of any electronic smoking device or electronic smoking device paraphernalia within the City of Columbus.
- (h) **Purchase or possession of electronic smoking device or electronic smoking device paraphernalia by persons under 21 prohibited.**
  - (1) No person under 21 years of age may falsely represent his or her age for purposes of receiving any electronic smoking device or electronic smoking device paraphernalia.
  - (2) No person under 21 years of age may purchase, attempt to purchase, or possess any electronic smoking device or electronic smoking device paraphernalia except as follows:
    - a. A person under 21 years of age may purchase or possess electronic smoking devices or electronic smoking device paraphernalia for the sole purpose of resale in the course of employment during his or her working hours if employed by a retailer.

- b. A person under 21 years of age, but not under 15 years of age, may purchase, attempt to purchase or possess electronic smoking devices or electronic smoking device paraphernalia in the course of his or her participation in an investigation under the same terms and conditions as an investigation as set forth in §254.916, Stats.
  - c. No person may purchase electronic smoking devices or electronic smoking device paraphernalia on behalf of, or to provide to, any person who is under 21 years of age.
  - d. A law enforcement officer shall seize any electronic smoking device or electronic smoking device paraphernalia that has been sold to and is in the possession of a person under 21 years of age.
- (i) **Penalties.**
  - (1) Those who violate 66-180(c), 66-180(d)(1) or 66-180(d)(2) shall be fined \$20.00 for a first offense, \$50.00 for a second offense, and \$150.00 for a third and subsequent violation.
  - (2) Those who violate 66-180(d)(3) and 66-180(f) shall be fined \$50.00 for a first offense, \$150.00 for a second offense, and \$200.00 for a third and subsequent violation.
- 2. **Severability.** Each section, paragraph, sentence, clause, word, and provision of section 66-180 is severable, and if any such provision shall be held unconstitutional or invalid for any reason, such decision(s) shall not affect the remainder of the chapter nor any part thereof other than that affected by such decision
- 3. **Effective Date.** This Ordinance shall take effect immediately upon its passage and posting as required by law.

Section 18-578 (c) *Natural law exception—Registration and fee.* Any owner or occupant of a lot or parcel subject to subsection (b) above and desiring a natural lawn may register with the city clerk for a natural lawn as defined in subsection (a)(2) above where grasses and foliage exceed ~~12~~ 8 inches in height provided that such plantings meet the requirements of this subsection. Applications for registered natural lawns shall be available from the office of the city clerk and the fee for a registered natural lawn will be set by the City of Columbus Common Council.

**Detailed Description of Subject Matter:** The Doylestown Fire Department is again requesting to use the Pavilion for a gun raffle fundraiser in April (Spring) of 2026. This would require us to exempt them from Sec. 66-216(b) of our municipal code for this event. The actual dates of the event will be shared when they have been decided upon.

**Sec. 66-216 reads as follows:**

**Sec. 66-216. - Firearms.**

- (a) No person, except an authorized peace officer, shall discharge any firearm within the city. Provided, however, this prohibition shall not be enforced if the actor's conduct is justified or, had it been subject to a criminal penalty, would have been subject to a defense described in Wis. Stats. § 939.45. Further, upon prior written approval of the chief of police, persons or a group may discharge a firearm for the purpose of engaging in creational target shooting at an approved club or range or for historical re-enactment events.
- (b) No person shall carry a concealed or unconcealed firearm into any building owned, occupied or controlled by the city where the city has notified the person in writing not to enter or remain in any part of the building while carrying a firearm, which notice complies with Wis. Stats. § 943.13(2). A "firearm" means a weapon that acts by force of gunpowder.

(Ord. No. 669-11, § 1, 1-17-12) **Editor's note—** Ord. No. 669-11, § 1, adopted Jan. 17, 2012, repealed former § 66-216, and enacted a new § 66-216 as set out herein. Former § 66-216 pertained to the same subject matter and derived from Code 1978, § 9.02.
