- Est. (quote) for project: \$277,000.00
  - Does not include anticipated City cost of internal staff demo
- Current Project Timeline: 20 Weeks
  - Once equipment is ordered and we have a reliable ETA, more specific project dates will be provided.

 Goal is to have complete by end of February 2025, in anticipation of T-Ball starting March 1
