MINUTES

CALL TO ORDER - Mayor Conrado called the meeting to order at 6:05 pm.

ROLL CALL – Council Members Ponciano, Vaca, Markss, Codorniz and Mayor Conrado were present.

11. Consideration of intent to secure Sourcewell Contract and Plan for purchase of an Aerial Ladder Truck.

Fire Chief Conley provided new information on the down payment. Council asked questions and obtained clarification from Chief Conley.

Public Comments – Citizen Womble commented about high buildings in town and possible mandatory requirements for a ladder truck. Citizen Stuck asked about grants in the future for the ladder truck.

ACTION: Motion made by Council Member Ponciano to adopt the Resolution authorizing staff to proceed with planning and ordering activities for the future purchase of a ladder truck through a Sourcewell cooperative contract. With a total estimated cost of \$1.6 million. **Motion failed with no second.**

12. Consideration of suspending the Parks, Recreation, and Tree Commission and future restructuring.

City Manager Cain provided the report.

Public Comments: PRT Chair Elizabeth Yerxa stated the duties for the commission are found in Ordinance 500. She referred to the Resolution in 2014 when the commission merged. Lesli Poland, PRT Commissioner, provided a summary of what the commission accomplished over the years.

Thomas Roach, PRT Commissioner, shared his passion for being on the commission.

Jim White, HPC Commissioner, shared the value of having the PRT Commission.

Cynthia White, PRT Commissioner, shared her sadness that the council may suspend the PRT Commission.

ACTION: Motion by Council Member Ponciano, seconded by Council Member Codorniz to table this item until Council has had time to review the Ordinance.
