Public Comments: Rick Kunze, Colusa Net provided information relating to the proposal and his opposition to it. Citizen Daniel St. James explained his opposition to the internet dish on the towers. Citizen Thomas Roach also expressed his opposition of antennas on the water towers.

Council directed staff to inform Succeed Net that the City of Colusa was not interested. There was council consensus keeping the water towers free from any type of antennas or internet dishes.

11. FEMA Mapping Update and Discussion

City Engineer Swartz and City Manager Cain explained Colusa was the last city in the State to be mapped. Swartz stated letters were mailed to 652 residents who were in the flood zone. He recommended citizens contact their insurance company after they receive their letter. Swartz provided FEMA handouts to the council and the public. City Manager Cain explained existing homes in the flood zone would need a surveyor if they pull building permits. Swartz provided directions to the FEMA website to check if their property was in the flood zone.

Public Comments: Supervisor Kalfsbeek-Smith stated the county mailed notifications over a year ago to every parcel owner in the county.

12. Consideration of updated information on the American Relief Program Act (ARPA) / State and Local Fiscal Recovery Funds (SLFRR) expenditures.

City Manager Cain and Finance Director Aziz-Khan presented information. There will be an updated ARPA Spending Plan in the upcoming budget. A spreadsheet was provided of what the council approved last year. The timeline to spend the money is December 2026.

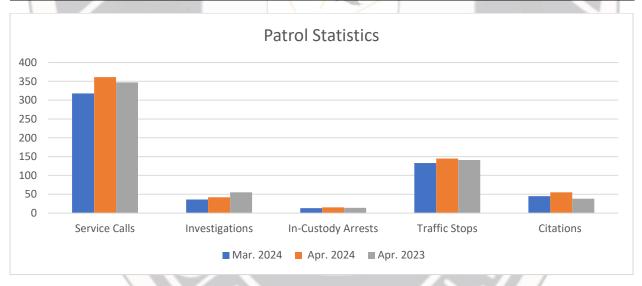

# Monthly Report for April 2024

#### **Monthly Statistics**



- There were 361 calls for service for patrol officers with 33 agency assists. The call volume in April increased 12% as compared to March. In April of 2023, there were 347 calls for service which is slightly lower than the call volume of the current year. It is not uncommon to begin to see an increase in the call volume as the weather becomes warmer.
- During April 2024, there were 15 in-custody arrests. There were 3 citations issued in lieu of subjects being booked in jail. There were 4 domestic violence related incidents reported in April. There were 2 DUI related arrests made. There were 42 reports initiated.
- During the month of April, officers initiated 145 traffic enforcement stops. There were 55 citations issued. Several of the citations issued were for registration and driver's license related violations and stop sign violations. There were no reportable traffic collisions with injuries.
- The Police Services Manager handled 72 calls for service during the month of April. These calls for service don't include telephone calls handled by the Police Services Manager.

#### Items of Interest

- The 'major case of the month' involved an assault with a firearm that took place on April 7<sup>th</sup> in the 400 block of Carson Street. Two male suspects along with a female suspect approached two men walking west on Carson Street. An AR-15 style rifle was produced and used to strike the male victim as the other male accompanying the victim walked away. Fortunately, the weapon wasn't fired nor did the victim sustain severe injuries. A search warrant was subsequently served at the residence of the suspects and associated vehicles. The firearm was recovered and all three suspects were booked into Colusa County Jail on charges associated with the attack.
- During the months of March and April, the Colusa Police Department worked with Cordico to develop and launch an application for officer wellness. This application is not only available to officers but also their spouses/significant others and children as well as retired officers. The application assists with not only mental health but also physical fitness, healthy sleep habits, financial fitness. Resources to mental health therapists, chaplains, and the Employee Assistance Program are also accessible through the application.
- Code Enforcement along with Officers will continue to check trucks/trailers for compliance with paying launch fees at the boat launch in Colusa. Additionally, vehicles will also be issued citations for vehicles not legally parked in the immediate.
- It is not uncommon for the Colusa Police Department to receive complaints about vehicles parked along public roadways that are inoperable or even abandoned. If a vehicle's registration has expired for more than 6 months, it can be towed pursuant to section 22651(o) of the California Vehicle Code. A vehicle can't be parked on a public roadway more than 120 hours on a per section 11-8(Z) of the Colusa City Code. This excludes vehicles on private property. Should you notice a yellow 'warning' tag on vehicle, if the vehicle is not moved quickly, it will be towed. Often it will be tagged without further notice.

#### **BACKGROUND ANALYSIS:**

In August 2021, the City submitted an application for a grant under what is called the LOSSP grant. (The Locally-Operated State Park Program of Proposition 68)

The project that is to be completed shall consist of rehabilitating the septic system and installing a pay station at the dump station. The City will also be installing a new entrance pay station with a gate to ensure that payment has been made. All of the split rail fences will be replaced and the groups areas will be fenced off again. Turf and irrigation repairs will be completed, as well as replacement of broken or missing picnic tables and BBQ's.

On March 08, 2024, the City sent a request for proposal (RFP) for the Rehabilitation of the Colusa Sacramento River SRA. The bid closing date was April 09, 2024, at 4pm. The City received only one bid and it was from Dos Rios Inc. in the amount of \$358,030.16.

BUDGET IMPACT: None - City we will be using the LOSSP grant that we received.

**STAFF RECOMMENDATION:** Council to approve Resolution 24-\_\_\_ Authorizing the City Manager to enter into a construction contract with Dos Rio Inc.

Hydroflush leach lines.- Sub Contract Fletchers plumbing with DRI assistance.

RV dump station – An automated attendant which is capable of measuring the effluent amount and then charging the users for discharging their effluent. The station is equipment based and will be specified in design documents and will be installed per the manufacturer recommendations on a concrete pedestal. It will require a credit card and cash deposit prior to allowing the users access. – Install Sanistar Automated attendant with required capabilities. This is the only unit we found that qualifies for the Cities needs and does require the City to contract with Sanistar for the annual service fees.

Repair automatic pay machine This work scope proposes a more cost-effective solution as the current machine is out of date and not usable. City proposes that we Purchase and install a Ventek Model 400 or equivalent parking unit pay station which offers four types of rate configurations: Flat Rate, Quick-Pick, Pay & Display and Pay-by-Space, so that you can customize it to suit any fee schedule. The model can be supplied with AC power or solar power and is backed up by a battery for reliability, or it can be operated solely on the battery. 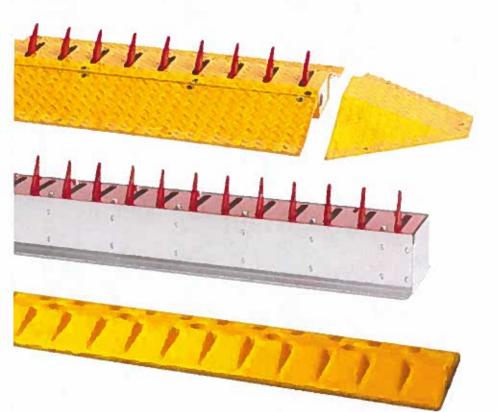

The staff wants the Council's attention on adding the rental fee for Scout Cabin and the parks to nonprofit organizations as stated under the Parks & Recreation Fee Schedule highlighted in yellow.

Cost recovery for provided services.

#### **RESOLUTION NO. 24-**

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLUSA UPDATING AND ADOPTING THE FISCAL YEAR 2024-25 COMPREHENSIVE FEE SCHEDULE FOR THE CITY OF COLUSA

**WHEREAS,** The City of Colusa ("City") is authorized by law to establish fees for certain City programs and services; and

**WHEREAS,** in accordance with applicable laws, fees adopted by City for certain City services may not exceed the estimated reasonable cost of providing the service or regulatory activity for which the fee is charged; and

**WHEREAS,** in 2009 the City set fees based on a Comprehensive Fees Study performed by a consultant ("Maximus") to determine the actual costs associated with the provision of certain City services; and

WHEREAS, upon review the City has determined that many of City's existing fees and deposits need to be updates once again due to changes in the law, as well as the increasing costs associated with City services; and

**WHEREAS,** City staff has reviewed the fees and have made recommendations for fees which do not exceed the actual and/or reasonable costs associated with providing the services; and

**WHEREAS,** the City Council has determined that the schedule of fees and deposits and the total amounts thereof, described in the attached Exhibit "A," are reasonable in that they do not exceed the estimated reasonable cost of providing the related City services; and

**WHEREAS**, the City Council desires to establish the Comprehensive Fee Schedule attached as Exhibit "A" as the official fee schedule for the City.

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COLUSA DOES HEREBY RESOLVE:

Section 1. Findings

- A. The purpose of the fees and deposits set forth the Comprehensive Fee Schedule attached as Exhibit "A" is to recover the costs incurred by the City in providing various City services, and such fees and deposits are not levied for general revenue purposes.
- B. After consideration of the data and information regarding the costs of providing services identified Comprehensive Fee Schedule, all testimony received orally or in writing at or before the noticed public hearing and the information provided by City staff in the agenda report, the City Council adopts the fees identified the Comprehensive Fee Schedule and

finds that the fees are reasonable estimates of the cost of providing such services, and that the fees are necessary to recover the reasonable, estimated cost of providing the identified services.

C. Adoption of the fees and deposits set forth in Exhibit "A" of this Resolution are not a project subject to the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15378(b)(4) and/or CEQA Guidelines Section 15061(b)(3).

Section 2. Adoption of Comprehensive Fee Schedule

The City Council hereby adopts the schedule of fees and deposits identified in the Comprehensive Fee Schedule, incorporated herein by this reference, and attached as Exhibit "A." The fees and deposits identified in the Comprehensive Fee Schedule are hereby directed to be charged and applied by the various City departments, and to be collected for the provision of identified City services.

#### Section 3. Severability

The individual fees and charges set forth in Exhibit "A" of this Resolution and all portions of this Resolution are severable. Should any of the fees or charges or any portion of this Resolution be adjudged to be invalid and/or unenforceable by a body of competent jurisdiction, then the remaining fees, charges and/or Resolution portions shall continue in full force and effect. The City Council hereby declares that it would have individually adopted each of the fees and charges set forth in Exhibit "A," and each individual section, subsection, clause, and portion of this Resolution, irrespective of the fact that one or more of the fees, charges, or sections of this Resolution may be held invalid.

Section 4. Effective Date

This Resolution shall take effect immediately. The fees shall be effective on July 1<sup>st</sup>, 2024 unless otherwise stipulated.

#### **BUDGET IMPACT:**

This district requires no additional funds from the City of Colusa General Fund. Note: This amount is approximate and could vary by no more than 10% at the time of filing.

The Colusa Meadows West Public Facilities Assessment District was created in 2006 to provide maintenance, operation, and improvement of the streets, utilities, drainage, sidewalks, curbs, gutters, landscaping, and street lighting, within the Colusa Meadows West development, and to provide maintenance, operation and improvement of neighborhood park facilities. As outlined on page 18 of the engineer's report, the FY 2024-25 Single Family Equivalent Unit assessment is \$556.00.

The Hoblit Public Facilities Assessment District was created in 2007 to provide maintenance, operation, and improvement of the streets, utilities, drainage, sidewalks, curbs, gutters, landscaping, and street lighting, within the Hoblit development. As outlined on page 18 of the engineer's report, the FY 2024-25 Single Family Equivalent Unit assessment is \$541.66.

## BUDGET IMPACT:

The Colusa Meadows West Public Facilities Assessment District projected revenues and expenditures for FY 2024-25 are \$10,008. The Hoblit Public Facilities Assessment District projected revenues and expenditures for FY 2024-25 are \$6,500.

## BACKGROUND ANALYSIS:

The City of Colusa Parks, Trees & Pool Improvement District was created in 1996 to provide funding for the improvements, maintenance and servicing of swimming pools, landscaping, tennis courts, sprinkler systems, park grounds, park facilities, landscape corridors, publicly owned trees, street frontages, running tracks, turf areas and other recreational facilities in the City. The 1996 approved assessment rate per Single Family Equivalent (SFE) unit is \$36.00 without provisional annual CPI adjustments. A Resolution was previously adopted which was the intent to collect and levy along with the engineer's report.

## **BUDGET IMPACT:**

The City of Colusa Parks, Trees & Pool Improvement District projected revenues are estimated to be \$86,350 and expenditures for FY 2024-25 are \$289,888. The excess expenditures of \$203,538 will be covered by the City of Colusa General Fund. Please Note: as of the date of this staff report the County assessor's office was in the process of providing information related to this assessment district, so these numbers are likely to change, but not more than 10%.
