**Subject: December Fire Department Report** 

#### 2. Department Activities & Training:

- Conducted multiple fire safety inspections of businesses and public buildings, ensuring compliance with fire codes.
- Performed Annual NFPA Fit Testing for Breathing Apparatus for all members.
- SCBA annual servicing and repairs were made by Municipal Emergency Services (EMS).
- Routine checks and service were performed on all apparatus and equipment to ensure operational readiness.

#### 3. Community Engagement & Public Education:

- Through September and October, Fire Personnel were busy with Fire Prevention Assemblies and Station tours, as well as performing all EMS standby for Colusa RedHawks football games.
- Fire personnel working with Colusa High School to put together a program to assist with recruitment and engagement opportunities for the Colusa Senior class.
- Multiple senior citizens utilized the smoke detector installation program.

#### 4. Staffing & Apparatus Updates:

- Currently, the department operates with 6 full-time and 18 volunteer firefighters.
- We currently have one Vacant F/F Position that has been filled in the past months by Per-Diem F/F's. Staffing the vacant position is an ongoing challenge due to a high turnover rate.
- E551 (2013) Type 1 pumper, first-out for all structural fires and rescue calls.
- E561 (2007) Type 1 pumper, second out for all structural fires and Rescue calls
- E552 (2002) Type 1 or 2 pumper, reserve unit, second-out for structure fire calls.
  - o Auxiliary pump was rebuilt and serviced by Riverview International
- E553 (2009) Type 3 Wildland Urban Interface, first-out for grass/wildland fires.
  - o A/C repairs and primer pump replaced by Riverview International.
- E556 (2019) Type 6 quick attack, first-out for non-structural fire calls.
- T571 (2027) BLS transport unit.
- T572 (2007) BLS transport unit, reserve unit.
- C770 (2018) Chief staff unit.

#### 5. Budget & Resource Needs:

- Ladder Truck A new ladder truck is essential for firefighting, rescues, and elevated access during emergencies. In addition to improving response capabilities, this purchase ensures compliance with NFPA standards and helps maintain our ISO rating of 3.
- Command Vehicle The Fire Department's current staff/command vehicle is a 2018 Ford Explorer with nearly 40,000 miles. While this mileage may be considered relatively low compared to civilian use, the vehicle's engine and idle hours are significantly higher due to the operational demands of emergency services. Extended idling, use of onboard electronics, and high-frequency short trips place greater wear on the drivetrain, cooling, and electrical systems than traditional civilian use.
- Automated External Defibrillators (AEDs) Life-saving devices for rapid response to cardiac emergencies, improving survival rates. Our current AEDs that are 10-15 years old are units donated to us through county OES surplus.

#### 6. Goals:

- Continue training efforts with a focus on EMS and Firefighting skills.
- Refresher training for flood response and sandbagging operations.
- Prepare for ISO audit planned for the first quarter of 2026
- Evaluate and improve emergency response strategies for multistory, multifamily dwellings within the city. submitted,





## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLUSA AMENDING THE CONFLICT-OF-INTEREST CODE

WHEREAS the Political Reform Act of 1974 (Govt. Code § 81000 et seq.) requires every local government agency to adopt and promulgate a Conflict of Interest Code ("Code"); and

WHEREAS the City desires to adopt their formal Conflict of Interest Code in a Resolution, and to update such Code; and

WHEREAS Title 2, Section 18730 of the California Code of Regulations contains the terms of a Model Conflict of Interest Code developed by the Fair Political Practices Commission ("FPPC") that agencies can adopt by reference, which may be amended from time to time by the FPPC after public notice and hearing to conform to amendments in the Political Reform Act; and

WHEREAS the City may adopt by reference the terms of the FPPC's Model Conflict of Interest Code, and amendments thereto, as set forth in the California Code of Regulations, as the City's Conflict of Interest Code; and

WHEREAS, adopting the Model Conflict of Interest Code will meet the statutory requirements for adopting such a code and save the City time and resources by minimizing the actions required to keep the Code in conformity with the Political Reform Act;

WHEREAS, pursuant to Government Code Section 87302, the Conflict of Interest Code must specifically enumerate the positions within the City, other than those specified in Government Code Section 87200, that involve the making or participating in making decisions that may foreseeably have a material effect on any financial interest, and, for each such enumerated position, the Conflict of Interest Code must state the specific types of investments, business positions, interests in real property and sources of income that are reportable.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF COLUSA DO HEREBY RESOLVE:

#### **Section 1: Adoption of Model Conflict of Interest Code.**

- A. The Model Conflict of Interest Code set forth in Title 2, Section 18730 of the California Code of Regulations and any amendments to it duly adopted by the FPPC are hereby incorporated by reference and including the attached Exhibit A in which public officials and employees are designated and Exhibit B in which disclosure categories are set forth, shall constitute the Conflict of Interest Code of the City of Colusa and the Colusa Entities.
- B. The designated officials, employees and consultants as set out in Exhibit A, shall be subject to the provisions of the Conflict-of-Interest Code and their disclosure categories.

#### Section 2. Annual Disclosure Statements

Persons holding designated positions shall file an annual statement no later than April 1st of each year. Annual statements shall disclose any reportable investments, interests in real property, income and business positions held or received during the previous calendar year; provided however, that the period covered by an employee's first annual statement shall begin on the effective date of the code or the date of assuming office, whichever is later.

#### Section 3. Filing Officer

The City Clerk is the filing official for Council Members, the City Manager, the City Attorney, Planning Commissioners and City Treasurer, Finance Director or other public officials managing public investments. For the persons holding these positions, the City Clerk accepts the filing, retains a copy and forwards the original to the Fair Political Practices Commission in Sacramento. For all other persons holding designated positions, the City Clerk is the filing officer and retains the statements. The City Clerk shall make the statements available for public inspection and reproduction.

#### Section 4: New Officials, Employees and Consultants.

Following the adoption of the Code, any newly designated officials, employees, and consultants shall comply with the Conflict of Interest Code for the City within thirty (30) days.

#### **EXHIBIT "B"**

#### **Conflict of Interest Disclosure Categories**

The disclosure categories listed below identify the types of investments, business entities, sources of income, or real property which the Designated Employees must disclose for each disclosure category to which he or she is assigned.

#### Designated Employees Each Category Must Report

#### **Category 1**—Officials and employees whose duties are broad and indefinable:

Investments, business positions, and income from sources located in or doing business in the jurisdiction. Interests in real property located in the jurisdiction, including property located within a two-mile radius of any property owned or used by the agency.

#### Category 2—Officials and employees whole duties involve contracting or purchasing:

Investments, business positions, and source of income of the type which: provide services, supplies, materials, machinery, or equipment of the type utilized by the agency.

#### **Category 3**—Officials and employees with regulatory powers:

Investments, business positions, and sources of income of the type which are subject to the regulatory, permit, or licensing authority of the agency.

#### **Category 4**—Officials and employees whose decisions may affect real property interests:

Investments, business positions, and sources of income of the type which engage in land development, construction, or the acquisition or sale of real property. Interests in real property located within the jurisdiction, including property located within a two-mile radius of any property owned or used by the agency.

#### **Disclosure by Consultants**

For purposes of this code, "consultant" shall have the same meaning as stated in 2 CCR 18700.3, which is the following:

An individual who, pursuant to a contract with a state or local government agency:

- (1) Makes a governmental decision whether to:
  - (A) Approve a rate, rule, or regulation;
  - (B) Adopt or enforce a law;
- (C) Issue, deny, suspend, or revoke any permit, license, application, certificate, approval, order, or similar authorization or entitlement;
- (D) Authorize the agency to enter into, modify, or renew a contract provided it is the type of contract that requires agency approval;
- (E) Grant agency approval to a contract that requires agency approval and to which the agency is a party, or to the specifications for such a contract;
  - (F) Grant agency approval to a plan, design, report, study, or similar item;
- (G) Adopt, or grant agency approval of, policies, standards, or guidelines for the agency, or for any subdivision thereof; or

(2) Serves in a staff capacity with the agency and in that capacity participates in making a governmental decision as defined in Regulation 18704(a) and (b) or performs the same or substantially all the same duties for the agency that would otherwise be performed by an individual holding a position specified in the agency's Conflict of Interest Code under Section 87302.

**Disclosure Requirements for Designated Consultants.** If a natural person is a "consultant" as defined above and has not been designated as exempt from disclosure requirements pursuant to this section, and such person has been deemed to make or participate in the making of decisions which may foreseeably have a material effect on any financial interest, such consultant shall provide such disclosure as the city manager deems appropriate in light of the services provided by said consultant.

Consultants Exempt from Disclosure Requirements. The city manager may determine in writing that a particular consultant, although a designated position, is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements. Any such written determination shall include a description of the consultant's duties and, based upon the description, a statement of the extent of disclosure requirements, in any. The city manager may also determine whether a particular contract consultant constitutes a "consultant" as the term is defined in the Political Reform Act and regulations promulgated thereunder. The city manager's determination is a public record and shall be retained for public inspection in the same manner and in the same location as other filings required by the conflict-of-interest code.

**Recommendation:** Approve Resolution 25-\_\_\_\_\_- and authorize City Engineer to record a Notice of Completion with the County Recorder's office and authorize the city Finance Director to release the retention pending no claims from suppliers or subcontractors. Contract with R&R Horn for an amount of \$2,833,120

#### **BACKGROUND ANALYSIS:**

The City bid and awarded the project in May of 2024 but did not receive final budget approval until August of 2024. The reason for the delay was that the state approved construction budget for this project is \$2,487,695, which was \$345,425 lower than the lowest competitive bid received. On the final budget approval submittal to the State, staff requested additional funding to cover this shortfall and were successful in working with state representatives to procure this extra funding.

The notice to proceed with construction was issued in September of 2024 and construction has been ongoing for the past year.

The city has worked closely with the State Water Board to secure funds for this project which are in the form of a **forgivable loan** to install the new water system that meets the cities standards.

At the time of bidding the City Received four bids based on competitive bidding and procurement procedures for this work, with the lowest responsive bidder was R&R Horn.

This project dates back to 2014 when the water source supply (wells), located within the Walnut Ranch Subdivision failed to pass drinking water standards due to exceedance of maximum contaminate levels of arsenic. At that time the water system was owned and operated by Del Oro Water Company Inc.

As a result of the failed wells, the City supplied an emergency water supply connection to the subdivision.

The residents put together their own coalition and petitioned the City for annexation into the City limits, and requested the City take over ownership, operations and maintenance of the water system.

The system contained asbestos piping, and did not meet city minimum standards for sizing, so as a condition of assuming ownership the residents paid for a grant application to replace the system and bring it up to city standard.

More than a decade later, the subdivision was annexed, and funds received via a planning grant to provide for the environmental and engineering of a replacement system.

**BUDGET IMPACT: The** city will collect water impact fees as a part of the grant to connect the residents per city ordinance. These fees were a part of the forgivable loan and thus did not cost the residents for their connections to the city. Also, all residents are now connected and part of the city water metering system. Prior they were flat rate customers.

**STAFF RECOMMENDATION:** Approve Resolution No. 25- and authorize the City Engineer to record a notice of completion for the subject contract with R&R Horn for the installation of a new water system for the Walnut Ranch Project.

**Recommendation:** Approve Resolution 25-\_\_\_\_\_- and authorize City Engineer to record a Notice of Completion with the County Recorder's office and authorize the city Finance Director to release the retention pending no claims from suppliers or subcontractors. Contract with R&R Horn for an amount of \$2,846,400

#### **BACKGROUND ANALYSIS:**

The Walnut Ranch Subdivision Phase I and Phase II was constructed near the City of Colusa limits in the early 1970's. The lots were served by on-site septic systems and have been for the past 50 years. The septic systems throughout the project have been in failure for the past 15+/- years.

With the help of former water board Staff, Namely Reese Crenshaw (RIP), it was recognized at the time of the water application that the Sewer System was failing, and the State reps assisted the City in amending its application to include brining in the sewer system into the Cities municipal treatment plant.

The City bid and awarded the project in May of 2024. The project was bid as a single project, however the water and sewer installations themselves had to be separated and tracked separately for construction and installation because they were funded from two different sources. The sewer project bids came in under the funding allocation by \$300,080. The construction budget estimate approved by the State for this project was 3,146,480.

Construction start was delayed with the Water project funding request so the projects could be built simultaneously.

The notice to proceed with construction was issued in September of 2024 along with the water project, and construction has been ongoing for the past year.

The city has worked closely with the State Water Board to secure funds for this project which are in the form of a **forgivable loan** to install the new sewer system that meets the city's standards and abandon the septic systems which were mostly in failure throughout the subdivision.

At the time of bidding the City received four bids based on competitive bidding and procurement procedures for this work, with the lowest responsive bidder was R&R Horn.

**BUDGET IMPACT:** City will collect sewer impact fees as a part of the grant to connect the residents per city ordinance. These fees were a part of the forgivable loan and thus did not cost the residents for their connections to the city. Also, all residents are now connected and part of the city sewer system and will be paying sewer rates.

**STAFF RECOMMENDATION:** Approve Resolution No. 25- and authorize the City Engineer to record a notice of completion for the subject contract with R&R Horn for the installation of a new sewer system for the Walnut Ranch Project.
