 Waiver of Subrogation with respect to general liability."
- All applications are subject to approval by the City Council.
- Applicants will be notified when the request has been approved or if additional information is required. Inquiries about the status of an application
 may be directed to City Hall.
- All street closures must maintain adequate clearance for emergency vehicle access.
- If event will take place on the state highway, attach a copy of the Caltrans encroachment permit.

THIS NOTICE OF TERMINATION is dated as of <u>March 5</u>, 2024, and is executed by <u>RPTS Development, LLC</u> ("Landowner") and City of Colusa, a municipal corporation ("City").

- A. The City is party to that certain City of Colusa and RPTS Development, LLC Development Agreement, dated as of June 23,2022, recorded on May 4, 2023, in the Official Records of the Recorder's Office of Colusa County, California as Instrument No. 2022-2174 (the "Development Agreement"), which created certain duties, obligations, and easements affecting the land described in Exhibit A attached hereto and incorporated herein by this reference (the "Property"), commonly known as RPTS Development LLC. Unless otherwise defined herein, all capitalized terms used in this Termination Notice shall have the meanings ascribed to them in the Development Agreement.

BACKGROUND ANALYSIS: The Utilities Department has been budgeting for a new backhoe for the last few years now, with the mid-year complete and adopted it is now time that we move forward on purchasing a new backhoe. Normally this type of purchase requires the City to send out a request for proposal unless it is bought from a state contract. All state contracts have already gone through the bid process to ensure that when the City uses the State Contract, we are getting the best price that we can.

The city contacted our local dealers to start working on quotes for a new backhoe and after looking at each of them and what would meet the City's needs. The Staff felt even though it was the cheapest backhoe the JCB 3CX Compact Pro would be the best fit for the city and provide the most use.

All companies quoted us using the Sourcewell state contract pricing. N&S Tractor came back with the lowest price at \$142,317.25.


