Item Summary/Background/Prior Action

Corinth Economic Development Corporation

The following amended language is proposed for Section 4.1(c) of the Corinth Economic Development Corporation Bylaws:

Each member of the Board of Directors shall serve a two (2) year term, or until his/her successor is appointed, unless disqualified or removed from office. Each Director shall be eligible for reappointment. No Director shall serve more than two (2) consecutive terms excluding the initial term, if less than two (2) years. Any vacancy occurring on the Board shall be filled by appointment of the City Council, to hold office until the expiration of the term of the vacating member. Unless otherwise provided, terms shall begin on October 1st and expire on September 30th.

The intent of this amendment is to better ensure continuity in appointed officials throughout a project's lifetime as the City continues to focus on economic development.

Amendments to the CEDC Bylaws are governed under Section 8.2, which states that amendments may be made either through a majority vote of the CEDC and subsequent approval from the Corinth City Council or solely by the Corinth City Council.

Finance Audit Committee

The following amended language is proposed for Section 33.102 of the Corinth Code of Ordinances, which governs the Finance Audit Committee:

The term of each Committee member shall be $\frac{\text{two}}{(2)}$ three (3) years. The Committee members from the community shall serve no more than two (2) successive terms, provided, however, that a Committee member

appointed to complete the term of another Committee member shall, at the completion of such term, be eligible for appointment for another full term.

The intent of this amendment is also to ensure continuity in appointed officials, especially as City financial decisions are made with the awareness of potential impacts several years out.

Amendments to the rules governing the Finance Audit Committee can be made by the Corinth City Council through ordinance or resolution to the applicable section of the Corinth Code of Ordinances.

Item Summary/Background/Prior Action

The City of Corinth contracts with SPAN, a non-profit corporation, for transportation and social services to older persons with disabilities, veterans, and the general public. SPAN provides door-to-door services to Corinth residents who are sixty years of age or older and persons with documented disabilities. Riders are charged \$3.00 per one-way trip. Services are provided Monday through Friday from 7:00 am - 6:00 pm. No services are provided during the weekend.

Previously this service was covered by the CARES Act federal funding. The funds were depleted in SPAN's 1Q24. The City is charged \$20.24 per one-way trip. From December 1, 2023, through July 31, 2024, residents have utilized 1,015 trips to and from medical appointments, life skill programs, employment, and shopping. SPAN charges the City for ½ of the trips. The total cost to the City to date is \$9,016.92. To date, twenty-four Corinth addresses utilize this service.

The current agreement will expire on 09/30/2024.

Often hear non-bike riders talking about bikes blocking their way (slowing them down), not realizing that bikes have a right to the road too. signage and education campaigns would be huge improvement.

State School road is particularly dangerous. There is a section of roadway without sidewalks or shoulders so cyclists (and pedestrians) are forced to travel on the street. I have had many close calls with distracted or aggressive motorists.

A maximum of \$100,000 for escrow deposits is more in line with present development costs and will allow Staff and developers additional flexibility regarding the timing of the installation of required improvements.

Hold a public hearing, consider and act on an ordinance amending Section 50.16 of the Code of Ordinances of the City of Corinth to increase the Water and Wastewater rates currently in effect; providing for the Incorporation of Premises; Providing Amendments; Providing for a Cumulative Repealer Clause; Providing a Savings Clause; Providing a Severability Clause; and Providing an Effect Date.

Item Summary/Background/Prior Action

The City Council for the City of Corinth will hold a public hearing regarding the rate design study and proposed water and wastewater utility rates on Thursday, August 22, 2024 at 6:30 p.m., in the City Council Chambers located at 3300 Corinth Parkway, Corinth, Texas. The meeting will be held for the purpose of receiving community input on the proposed water and wastewater rates. All interested citizens are encouraged to attend.

In April 2023 the city engaged Raftelis Financial Consultants, Inc. to perform an in-depth cost of service and rate design analysis. The study's intent was to achieve a water and wastewater rate structure that will assure equitable and adequate revenues for operations, debt service retirement, asset management, capital improvements, and bond covenant requirements. Therefore, ensuring the utility operates on a self-sustaining basis while considering the economic impact on the City's customers.

The study identified that in order to meet future revenue requirements, the city needs to implement future water and wastewater rate increases. The analysis examined requirements for a three-year period and determined that rates were not sufficient to meet revenue requirements for the three-year study period. Staff recommendation is to adopt the second year of the financial plan and corresponding rate structure. The rate design recommendation summary is as follows:

- 3% increase in fixed and volumetric water rates
- 3% increase in fixed and volumetric wastewater charges

Senior citizens over the age of 65 receive 5,000 gallons of water and 1,000 gallons of sewer included in their monthly minimum bill. For residential wastewater customers, the new rate structure also maintains a cap at a maximum 25,000 gallons.

Applicable Policy/Ordinance

The city council sets rates that generally cover reasonable operating and maintenance costs, a reserve fund, and any loan or bond debt service expenses. In any case, the rates set must be "fair, just, and reasonable." TEX. WATER CODE § 13.042. State law provides no specific procedures that a city must follow to increase rates within the city's limits. A city is permitted to operate and regulate the utility in a manner that protects the interests of the city. TEX. LOC. GOV'T CODE §552.001.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORINTH, TEXAS, AMENDING SECTION 50.00, "WATER AND WASTEWATER UTILITY FEE SCHEDULE," OF CHAPTER 50, "WATER AND SANITARY WASTEWATER SYSTEMS," OF TITLE V, "PUBLIC WORKS," OF THE CODE OF ORDINANCES OF THE CITY OF CORINTH TO INCREASE THE WATER AND WASTEWATER RATES CURRENTLY IN EFFECT; PROVIDING FOR THE INCORPORATION OF PREMISES; PROVIDING AMENDMENTS; PROVIDING FOR A CUMULATIVE REPEALER CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Corinth, Texas, is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, the City commissioned a water and wastewater cost of service and financial plan study which was presented to the City Council on August 22, 2024, and which recommends that increases in water and wastewater rates are necessary at this time due to increased water and wastewater service use; and

WHEREAS, the City Council desires to adopt this Ordinance to amend the water and wastewater utility fee schedule in Title V, "Public Works" in the Code of Ordinances;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CORINTH, TEXAS:

SECTION 1. INCORPORATION OF PREMISES

The above and foregoing recitals are found to be true and correct and are incorporated into the body of this Ordinance for all purposes.

SECTION 2. AMENDMENTS

That Sections 50.00(A) and (B) in Chapter 50, "Water and Sanitary Wastewater Systems" of Title V, "Public Works" in the Code of Ordinances of the City of Corinth, Texas is hereby amended to be read as follows:

§ 50.00 WATER AND WASTEWATER UTILITY FEE SCHEDULE.

The rates, charges, fees, deposits, billings, and procedures for providing water and wastewater service by the City to its customers shall be established and be in accordance with this Chapter and may be amended from time-to-time by the City Council. All water and wastewater fees are consolidated in this fee schedule. The fee schedule related to new development are found in § 50.17, § 50.36, § 50.38, and § 38.16.

A. Water Rates and Billing Basis.

1. Water rates consist of a base rate and a volumetric rate designed to ensure the water utility operates on a self-sustaining basis. The base rate is the minimum bill that a residential or commercial customer would receive to equally share in providing the availability of service. Minimum base rates are based on meter size. The rates also include a senior citizen discount where senior citizens receive 5,000 gallons of water in their monthly minimum bill. The volumetric rate is the amount charged to a customer per thousand gallons used and uses a tiered structure.

B. Wastewater Rates and Billing Basis

- 1. *Single family dwelling*: Each year, residential monthly water consumption is measured and averaged to establish the monthly wastewater charge for each customer for the upcoming year. The average will be calculated by taking the prior November, December, January, and February metered water consumption, subtracting out the highest month's usage, and averaging the consumption to be known as the "winter quarter average." Each March, the billable flows for each residential customer will be readjusted based on the previous winter quarter average. The rates include a senior citizen discount where senior citizens receive 1,000 gallons of wastewater included in their monthly minimum bill. Residential gallons billed are capped at 25,000 gallons.
- 2. *New customers averaging*: The City will accept submission of previous consumption history from a new customer to establish the winter average. The information submitted must reflect the winter quarter average months used by City, as the basis for customer's

wastewater rate. Where no prior winter quarter average exists, the City's standard quarter average for all residential customers will be used.

- 3. Non-single-family dwellings: Rates shall be based upon each month's water consumption.
- 4. *Commercial customers*: The volume of flow used in computing wastewater charges for commercial customers will be based on metered water consumption as shown in the meter reading records retained by the City.

<u>SECTION 3.</u> CUMULATIVE REPEALER

This Ordinance shall be cumulative of all other Ordinances and shall not repeal any of the provisions of such Ordinances except for those instances where there are direct conflicts with the provisions of this Ordinance. Ordinances, or parts thereof, in force at the time this Ordinance shall take effect and that are inconsistent with this Ordinance are hereby repealed to the extent that they are inconsistent with this Ordinance. Provided however, that any complaint, action, claim or lawsuit which has been initiated or has arisen under or pursuant to such other Ordinances on this date of adoption of this Ordinance shall continue to be governed by the provisions of such Ordinance and for that purpose the Ordinance shall remain in full force and effect.

SECTION 4. SAVINGS

All rights and remedies of the City of Corinth, Texas are expressly saved as to any and all violations of the provisions of any other ordinance affecting fees which have secured at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances same shall not be affected by this Ordinance but may be prosecuted until final disposition by the court.

<u>SECTION 5.</u> SEVERABILITY

The provisions of the Ordinance are severable. However, in the event this Ordinance or any procedure provided in this Ordinance becomes unlawful, or is declared or determined by a judicial, administrative or legislative authority exercising its jurisdiction to be excessive, unenforceable, void, illegal or otherwise inapplicable, in while in part, the remaining and lawful provisions shall be of full force and effect and the City shall promptly promulgate new revised provisions in compliance with the authority's decisions or enactment.

SECTION 6.

EFFECTIVE DATE

This Ordinance shall take effect upon its passage and publication as required by law. The City Secretary is directed to publish the caption of this Ordinance as required by the City Charter and state law.

Consider and act on approving an Economic Incentive and Performance Agreement between the Corinth Economic Development Corporation and EDM Development, L.L.C.

Item Summary/Background/Prior Action

The Corinth Economic Development Corporation ("CEDC") received an application for incentives from EDM Development, L.L.C. ("Developer") to assist with improvements for a new restaurant tenant at the Developer's property located at 6828 S I-35E Corinth, TX 76210, also known as Magnolia Center.

The CEDC reviewed the application at their regular meeting on July 1st, 2024, in Closed Session as authorized by Section 551.087 (Economic Development) of the Texas Government Code. Staff then proceeded to draft an Economic Incentive and Performance Agreement ("Agreement") as directed by the CEDC to partially assist the Developer with costs related to refinishing the space for a new tenant, including:

- a. Flooring installation using upgraded materials and refinishing and repainting of walls.
- b. Reconfiguration of existing layout.
- c. Plumbing improvements.

The investment in these new improvements for the purpose of promoting new business development is seen as a qualified economic development project and is in line with the City's & CEDC's targeted priority of encouraging the development of niche/specialty retail, entertainment, or restaurant as outlined in the Corinth Economic Development Incentive Policy.

The incentive being offered to the Developer is equal to a one-time reimbursement grant not to exceed \$12,500. The Developer is only eligible to receive the incentive upon successful completion of the following conditions:

- Completion of the improvements [as listed above] within 90 days of the Agreement's execution date as evidenced by receiving a certificate of occupancy by the City for the property.
- A minimum investment of at least \$25,000 by the Developer on all improvements to the property for the new tenant.
- Receipt of all applicable invoices from the Developer for any contractors used to complete the improvements deemed as eligible for reimbursement in the Agreement [as listed above].
- Execution of a lease between the Developer and the restaurant tenant for a minimum initial term of five years.

The Agreement stipulates that the tenant must remain operational at the property for a minimum of 18 months from the date a certificate of occupancy is issued by the City. Should the tenant close and/or terminate their lease prior to then, the Developer must repay the grant to the CEDC within 30 days of the tenant ceasing operations or within 30 days written notice is received by the Developer from the CEDC requesting such repayment, whichever occurs sooner. The Agreement shall terminate upon 18 months from the date a certificate of occupancy is issued to the tenant.

Financial Impact

Grant funds are being sourced from the dedicated Economic Development Incentives account found in the Economic Development Fund Budget as approved and adopted by the Council on September 21, 2023, and as included in the proposed FY 2025 Economic Development Fund Budget.

ECONOMIC INCENTIVE AND PERFORMANCE AGREEMENT Economic Development Grant

Project: Magnolia Center Tenant Finish-Out

THIS Economic Development Agreement ("Agreement") is made and entered into by and between the Corinth Economic Development Corporation, a Texas non-profit corporation ("CEDC"), and EDM Development, L.L.C, a Texas limited liability corporation ("Applicant"), effective as of the date the authorized representative for the CEDC countersigns this Agreement ("Effective Date").

RECITALS

WHEREAS, the CEDC is a Type B economic development corporation, and a Texas nonprofit corporation operating pursuant to Chapters 501 and 504 of the Texas Local Government Code, as amended (also referred to as the "Act"), and the Texas Non-Profit Corporation Act, as codified in the Texas Business Organizations Code, as amended; and

WHEREAS, the City of Corinth and the CEDC have adopted an Economic Development Program Incentives Policy which authorizes Economic Development Grants to finance qualified projects as determined by the CEDC Board; and

WHEREAS, an application for Economic Development Incentives was received by EDM Development, LLC (the "Applicant") seeking financial assistance from the City of Corinth and CEDC Board to assist in the improvement of Applicant's property located at 6828 S I-35E Suite 160 Corinth, TX 76210 located within the Magnolia Retail Center (hereinafter referred to as the "Property") for a restaurant; and

WHEREAS, the Applicant seeks funding for various improvements to the Property that will assist the success of the Property as more specifically described herein, and the restaurant is anticipated to attract patrons to the Magnolia Retail Center in which the Property is located; and

WHEREAS, the Applicant is an eligible applicant as the company is a for-profit, sales tax remitting business that is not currently doing business within the City of Corinth and the activities of the company will encourage the development of a new and unique dining concept; and

WHEREAS, the CEDC approved the provision of financial assistance to Applicant consistent with this Agreement, which will provide, subject to Applicant's satisfaction of certain conditions set forth herein, the necessary financial assistance for the Applicant to improve the Property in accordance with the standards set forth by the CEDC's Economic Development Incentive Policy to promote economic development and increase values of property; and

WHEREAS, the Applicant understands and agrees that in granting the financial assistance provided pursuant to this Agreement, the CEDC is relying upon Applicant's representations, warranties, and agreements, as set forth and provided for in this Agreement, and in the application presented to the CEDC; and

WHEREAS, the CEDC's Board of Directors have determined the financial assistance provided to Recipient pursuant to this Agreement is consistent, and meets the definition of "project" as that term is defined in Section 501.103 of the Texas Local Government Code, as amended, and meets the definition of "cost" as that term is defined in Section 501.152 of the Texas Local Government Code, as amended; and

NOW, THEREFORE, for and in consideration of the agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the CEDC and Recipient agree as follows:

1. <u>Findings Incorporated</u>. The foregoing recitals are hereby incorporated into the body of this Agreement and shall be considered part of the mutual covenants, consideration and promises that bind the parties.

2. <u>Improvements</u>. Grant funds must be used for site improvements performed on the Property to provide the following enhancements as identified by the Applicant (collectively the "Improvements"):

- (a) Flooring installation using upgraded materials and refinishing and repainting of walls
- (b) Reconfiguration of existing layout
- (c) Plumbing improvements

Each of the foregoing are qualified improvements eligible for funding and/or reimbursement.

The Applicant shall undertake and complete the Improvements on the Property within ninety (90) days of the Effective Date of this Agreement as a condition precedent to reimbursement via the Grant. The Applicant shall invest at least Twenty-Five Thousand and No/100 Dollars (\$25,000) on improving the property, including these Improvements. The Improvements are found by the CEDC Board of Directors to promote new business development and therefore are part of a qualified project.

3. <u>**Title to Property Established.**</u> Applicant represents and warrants that he/she is currently the owner of record of the Property in fee simple. Any substantial (outside of normal surveyor error or boundary dispute) misrepresentation or breach of the above representation and warranty shall entitle CEDC to terminate the Agreement.

4. <u>Grant</u>. The CEDC Economic Development Incentive Policy provides reimbursement of actual costs incurred and documented by the Applicant ("Actual Costs") through the payment of CEDC funds ("Grant Funds") for financing Improvements determined to be qualified projects by the CEDC Board. Notwithstanding the actual costs paid by Applicant for the Improvements, accordingly, the Grant Funds paid to Applicant shall not exceed Twelve Thousand Five Hundred and No/100 Dollars (\$12,500) and shall only be paid if the Applicant complies with all of the terms and conditions of this Agreement. Grant Funds cannot be combined with any other CEDC site enhancement matching grant programs. The Applicant must complete the Improvements within ninety days (90) of the Effective Date of this Agreement.

5. <u>Use of Grant Funds</u>. Grant Funds shall be used only for Improvements approved by the CEDC. Any alterations, revisions or changes to the Improvements will be authorized and approved by the CEDC Board of Directors. Failure to have alterations, revisions or changes approved in advance by the CEDC Board of Directors will result in the termination of this Agreement and forfeiture of the Grant Funds.

6. <u>Reimbursement Procedures</u>. Grant Funds shall be disbursed to the Applicant only when Improvements are completed, inspected, approved by an agent for the City of Corinth as being in accordance with the City's Building Codes and Standards, including any standards that apply to any special districts throughout the City, and a Certificate of Occupancy is issued. The development and use of the Property shall comply with the ordinances, policies, standards, and regulations of the City, including, but not limited to, the City's Comprehensive Zoning and Subdivision Ordinances.

Upon completion of the Improvements, the Applicant shall submit an itemized invoice and evidence of payment thereof, with copies of all contractor's invoices, and such other records as the CEDC may reasonably request for verification purposes to the CEDC for payment. The Applicant has executed and shall maintain an initial lease agreement with a tenant for the Property for a minimum of five (5) years from the Effective Date, or five (5) years from the date the lease agreement was executed if in effect prior to the Effective Date of this Agreement, in order to qualify for the Grant Funds. If the tenant for the Property and/or the Applicant moves from the Property prior to the expiration of eighteen (18) months from the date of issuance of a Certificate of Occupancy by the City of Corinth for the Property, Grant Funds shall be forfeited and the Applicant shall repay the Grant Funds to the CEDC within the earlier of thirty (30) days after the date that the tenant for the Property and/or the Applicant moves out of the Property or thirty (30) days after the date that Applicant receives a written notice and demand from the CEDC Board for return of the Grant Funds for noncompliance with the terms of this Agreement.

7. <u>Time of Performance</u>. The Applicant shall have ninety (90) days from the date of execution of this Agreement to complete all Improvements. An extension may be requested in writing to CEDC Staff, which will be taken to the CEDC Board of Directors. Any request for extension will be considered on a case-by-case basis.

8. <u>Indemnification</u>. THE APPLICANT DOES HEREBY INDEMNIFY AND HOLD HARMLESS THE CEDC, THE CITY OF CORINTH, AND THEIR EMPLOYEES, AGENTS, AND OFFICIALS, FROM ALL CLAIMS MADE OR ACTIONS AGAINST, OR LOSSES, DAMAGES, COSTS, AND ATTORNEY'S FEES INCURRED AS A RESULT OF, ARISING OUT OF, OR RELATED TO ANY INTENTIONAL ACT OR OMISSION BY THE APPLICANT UNDER, PURSUANT TO, OR IN CONNECTION WITH, THIS AGREEMENT AND THE WORK UNDERTAKEN FOR THE IMPROVEMENTS PURSUANT HERETO.

9. <u>**Termination.**</u> The Expiration Date of this Agreement shall be 18 months from the day a Certificate of Occupancy is issued by the City for the new tenant located at the Property. This Agreement terminates on the Expiration Date, and may, prior to the Expiration Date, be terminated

upon any one or more of the following: (a) by mutual written agreement of all the Parties; (b) by the CEDC, if the Applicant defaults or breaches any of the terms or conditions of this Agreement and such default or breach is not cured within thirty (30) days after written notice thereof; or (c) by the CEDC, if any applicable building permits required for the Property or the Improvements and issued by the City are revoked or expire, and Applicant fails to make reasonable efforts to obtain new permits, as determined by the City and such default is not cured by Applicant within thirty (30) days after written notice thereof. In the event of termination by the CEDC pursuant to romanette (b) or (c) of this Section, Applicant shall refund all Grant Funds received pursuant to this Agreement; all such Grant Funds shall be paid to City within thirty (30) days after the date that Applicant receives a written notice and demand from the CEDC Board for return of the Grant Funds for noncompliance with the terms of this Agreement. Upon termination pursuant to this Section, CEDC shall be released of all obligations to the Applicant, **but the Applicant's duty to indemnify shall survive the termination**.

10. <u>Party Relationships</u>. The parties to this Agreement hereby acknowledge that nothing contained in this Agreement shall be deemed or construed by either of them, or by any third person or entity, to create any relationship of principal and agent, limited or general partnership, employer and employee, or joint venture, between the CEDC and Applicant, or to create any relationship of third-party beneficiary in favor of a person or entity not a party to this Agreement, including contractors and suppliers.

11. <u>Entire Agreement</u>. This Agreement constitutes the entire Agreement of the parties hereto. It shall supersede all prior offers, negotiations, and agreements. No revision of this Agreement shall be valid unless made in writing and signed by the parties hereto.

12. <u>Remedies</u>. In the event the Recipient does not perform under the terms of this Agreement, the CEDC shall be entitled to its remedies at law and in equity, in addition to liquidated damages equal in amount to the Grant Funds, if said Grant Funds have been disbursed.

13. <u>Miscellaneous Provisions</u>.

(a) <u>Amendments</u>. This Agreement constitutes the entire understanding and agreement of the parties as to the matters set forth in this Agreement. Excluding any extension granted for Time of Performance in Section 8, no alteration of or amendment to this Agreement shall be effective unless given in writing and signed by the party or parties sought to be charged or bound by the alteration or amendment.

(b) <u>Applicable Law and Venue</u>. This Agreement shall be governed by and construed in accordance with the laws of the State of Texas, and all obligations of the parties created hereunder are performable in Denton County, Texas. Exclusive venue for any action arising under this Agreement shall lie in the state district courts of Denton County, Texas.

(c) <u>Assignment</u>. The obligations of Applicant under this Agreement may not be assigned without the express written consent of CEDC, which consent shall not be unreasonably withheld, conditioned or delayed. Applicant shall have the right to retain or assign the right to

receive all or a portion of the payments due to Recipient under this Agreement without the consent of CEDC.

(d) <u>Binding Obligation</u>. This Agreement shall become a binding obligation on the signatories upon execution by all signatories hereto. Applicant warrants and represents that the individual or individuals executing this Agreement on behalf of Recipient has full authority to execute this Agreement and bind Recipient to the same. CEDC warrants and represents that the individual executing this Agreement on its behalf has full authority to execute this Agreement and bind CEDC to the same.

(e) <u>Counterparts</u>. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall constitute one and the same document.

(f) <u>Notices</u>. Any notice or other communication required or permitted by this Agreement (hereinafter referred to as the "Notice") is effective when in writing and (i) personally delivered either by facsimile (with electronic information and a mailed copy to follow) or by hand or (ii) three (3) days after notice is deposited with the U.S. Postal Service, postage prepaid, certified with return receipt requested, and addressed to the addresses for the parties as provided for in this Agreement.

(g) <u>Severability</u>. If a court of competent jurisdiction finds any provision of this Agreement to be invalid or unenforceable as to any person or circumstance, such finding shall not render that provision invalid or unenforceable as to any other persons or circumstances. If feasible, any such offending provision shall be deemed to be modified to be within the limits of enforceability or validity; however, if the offending provision cannot be so modified, it shall be stricken and all other provisions of this Agreement in all other respects shall remain valid and enforceable.

(h) <u>Survival</u>. All warranties, representations, and covenants made by Applicant and the CEDC in this Agreement or in any certificate or other instrument delivered by one party to the other party under this Agreement shall be considered to have been relied upon by the parties hereto and will survive the making of this Agreement, regardless of any investigation made by either party or on either party's behalf.

(i) <u>Undocumented Workers</u>. The Applicant certifies that the Applicant does not and will not knowingly employ an undocumented worker in accordance with Chapter 2264 of the Texas Government Code, as amended. If during the Term of this Agreement, Applicant is convicted of a violation under 8 U.S.C. § 1324a(f), Applicant shall repay the amount of the public

subsidy provided under this Agreement plus interest, at the rate of eight percent (8%), not later than the 120th day after the date Applicant is convicted of such violation.
