Mayor Heidemann opened the Public Hearing at 5:44 P.M. and immediately closed it.



**Item/Caption**

Hold a Public Hearing and consider approval of an Order authorizing the Imposition of the District Sales and Use Tax at a Rate of .25% on gas and electricity for the Crime Control and Prevention District.

**Item Summary/Background/Prior Action**

SB 575, enacted during the 81st Texas Legislature Regular Session, authorizes local taxing authorities to impose a sales tax on the residential use of gas and electricity. This legislation allows cities, counties, and other local governmental entities to generate additional revenue to fund various community needs, including public safety and emergency services.

Cities that adopted sales tax effective October 1, 1979 or later may not impose its local sales tax residential use of gas and electricity. Cities that imposed local sales tax prior to that date could have retained the tax by ordinance or could reimpose it if they did not retain the exemption. The City of Corinth did retain the exemption effective May 1, 1979 (the city has imposed a city sales tax since July 1, 1972) and imposes its sales tax on residential use of gas and electricity.

The city has the opportunity to impose a sales tax on residential utility consumption, specifically targeting funding for the Crime Control and Prevention District. The local sales tax would be applied to residential use of gas and electricity, with the collected funds earmarked for supporting the operation and services of the district.

**Financial Impact**

The imposition of this sales tax is projected to generate an additional \$50,000 in revenue which will directly support public safety initiatives, including crime prevention efforts, and community-based emergency preparedness programs.

**Staff Recommendation/Motion**

Staff recommends approval of an order imposing the District sales and use tax at a rate of .25% on residential gas and electricity for the Crime Control and Prevention District.

**CORINTH CRIME CONTROL & PREVENTION DISTRICT**

**AN ORDER OF THE BOARD OF DIRECTORS OF THE CORINTH CRIME CONTROL & PREVENTION DISTRICT, (“CRIME CONTROL DISTRICT”) AUTHORIZING THE IMPOSITION OF THE DISTRICT OF SALES AND USE TAX AT THE RATE OF .25% ON GAS AND ELECTRICITY FOR RESIDENTIAL USE; PROVIDING FOR NOTIFICATION TO THE STATE COMPTROLLER’S OFFICE, PROVIDING FOR NOTICE TO GAS AND ELECTRIC COMPANIES WITHIN THE BOUNDARIES OF THE CRIME CONTROL DISTRICT; PROVIDING FOR PUBLICATION; PROVIDING FOR SAVINGS AND REPEAL; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on November 3, 2020, the City of Corinth, Texas, eligible voters of the City of Corinth, Texas (“City” or “Corinth”) authorized the establishment of the Corinth Crime Control & Prevention District (“Crime Control District”) pursuant to Chapter 344 of the Texas Local Government Code; and

**WHEREAS**, the Crime Control District, whose boundaries are coterminous with City’s corporate boundaries, imposes sales and use tax at the rate of .25% as provided by Chapter 363 of the Texas Local Government Code and Section 321.108 of the Texas Tax Code; and

**WHEREAS**, Corinth imposes a tax on the residential use of gas and electricity pursuant to Section 321.105 of the Texas Tax Code; and

**WHEREAS**; Section 321.1055 of the Texas Tax Code provides authority for the Crime Control District Board of Directors to approve by a majority vote of the membership of the Board of Directors following a public hearing an order or resolution authorizing the imposition of the Crime Control District sales tax authorized by Section 321.108 of the Texas Tax Code on receipts from the sale, production, distribution lease or rental of, and the use, storage, or other consumption within the Crime Control District of gas and electricity for residential use; and

**WHEREAS**, in accordance with Texas Tax Code §321.1055(b) the Board of Directors of the Crime Control District held a public hearing and considered public comments provided on the imposition of the Crime Control District sales tax as authorized by Texas Tax Code §321.108, at the rate of one-fourth of one-percent on receipts from the sale, production, distribution lease or rental of, and the use, storage, or other consumption within the Crime Control District of gas and electricity for residential use as authorized by the Texas Tax Code; and

**NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF THE CRIME CONTROL DISTRICT:**

**Section 1. Findings Incorporated.** The findings set forth above are incorporated into the body of this Order as if fully set forth herein.

**Section 2. Sales Tax Imposed on Gas and Electricity for Residential Use.** The Crime Control District sales tax, at the rate of one-quarter of one percent, is hereby authorized and imposed on receipts

from the sale, production, distribution lease or rental of, and the use, storage, or other consumption within the Crime Control District of gas and electricity for residential use as authorized by the Texas Tax Code §321.1055.

**Section 3. Notice to Comptroller’s Office and Publication.** The City Secretary is directed to forward to the State Comptroller’s office by certified mail return receipt requested or registered mail a copy of this Order. The City Secretary also is directed to cause this Order to be published in a newspaper of general circulation within the Crime Control District.

**Section 4. Notice to Gas and Electric Companies.** The City Secretary is directed to forward by certified mail return receipt requested or registered mail a copy of this Order and a copy of the Crime Control District’s boundaries to each gas and electric company whose customers are subject to the tax imposed by this Order.

**Section 5. Severability.** If any section, article, paragraph, sentence, clause, phrase or word in this Order is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Order, and the Board of Directors hereby declares it would have passed such remaining portions of this Order despite such invalidity, which remaining portions shall remain in full force and effect.

**Section 6. Savings/Repeal.** All provisions of any Order in conflict with this Oder are hereby repealed to the extent they are in conflict. Any remaining portion of conflicting Orders shall remain in full force and effect.

**Section 7. Effective Date.** This Order shall be effective upon its passage.
