Texas Music Office – Presentation of Music Friendly Texas Community Certification.

Item Summary/Background/Prior Action

Beginning late last year, Staff began working with the Texas Music Office to have Corinth become certified as a Music Friendly Texas Community through the Music Friendly Texas program. This initiative was mainly driven through the Corinth Economic Development Corporation, who hosted an initial workshop detailing the program and it’s benefits to the community at the November 6, 2023 CEDC meeting. Staff executed a Memorandum of Understanding between the City and the Texas Music Office following the workshop for the purpose of exchanging information on music industry businesses in Corinth.

Through acquiring this certification, the City will be able to better utilize State resources to promote Corinth to the greater Texas music industry as a place to perform and do business. In turn, this will help bolster the local economy and strengthen opportunities for public engagement and entertainment.

The Certification will be maintained by the City’s Economic Development staff and in part by a Music Friendly Task Force to be made up of local stakeholders who will informally advise on ways to engage the community and encourage development of the music industry in Corinth.
