Conduct a public hearing to consider testimony and act on a project of the Corinth Economic Development Corporation to include the acquisition of properties for the purpose of promoting economic development.

Item Summary/Background/Prior Action

Following the Joint Meeting of the Corinth EDC & Corinth City Council on February 20, 2025, the CEDC went under contract to purchase two parcels of privately-owned property within the City of Corinth that are identified for Transit Oriented Development (TOD) within the City's Future Land Use Plan. Both properties are also located in the Downtown Corinth focus area. By undertaking this project, the CEDC will seek to stimulate economic development within the TOD/Downtown area with a focus on expanding the City's sales tax base. The subject properties are generally described as follows:

- An approximate 1.769-acre tract of land being situated in the City of Corinth, Denton County, Texas and being a part of the L. Bates Survey, TR 18 and more commonly identified as 5759 S I-35E; and
- An approximate 0.917-acre tract of land being situated in the City of Corinth, Denton County, Texas
 and being a part of the L. Bates Survey, TR 15 and more commonly identified as 1218 North Corinth
 Street.

Texas Local Government Code Sec. 505.159 stipulates that a Type B EDC will hold at least one public hearing on a proposed project. Furthermore, a Type B EDC may not undertake that project until sixty days after a notice has been given and no petition requesting an election for that project has been received per Texas Local Government Code Sec. 505.160.

A notice of the project and public hearing was published in the local newspaper on March 7, 2025.

Staff Recommendation/Motion

Staff recommends that the Board act to approve a project of the Corinth Economic Development Corporation to include the acquisition of properties more commonly identified as 5759 South Interstate 35E and 1218 North Corinth Street for the purpose of promoting economic development.

Item Summary/Background/Prior Action

After the Joint Special Meeting of the Corinth Economic Development Corporation and the Corinth City Council, both organizations voted to approve the EDC's acquisition of two properties within the City's Transit-Oriented Development area, as outlined in the Future Land Use Plan. A budget amendment is required to move \$1,400,000 from the Economic Development Fund Balance to the Capital Outlay account.

The Economic Development Fund budget is included as part of the City's Annual Program of Services and therefore under the purview of the Corinth City Council. Any budget amendments recommended by the CEDC Board for the Economic Development Fund must be approved and codified by an ordinance of the Corinth City Council.

Staff Recommendation/Motion

Staff recommends that the Board act to recommend a budget amendment to the fiscal year 2024-2025 Economic Development Fund budget in an amount of \$1,400,000.
