Approval of Events and Locations

Touch a Truck- June 18, 2022 & Summer Fest – August 5 & 6, 2022, Cortland Community Park

New Business for Discussion and Possible Action Support Cortland Fire Protection District Referendum

Assistant Fire Chief, Mark Hedrick, spoke with the board about the Cortland Fire Protection District Referendum that is on the June 28, 2022 primary ballot. This referendum would allow more revenue to Cortland Fire Protection District for payroll, equipment and maintenance. As of now, EMT's are making \$14.00 per hour and Paramedics are making \$16.00 per hour. This referendum would take an additional \$75 per \$100,000 of taxes each year.
