MINUTES

CALL TO ORDER / PLEDGE OF ALLEGIANCE / ROLL CALL

Mayor Pietrowski called the regular meeting of the Board of Trustees to order at 7:00 p.m. The pledge of Allegiance was recited and roll was called showing as present Trustees Stone, Fioretto, Haier and Olson. Shown as absent were Trustees Siewierski and Corson. Quorum was present. Also present were Public Works Director Joel Summerhill, Police Chief Lin Dargis, and Attorney Kevin Buick.

Clerk Aldis read the consent agenda into the record. Trustee Olson moved to approve the Minutes of June 9, 2025, Approve Expenditure Report and Accept Treasurer's Report of April 2024, seconded by Trustee Stone.

NEW BUSINESS FOR DISCUSSION AND POSSIBLE ACTION

2. Finance - Discussion of Revenues - Julie Wons, Lauterbach & Amen Julie Wons, Lauterbach and Amen, Finance Director for Cortland reported to the Board regarding unpredicted financial changes. She reported that the state's distribution of Sales Use Tax has changed beginning January 1, 2025. Use Tax is a tax imposed on the privilege of using tangible personal property purchased anywhere at retail. It's essentially a parallel tax to the state's Retailers' Occupation Tax (sales tax), designed to ensure fair competition between in-state and out-of-state businesses and to distribute the tax burden fairly among Illinois consumers. The Illinois Department of Revenue (IDOR) collects and distributes Use Tax revenues.

Use tax collections are distributed differently based on the type of purchase.

Starting January 1, 2025, retailers who previously collected Illinois Use Tax on sales sourced outside of Illinois are now subject to destination-based retailers' occupation

tax (ROT). This change means sales tax is calculated based on the combined state and local rate at the customer's shipping or delivery location. In this case, to Cortland.

In summary, the distribution of Illinois Use Tax revenue between the state and local governments varies depending on the type of transaction and the location of the use or titling/registration of the purchased property.

With this change the town has seen a decrease in revenue of approximately \$51,000. If the trend continues this will be an anticipated \$126,000 budget deficit

Ms. Wons explained that the 1% grocery collection tax will cease on January 1, 2026. The town has the authority to impose this tax to continue this revenue source. It is impossible for us to know the amount of anticipated revenue loss as the IDOR rules of privacy do not allow us to collect those exact numbers.

The Automotive and Filling Stations collection amount for 1st quarter 2025 shows \$94,960 in revenue. It is anticipated this number will decrease as well due to business closing.

Mayor Pietrowski reported he had met with DCEDC today to discuss marketing of land in corporate Cortland boundaries in hopes of generating economic development. He also reported that he has signed the gift acknowledgement of Aspasia Solar. This revenue would not be available until the solar field is operational. He reminded the Board that this is a one-time gift to be used as determined by the Board.

Other areas of consideration may be rezoning property currently zoned as residential to potentially mixed use, commercial on lower level, residential above. In many cases parking requirements are an obstacle. That is another area where consideration may need to be granted.

Another budgetary consideration for planning is the 2030 census. Should the town's population reach 5,000 the police pension system will change and will affect the budget process.

The Board discussed the nature of the ordinance. They were informed if they wished to continue the "grocery tax" without interrupted revenue, they would need to approve the ordinance and have all required department of revenue documents postmarked by October 1, 2025. Should they choose to adopt the ordinance at a later date, that is permissible, however, the process of notification, collection, and distribution of tax revenue would be determined by the timing of submittal to the department of revenue.

PARKS ADVISORY COMMITTEE REPORT

Trustee Fioretto reported the committee met on June 10. They will need guidance from public works as they move forward. Ms. Fioretto stated that she has narrowed down the candidate names to be applied to unnamed existing parks. They will need to talk about signage style.

She said she was happy to see the splash pad being heavily used.

DEPARTMENT HEAD REPORTS

Department Head Reports, May 2025
 Public Works, Police Department, Building Permits

Mr. Summerhill addressed the Board regarding the IEPA phosphorus mitigation. He reported that he, the engineer, and the attorney have met with the IEPA. They will be having monthly meetings. The next meeting is scheduled for July 14.

He stated that he will be applying for the discharge permit renewal (expires January 31, 2026) but not be asking for irrigation as a condition of the discharge permit. He stated a pilot study for a new piece of equipment for removal of phosphorus will be undertaken. He reported that the amount of phosphorous allowed is currently 1.0 mg/L but will be reduced to 0.5 mg/L by 2030. He is attempting to find equipment that will get them to the lower limit.

Mr. Summerhill addressed the US Postal Service mail system. He stated an estimate of over 200 bills to date have been delivered late, as much as one month after they were originally mailed. He said the irony was that the Post Office bill was returned as undeliverable. He has waived late fees for known issues. He commented this process should not continue. No further details were provided.

Police question regarding speed limits - the subcommittee meeting was not held and Trustee Stone wished to know why the speed limit north of Cortland Center Road could not be increased.

COMMENTS

There were no comments.

MAYOR'S REPORT

Mayor Pietrowski reported that Touch a Truck was well received. The weather was hot. Trustee Stone reported his observation that the kids were all over the equipment with support of the people in charge of the equipment.

Next event is SummerFest August 8 & 9, 2025.

Mayor Pietrowski mentioned that an ordinance was being worked on to bring back to the Board regarding urban backyard chickens. Documents needed for administrative implementation are needed as well, should the ordinance be passed.

2. Pilot Study - Phosphorous Removal Equipment - This proposal from Huber Technology, Inc. is for a pilot study to remove phosphorus at the wastewater treatment plant

INTERGOVERMENTAL OPERATING AGREEMENT BETWEEN THE TOWN OF CORTLAND AND THE ILLINOIS STATE POLICE

Pursuant to the Intergovernmental Cooperation Act, 5 ILCS 220/1, et seq., this Intergovernmental Operating Agreement ("Agreement") is entered by and between Cortland Police Department ______, a municipal law enforcement agency within the _______, a municipal law enforcement agency within the _______, and the Illinois State Police ("ISP"), an Illinois law enforcement agency. This Agreement creates the Violent Crime Intelligence Task Force pursuant to 20 ILCS 2605/2605-605 and sets forth conditions for participation.

WHEREAS, the Participating Agency is a law enforcement agency dedicated to combating crime in its jurisdiction, including but not limited to gun violence, gun-trafficking, and other violent crime;

WHEREAS, the ISP is authorized to establish a statewide multi-jurisdictional Violent Crime Intelligence Task Force pursuant to the Illinois State Police Law (20 ILCS 2605/2605-605);

WHEREAS, both the ISP and the Participating Agency (collectively, "Parties") agree that it is in the best interests of the Parties and the public to share information and develop partnerships where feasible to reduce and prevent illegal possession and use of firearms, solve firearm-related crimes, and otherwise reduce violent crimes in Illinois;

WHEREAS, the mission of this Task Force is to preserve life, eliminate the fear of violent crime, and reduce the occurrence of violent crime; and

WHEREAS, the Task Force is intended to focus on reducing and preventing illegal possession and use of firearms, firearm related homicides, and other violent crimes (20 ILCS 2605/2605-605), in part, by enhancing enforcement of the Firearm Owner Identification (FOID) Card Act, the Firearm Concealed Carry Act, the Firearm Dealer License Certification Act, and Article 24 of the Criminal Code of 2012;

WHEREAS, the Parties agree that in order to further these goals and objectives, the Participating Agency shall, upon execution of this Agreement, become a member of the above referenced Violent Crime Intelligence Task Force; and

WHEREAS, both the ISP and the Participating Agency agree the Parties shall perform their duties with the utmost integrity in their respective operations;

NOW, THEREFORE, for and in consideration of the mutual promises contained herein and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties agree as follows:

I. TERM OF AGREEMENT

This Agreement shall commence on <u>date of last signer</u>, and shall continue year to year until amended or modified by mutual agreement of the Parties or until terminated as provided herein. In any event, the Parties agree that the terms and conditions of this Agreement shall be reviewed periodically and updated as necessary. This Agreement supersedes all prior Agreements between the Participating Agency and the ISP with respect to the matters addressed herein. GENERAL PROVISIONS

- 1. The Task Force may develop and acquire information, training, tools, and resources necessary to implement a data-driven approach to policing, with an emphasis on intelligence development. 2 1LCS 2605/2605-605(1).
- 2. The Task Force may utilize information sharing, partnerships, crime analysis, and evidence-based practices to assist in the reduction of firearm-related shootings, homicides, and gun-trafficking. 2605-605(2).
- 3. The Task Force may recegnize and utilize best practices of community policing and may develop potential partnerships with faith-based and community organizations to achieve its goals. 2605-605(3).
- 4. The Task Force may identify and utilize best practices in drug-diversion programs and other community-based services to redirect low-level offenders. 2605-605(4).
- 5. The Task Force may assist in violence suppression strategies including, but not limited to, details in identified locations that have shown to be the most prone to gun violence and violent crime, focused deterrence against violent gangs and groups considered responsible for the violence in communities, and other intelligence driven methods deemed necessary to interrupt cycles of violence or prevent retaliation. 2605-605(5).
- 6. In consultation with the Chief Procurement Officer, the Department of State Police may obtain contracts for software, commodities, resources, and equipment to assist the Task

Force with achieving this Act. Any contracts necessary to support the delivery of necessary software, commodities, resources, and equipment are not subject to the Illinois Procurement Code, except for Sections 20-60 (duration of contracts), 20-65 (right to audit records), 20-70 (finality of determination), and 20-160 (business entities; certifications; registration with the State Board of elections) and Article 50 (procurement ethics and disclosure) of that Code, provided that the Chief Procurement Officer may, in writing with justification, waive any certification required under Article 50 of the Illinois Procurement Code. 2605-605(6).

- 7. The Task Force will conduct enforcement operations against persons whose Firearm Owner's Identification Cards have been revoked or suspended and persons who fail to comply with the requirements of Section 9.5 of the Firearm Owners Identification Card Act, prioritizing individuals presenting a clear and present danger to themselves or to others under paragraph (2) of subsection (d) of Section 8.1 of the Firearm Owners Identification Card Act. 2605-605(7).
- 8. The Task Force will collaborate with local law enforcement agencies to enforce provisions of the Firearm Owners Identification Card Act, the Firearm Concealed Carry Act, the Firearm Dealer License Certification Act, and Article 24 of the Criminal Code of 2012. 2605-605(8).
- 9. By joining the Task Force, other Law Enforcement Agencies understand each agency, including the ISP, is responsible for their own costs, expenses, equipment, and personnel salaries and benefits. This Agreement does not create any financial obligation between any Law Enforcement Agency including the ISP.
- 10. All members of the Task Force will share information related to violent crimes as necessary and appropriate for joint investigations.
- 11. All members of the Task Force will share data related to violent crimes as necessary and appropriate for resource allocation and reporting requirements.
- 12. All members of the Task Force will share information related to invalid or revoked FOID cards in circulation in their jurisdictions, as well as their efforts to recover such FOID cards.
- 13. All members of the Task Force may share personnel and equipment to assist other member agencies of the Task Force.

III. DUTIES AND RESPONSIBILITIES OF THE PARTIES

- 1. The Director of the ISP or the designee of same shall:
 - A. Designate an ISP Command Officer to serve as a member of Violent Crime Intelligence Task Force;
 - B. Collaborate with local law enforcement agencies to enforce provisions of the Firearm Owners Identification Card Act, the Firearm Concealed Carry Act, the Firearm Dealer License Certification Act, and Article 24 of the Criminal Code of 2012;
 - C. Maintain and be the custodian of all records related to or generated by the Task Force. The records may include reports, notes, communications, databases, photographs, diagrams, maps, electronic and digitized material. All records will be maintained in compliance with relevant Record Retention Schedules and the State Records Act [5 ILCS 160/et seq.];
 - D. In its role as the custodian of all records generated, ISP shall respond to requests for records made under the Freedom of Information Act (FOIA). [5 ILCS 140/et seq.] If records were created for the Participating Agency, the ISP may require an update on the status of an investigation to determine whether any statutory exemptions apply (e.g., whether a case is an active criminal investigation); and
 - E. Manage the granting of funds from the FOID Enforcement Fund pursuant to the Illinois State Police Law.
- 2. The Chief or Sheriff of the Participating Agency or the designee of the same shall:
 - A. Designate members of the Participating Agency to serve as members of the Violent Crime Intelligence Task Force;
 - B. Conduct enforcement operations against persons whose Firearm Owner's Identification Cards have been revoked or suspended and persons who fail to comply with the requirements of Section 9.5 of the Firearm Owners Identification Card Act, prioritizing individuals presenting a clear and present danger to themselves or to others under paragraph (2) of subsection (d) of Section 8.1 of the Firearm Owners Identification Card Act;

- C. Collaborate with the ISP to enforce provisions of the Firearm Owners Identification Card Act, the Firearm Concealed Carry Act, the Firearm Dealer License Certification Act, and Article 24 of the Criminal Code of 2012;
- D. Respond to case status inquiries in a timely manner so the ISP may satisfy FOIA deadlines;
- E. Serve as the custodian of its records and responding to requests made to it under the Freedom of Information Act. [5 ILCS 140/et seq.]; and
- F. Designate an employee to receive grant funds from the FOID Enforcement Fund awarded pursuant to Illinois State Police Law.

IV. FOID ENFORCEMENT FUND GRANTS

- 1. The ISP shall:
 - A. Determine the Participating Agency's eligibility to receive grant funds from the FOID Enforcement Fund;
 - B. Where funds are available and have been appropriated, award grant funds from the FOID Enforcement Fund;
 - C. Require monthly performance and quarterly financial reporting from the Participating Agency when grant funds have been awarded; and
 - D. Ensure grant funds are spent in such a manner so as to affect the purpose of this Agreement, with specific emphasis on placing individuals into compliance who have had their firearm rights revoked or suspended and have been identified as presenting a risk to public safety in Illinois as determined by the ISP Division of Criminal Investigations (DCI).
- Participating Agencies that apply for and receive FOID Enforcement Grant Funds shall:
 - A. Designate a member of its Participating Agency to receive and manage grant funds from the FOID Enforcement Fund awarded pursuant to this Agreement;
 - B. Execute the Task Force Grant Agreement Addendum, which shall be incorporated to this Agreement by reference;

- C. Comply with required monthly performance and quarterly financial reporting within 7 days after the end of each reporting period when grant funds have been awarded;
- D. Ensure grant funds are spent in such a manner so as to affect the purpose of this Agreement and in compliance with the ISP Firearm Safety Enforcement Grant Detail Protocols as established by the ISP DCI;
- E. Focus its efforts on placing individuals into compliance who have had their firearm rights revoked or suspended and have been identified as presenting a risk to public safety in Illinois as determined by the ISP DCI; and
- F. Retain records sufficient to support the expenditure of grant funds for a period of not less than seven years and cooperate with any request to audit such records from the Illinois State Police or Illinois Auditor general.

V. APPLICABLE LAW

This Agreement shall be governed and construed according to Illinois law.

VI. MEMBERSHIP

Membership in the Task Force is created when both authorized signatures of the Law Enforcement Agency and the Illinois State Police appear on the last page of the Agreement. New members of the Task Force need only execute (sign and date) the last page of this Agreement for ISP to consider membership in the Task Force. Once membership in the Task Force is approved by the ISP, the signed signature page will be returned to the Law Enforcement Agency. An emailed, or .pdf copy of the signatures on the signature page is the same as the original signature. This same language appears at the top of the Signature Page.

VII. COUNTERPARTS

This Agreement may be executed in one or more counterparts, each of which shall be considered to be one and the same agreement, binding on all Parties hereto, notwithstanding that all Parties are not signatories to the same counterpart. Duplicated signatures, signatures transmitted via facsimile, or signatures contained in a Portable Document Format ("PDF") document shall be deemed original for all purposes.

VIII. INFORMATION SECURITY PROTOCOLS.

All Parties shall comply with applicable Illinois and Federal court orders and subpoenas, federal statutes and regulations, and Illinois administrative rules regarding dissemination of confidential and/or personal identifying information. All records and information related to the Task Force shall be protected by the parties from unlawful dissemination. Notice to all parties is required in the event of a breach of confidential information, and responsibility for any improper dissemination of confidential records and/or personal identifying information is the sole responsibility of the party that committed the breach.

IX. TERMINATION

This Agreement may be terminated by mutual agreement of the Parties or upon at least 30 days written notice and after returning of any borrowed equipment as well as the expenditure of all grant funds awarded hereunder.

IN WITNESS WHEREOF, the Parties hereto have executed this Agreement, and this Agreement shall be effective from the day and year first above written. This Agreement contains all the terms and conditions agreed upon by the Parties. No other understandings, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind any of the Parties hereto.

- A. I have reviewed the proposed Second Amendment and the proposed Ordinance adopting the 2nd Amendment.
- B. The Town Board approved by Ordinance 2013-05, on 4/22/13, the First Amendment which removed the requirement that Phase 1 Lots 77,78,79, 108, 110, and 111 be developed as "townhomes (age targeted) to seniors".
- C. The proposed 2nd Amendment would: 1) remove the requirement that Lots 77,78,79,108,110, and 111 be built subject to the Affordable Housing Requirements of the TIF Act. New housing units built under such Affordable Housing requirements can qualify for up to 50% of the costs of construction being treated as a TIF eligible cost. Otherwise, the TIF Act does not permit as a reimbursable eligible TIF cost the vertical construction costs of new private structures. All of the other TIF costs, such as land acquisition, site preparation, engineering, interest financing, etc. remain TIF eligible costs, and 2) it further deletes the requirement that lots 112,113, 114, 115, and 116 be developed as "for senior housing (age restricted) rental units per the Affordable Housing Act Requirements...". This deletion is done by changing the word "shall" to "may" and striking the term "per the Affordable Housing Requirements of the TIF Act" at Section 1.2. of the proposed 2nd amendment.
- D. The decision to adopt the amendment is a legislative decision to be made by the Town. Whether the new units are built under the Affordable Housing Requirements or not only matters from a TIF perspective as to which TIF costs are eligible for reimbursement to the Developer.
- E. I have attached my comments to the proposed Ordinance in blue.

My comments on the proposed 2nd Amendment are:

- 1. On the cover page of the Second Amendment, Lots 112, 113, 114, 115, and 116 are stricken. However, the Developer is proposing a change to those Lots as well as identified in C. above.
- 2. I do not know why the 4th WHEREAS clause is stricken, as it is accurate. However, I don't believe that inclusion is required.
- 3. The 5th WHEREAS clause has the wrong date of June 12, 2013, inserted. It should be April 22, 2013, for the date the first amendment was approved.

- 4. On Section 1. 2. See my comments at C. above.
- 5. Section 2 purports to amend and replace the TIF Eligible Costs of Exhibit B.1. I see no difference between the Exhibit attached as B.1 to the first amendment of 4/22/13 and this Second Amendment. I note that if the Developer is not building per the Affordable Housing Requirements: that the line item of "Construction Cost per Affordable Housing Requirements of TIF Act for \$1,387,500" should be deleted as such will not be an reimbursable TIF cost and the overall Total Estimated TIF eligible Project Costs would correspondingly be reduced to \$2,610,320.

PREAMBLE

WHEREAS, the Town by its duly elected Mayor and Board of Trustees heretofore adopted a Redevelopment Plan and Projects; designated a Redevelopment Project Area; and adopted Tax Increment Financing pursuant to the Tax Allocation Redevelopment Act, 65 ILCS 5/11-74.4 et. seq. (the "Act"), known as the Cortland TIF District (the "TIF District") on January 23, 2012; and

WHEREAS, the Parties hereto entered into a Redevelopment Agreement on September 24, 2012, pursuant to the Act (the "Redevelopment Agreement"), wherein the Town agreed to extend incentives to provide reimbursement of certain Redevelopment Project Costs ("TIF Eligible Project Costs") for the Developer's Project for certain properties owned by the Developer, specifically for Lots 77, 78, 79, 108, 110, 111, 112, 113, 114, 115 and 116 in Robinson Farm Unit 2 (the "Property"); and

WHEREAS, the Redevelopment Agreement, as amended, states in Section A., Paragraph 2., that the Town relied on the representation of the Developer to market and develop Lots 77, 78, 79, 108, 110, 111 (Phase I) for "townhomes per the Affordable Housing Requirements of the TIF Act", and Lots 112, 113, 114, 115 and 116 (Phase II) for "senior housing (age restricted) rental units per the Affordable Housing Requirement of the TIF Act"; and

WHEREAS, on the 22nd day of April, 2013, the Parties agree to amend the terms of the original Redevelopment Agreement to eliminate age restrictions as to Lots 77, 78, 79, 108, 110 and 111, as set forth therein; and

WHEREAS, the Parties wish to further amend the terms of the Redevelopment Agreement to eliminate additional restrictions.

AMENDMENT

- 1. **PRELIMINARY STATEMENTS:** Section A., Paragraph 2. shall be stricken and replaced by the following language:
 - "2. The Town, in extending incentives to the Developer, has relied on the representation of the Developer contained herein to market and develop Lots 77, 78, 79, 108, 110, 111, which shall be for townhomes, hereinafter referred to as Phase I; and Lots 112, 113, 114, 115 and 116, which may be for senior housing (age restricted) rental units, (hereinafter referred to as Phase II. Both Phase I and Phase II are "Approved Uses". For the purposes of this Agreement, "Age restricted" shall mean the units are restricted for occupants at least fifty-five (55) years of age."
- 2. **EXHIBIT B.1:** In *Exhibit B.1*, the "Project Description" shall be amended as follows:

"Project Description: Developer to construct townhomes. (PHASE I)"

Amended Exhibit B.1 is hereby attached to the Agreement and shall replace Exhibit B.1 of the original Redevelopment Agreement, as amended.

3. **PRIOR AGREEMENT TERMS APPLY:** All terms of the original Redevelopment Agreement and Exhibits contained therein shall remain in full force and effect unless specifically modified by this Amendment.
