MINUTES OF THE CROCKETT CITY COUNCIL MEETING HELD ON THE 15<sup>th</sup> DAY OF AUGUST 2022 IN THE CITY HALL COUNCIL CHAMBERS, LOCATED AT 200 NORTH FIFTH IN THE CITY OF CROCKETT, HOUSTON COUNTY TEXAS AT 6:00 P.M.

THE COUNCIL MET IN REGULAR SESSION WITH THE FOLLOWING MEMBERS PRESENT: IANTHIA FISHER, GENE CALDWELL, ERNEST JACKSON, MARQUITA BEASLEY & MIKE MARSH. CITY OFFICIALS PRESENT: CITY SECRETARY MITZI STEFKA, CITY ADMINISTRATOR JOHN ANGERSTEIN, POLICE CHIEF CLAYTON SMITH AND FIRE CHIEF JASON FRIZZELL. DARRELL JONES NOT PRESENT.

Council member Jackson made a motion to approve a request for a specific use permit from Jeffrey W. Darst of Possum Grape II, LLC to allow District C-3 Horizontal Mixed Commercial and Residential use of the building located at 205 E. Goliad, Crockett, Texas 75835, also known as Houston County Appraisal District Parcel 76. Legal description: Lot 43, Block No. 35, original town of Crockett in Houston County, Texas being the same property conveyed to Earl P. Adams by June A. 6. PUBLIC HEARING ON PROPOSED BUDGET OF THE CITY OF CROCKETT FOR THE 2022-2023 FISCAL YEAR

Mayor Fisher opened the public hearing. Mr. Angerstein noted that this is the same budget presented and discussed last month, it has been placed in the foyer for viewing and the public hearing has been published in the newspaper. This budget funds the pay increase for employees as well as funds two additional full-time firefighters. No comments. Mayor Fisher closed the public hearing.

7. CONSIDER AND APPROVE AN ORDINANCE MAKING APPROPRIATION FOR THE SUPPORT OF THE CITY OF CROCKETT FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023; APPROPRIATING MONEY TO SINKING FUND TO PAY INTEREST AND PRINCIPAL DUE ON THE CITY'S INDEBTEDNESS; AND ADOPTING THE ANNUAL BUDGET OF THE CITY OF CROCKETT FOR FISCAL YEAR 2023

Mayor Pro Tem Marsh made a motion to approve an Ordinance making appropriation for the support of the City of Crockett for the Fiscal Year beginning October 1, 2022 and ending September 30, 2023; appropriating money to Sinking Fund to pay interest and principal due on the City's indebtedness; and adopting the annual budget of the City of Crockett for Fiscal Year 2023. Council member Beasley seconded the motion. Motion passes 4-0.

#### 8. PUBLIC HEARING ON 2022 TAX RATE

Mayor Fisher opened the public hearing. Mr. Angerstein stated the tax rate will be set at the De Minimis Rate of .06813. This is the rate that will fund the budget just approved. It covers the City's debt, overall budget, as well as funding the pay increase for employees. It will bring in an additional \$500,000 over last year's budget, with that revenue funding the personnel costs only. Buddy Clonts spoke against the increase. Sherald Woods spoke in favor. Mayor Fisher closed the public hearing.

9. CONSIDER AND APPROVE AN ORDINANCE LEVYING AD VALOREM TAXES FOR USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF CROCKETT FOR FISCAL YEAR 2023; PROVIDING FOR APPORTIONING EACH LEVY FOR SPECIFIC PURPOSES; AND PROVIDING WHEN TAXES SHALL BECOME DUE AND WHEN SAME BECOME DELINQUENT IF NOT PAID

Council member Beasley made a motion to approve an Ordinance levying ad valorem taxes for use and support of the municipal government of the City of Crockett for Fiscal Year 2023; providing for apportioning each levy for specific purposes; and providing

when taxes shall become due and when same become delinquent if not paid. Council member Jackson seconded the motion. Motion passes 4-0.

#### 10. CONSIDER AND APPROVE 2022 TAX ROLL

Council member Jackson made a motion to approve the 2022 Tax Roll. Council member Caldwell seconded the motion. Motion passes 4-0.

# 11. CONSIDER AND APPROVE 2022-2023 FISCAL YEAR BUDGET FOR THE CROCKETT ECONOMIC & INDUSTRIAL DEVELOPMENT CORPORATION

Mr. Gentry presented council with the 2022-2023 budget and explained he has made adjustments in terms of how to report and eliminating the statement regarding the draw note that was approved by the city of \$600,000.00, which was used for business prospects and incentives. This is a flat budget with some cost of living improvements and impacts from higher fuel costs. Several prospect incentives have been addressed in this budget as well. Mr. Gentry went over line items with council and stated the budget is well under the total projections for the year. Council member Caldwell ask why the gas line is part of the prospect incentive line item. Mr. Gentry stated this was recognized several years ago, to construct an industrial gas line for future prospects to the Industrial Park. Mayor Pro Tem Marsh ask Mr. Gentry if there should be a commitment before installing this gas line. Council member Beasley stated that the cost of the gas line was not included in the budget presented. Council members discussed and questioned the placement of several line items in the budget. After discussion; Council member Jackson made a motion to approve the 2022-2023 fiscal year budget for the Crockett Economic & Industrial Development Corporation as presented pending the need for prospect incentives such as the gas line and roof repair as line items in capital expenditures, to come back before council. Council member Beasley seconded the motion. Motion passes 3-1. Council member Caldwell votes against the motion.

AN ORDINANCE AMENDING CHAPTER 19, UTILITIES, OF THE CROCKETT CODE; AMENDING SECTION 19-37(a), INCREASING THE RATES FOR RESIDENTIAL AND COMMERCIAL WATER SERVICE; CONTAINING A SEVERABILITY CLAUSE; CONTAINING A REPEALING CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

THE COUNCIL OF THE CITY OF CROCKETT, TEXAS HEREBY ORDAINS:

#### SECTION I:

Section 19-37(a) of the Crockett Code is hereby amended to read as follows:

Sec. 19-37(a). Water rates.

- (a) The monthly rates or charges for service furnished by the city's water works system inside the city limits shall be as follows:
  - (1) The rates for residential water shall be twenty four dollars and sixty seven cents (\$24.67) base rate, plus fifty four and nine-tenths cents (\$.549) per hundred gallons used.
  - (2) The rates for commercial water shall be thirty four dollars and seventy one cents (\$34.71) base rate, plus fifty four and nine-tenths cents (\$.549) per hundred gallons used.
  - (3) Rates for water service outside the city limits shall be two (2) times those inside the city limits.

#### SECTION II: Severability.

The provisions of this Ordinance are declared to be severable, and if any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses or phrases of this Ordinance, but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

### <u>SECTION III:</u> Repealing Clause

All Ordinances, or parts of Ordinances, inconsistent or in conflict with the provisions of this Ordinance are hereby repealed.

AN ORDINANCE OF THE CITY OF CROCKETT, TEXAS AMENDING CHAPTER 10, GARBAGE AND TRASH OF THE CROCKETT CODE; AMENDING SECTION 10-21, REQUIRING ALL LOOSE REFUSE AND KITCHEN GARBAGE TO BE PLACED INSIDE GARBAGE BAGS; AMENDING SECTION 10-29, RATES GENERALLY TO CHANGE THE RATES; PROVIDING A SEVERABILITY CLAUSE; CONTAINING A REPEALING CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

THE COUNCIL OF THE CITY OF CROCKETT, TEXAS HEREBY ORDAINS:

#### SECTION I:

Section 10-21 of the Crockett Code is hereby amended to read as follows:

Section 10-21. Ninety-Five Gallon Carts, and Garbage Bags Required.

- (A) All residential solid waste must be placed for collection in 95-gallon carts provided by the private contractor collecting solid waste for the City.
- (B) All loose refuse and kitchen garbage must be placed inside garbage bags placed in the 95-gallon carts. No loose garbage is permitted inside the carts.

#### SECTION II:

Section 10-29 of the Crockett Code is hereby amended to read as follows:

Section 10-29. Rates.

The rates charged for collecting solid waste in the City shall be as follows:

#### RESIDENTIAL TRASH RATES

Collection of Trash with 95 Gallon Cart

One time per week, at \$21.37 per home (unit) per month.

Each additional cart for one time per week collection, at \$5.70 per home (unit) per month.

Pick up of vegetative debris with a crew (includes limbs, leaves, etc.), at \$26.50 per yard.

Up to two (2) large bulky items (such as furniture, mattress)

or three (3) thirty (30) gallon bags picked up at curbside each week for all regular customers at no additional cost.

\*Must call the private contractor at (800) 324-2092 an schedule pickup time before placing outside.

\*\*Must be occasional and not a regular occurrence.
