Mr. Angerstein explained the need for redistricting due to the 2020 census data and previous litigation that mandated the city precinct lines coincide with the Crockett ISD district lines. Attorneys for the city explained the reasoning behind the changes in our precinct lines. Council member Beasley inquired about which ethnic groups were considered minorities for this survey. Mayor Pro Tem Marsh made a motion to approve an Ordinance of the City council of the City of Crockett, Texas, approving the redistricting of the city's single member council precincts (Exhibit B) and establishing new precinct boundary lines based on 2020 census data for the City of Crockett, Texas city council elections; making various findings and provisions related to the subject and providing for an effective date. Council member Jackson seconded the motion. Motion failed 2-1. Council member Beasley voted against the motion. Council member Beasley made a motion to keep the precinct boundaries the same. Motion fails for lack of a second.

The Crockett ISD School Board voted to adopt Exhibit B establishing school boundary lines.

Council member Beasley made a motion to allow the city administrator and the attorney to adopt policy whereby the city council will hire/fire the key personnel listed above and those personnel will hire/fire the employees within their respective department and to remove boards and commissions from the charter to be created/managed by ordinance. Council member Ivey seconded the motion. Motion passes 4-0.

**JOINT ELECTION AGREEMENT BETWEEN THE  
CROCKETT INDEPENDENT SCHOOL DISTRICT AND  
THE CITY OF CROCKETT**

This joint election agreement is made this 22nd day of January 2024, by and between the Crockett Independent School District ("Crockett ISD") and the City of Crockett ("the City").

WHEREAS, Crockett ISD plans to hold a Board of Trustees Election on Saturday, May 4, 2024 for the purpose of electing trustees for Districts 3, 4, & 7;

WHEREAS, the City plans to hold a City Council Election on Saturday, May 4, 2024 for the purpose of electing Councilmembers to Positions 3, 4, & 5;

WHEREAS, Texas Election Code § 271.002 authorizes the governing bodies of political subdivisions to enter into an agreement to hold joint elections in election precincts that can be served by common polling places;

WHEREAS, Crockett ISD and the City will hold elections on the same day; and

WHEREAS, the parties to this agreement serve voters within the same boundaries, and it would be to the benefit of the City, Crockett ISD, and the citizens and voters thereof to hold the elections jointly.

NOW, THEREFORE, IT IS AGREED that a joint election will be held by Crockett ISD and the City of Crockett under the following terms and conditions: Each entity, Crockett ISD and the City of Crockett will be responsible for their own:

Election Forms & Records  
Tabulation of results and canvassing
