1. CALL TO ORDER - ROLL CALL

2. OLD BUSINESS

A. Mission/Vision Statement: Commissioner Bordin presented the Mission/Vision Statement he created for the Planning Commission. A. Update on Parks Plan: Mayor Springer states she has been working on the edits, but we are needing the Park Committee involvement. She gives a brief update on the importance of the Comprehensive Plan, potential for GHCOG to help get this plan updated. The goal is to have this completed by the end of this year or early next year, we continue working on applying for Grants to aid in the costs of this. Vice-Chair Lohr asks if Vickie with GHCOG could look at the plan before they begin edits to figure out what all needs to be updated. Chair Brown asks if there is a way to get an editable version of the plan so they can read through and add their edits. Chair Brown also asks if the Planning Commission will be focusing on the Parks Plan or if this will be passed on to the Parks Committee. Mayor states this will be passed along then brought before Planning Commission for review before going before Council for approval.
