APPROVAL OF MINUTES

1. December 13, 2023

Board Member Kollhoff made a motion to approve the minutes from December 13, 2023. Board Member Brown seconded the motion. Motion carried unanimously. Vote: 4-0

NEW APPLICATION

2. Cheeseburger Bobby's (Pouring: Beer/Wine)

Chairman Napps called the next item and asked if anyone was present to represent this application.

Kinjal Patel came forward to represent the application and stated his wife operates two (2) Johnny New York Style Pizza's located in Douglasville and Hiram and has never had any violations. Additionally, he reviewed his training procedures with the board members.

3. CVS Pharmacy #3086 (Change of Manager)

Julia Drake, City Clerk, stated to the Board that the fingerprint background check came back for the Bartow County Resident contact, and she did not meet the ordinance requirements. Therefore, the applicant would be required to provide another contact. If the Board decides to approve this application, it will need to be pending the new contact information and new contact fingerprint background results.

Yasir Irshad, applicant, came forward and stated he understood.

Board Member Rogers explained previous establishment violations and probation until 2027.

Board Member Terry inquired on identification verification and training procedures.

Board Member Rogers made a motion to approve the application pending the applicant provides a new contact and he/she meets the requirements. Board Member Kollhoff seconded the motion. Motion carried unanimously. Vote: 4-0

5. Marisco El Nuevo Nayarit (Pouring: Beer/Wine/Distilled Spirits/Sunday Sales)

With no one present to represent the application, Board Member Kollhoff made a motion to deny the application. Board Member Terry seconded the motion. Vote 0-1. Motion failed.

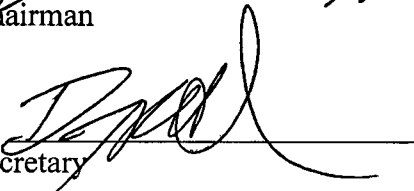
