Mayor called for a motion to appoint Heather Coggins as the Assistant City Administrator effective immediately.

Councilman Haynes, Jr. motioned to appoint Heather Coggins. Councilman Williams seconded. Motion passed unanimously.

4. Amend City Code of Ordinances, Section 2-7

Mayor King called for a motion to amend the City Code of Ordinances to add Section 2-7, (City Administrator) effective immediately.

Councilman Spain motioned to amend the City Code of Ordinances. Councilman Haynes, Jr. seconded. Motion passed unanimously.

5. Approve City Administrator job description

6. Approve settlement with Gwinnett County for Harbins Road improvements

7. Consulting Agreement: Joey Murphy

Mayor King called for a motion to approve the Consulting Agreement with Joey Murphy at \$55.00 per hour effective November 1, 2021 to October 31, 2022.

Councilman Williams motioned to approve. Councilman Haynes, Jr. seconded. Motion passed unanimously.

8. Consulting Agreement: McFarland-Dyer & Associates, Inc.

Mayor King called for a motion to approve the Consulting Agreement with Bowman Consulting Group Ltd. formally McFarland-Dyer & Associates, Inc. at \$175.00 per hour on an as needed basis.

Councilman Spain motioned to approve. Councilman Haynes, Jr. seconded. Motioned passed unanimously.

9. Consulting Agreement: Precision Planning, Inc.

Mayor King called for a motion to approve the Consulting Agreement with Precision Planning, Inc. based on the provided rate schedule on an as needed basis.

Councilman Haynes, Jr. motioned to approve. Councilman Williams seconded. Motion passed unanimously.

10. PUBLIC HEARING: 2021-CD-RZ-04, Applicant: Starlight Homes of Georgia, LLC c/o Mahaffey, Pickens, Tucker, LLP, Owner(s): Ernest Walker Cain, Jr. and James H. Wilbanks requests rezoning from R-1200 Single-Family Residential District to TRD Transitional Residential District. The property is located in Land Lot 275, Parcel 001 of the 5th District and contains 74.04 acres more or less.

Councilman Williams motioned to open the public hearing. Councilman Haynes, Jr. seconded. Motion passed unanimously.

Director of Planning & Economic Development, Brittni Nix, presented the staff report for the application for rezoning from R-1200 Single-Family Residential to TRD Transitional Residential District. Ms. Nix stated staff recommended approval of the application with 19 conditions.

Shane Landham, 1550 North Brown Rd, Suite 125, Lawrenceville, Georgia 30043, on behalf of the applicant, presented the rezoning application. Mr. Landham stated that the proposed development is compatible with the policies in the comprehensive plan as well as the zoning classifications and land uses of the surrounding area. He also requested that a change be made to one of the conditions to include a traffic impact study.

Comment in opposition

Dawn Young, 2340 Fortune Drive, Dacula, Georgia 30019, inquired if there was going to be another meeting after the traffic impact study was conducted. Ms. Young also shared her concerns with the possible accidents that would occur with the increase of traffic along Stanley Road.

Lanita Cornell, 309 Church Street, Dacula, Georgia 30019, shared her concern with the increase of homes and traffic within the city limits.

Councilman Spain motioned to close the public hearing. Councilman Williams seconded. Motion passed unanimously.

11. Rezoning Application: 2021-CD-RZ-04, Applicant: Starlight Homes of Georgia, LLC c/o Mahaffey, Pickens, Tucker, LLP, Owner(s): Ernest Walker Cain, Jr. and James H. Wilbanks requests rezoning from R-1200 Single-Family Residential District to TRD Transitional Residential District. The property is located in Land Lot 275, Parcel 001 of the 5th District and contains 74.04 acres more or less.

Mayor King called for a motion to table application 2021-CD-RZ-04 until the December 2, 2021 Council meeting to further study the request and find some solutions that could potentially address the concerns.

12. PUBLIC HEARING: 2021-CD-AA-01 and 2021-CD-RZ-05, Applicant: New Rock Springs Missionary Baptist Church, Owner: New Rock Springs Missionary Baptist Church requests annexation and rezoning from RA200 Agriculture-Residence District (County) to R-1400 CZP Single-Family Residential District (City). The property is located in Land Lot 331, Parcel 007 of the 5th District and contains 3.0 acres more or less.

Councilman Haynes, Jr. motioned to open the public hearing. Councilman Williams seconded. Motion passed unanimously.

Director of Planning & Economic Development, Brittni Nix, presented the staff report for the applications for annexation and rezoning from RA200 (County) to R-1400 CZP (City). Ms. Nix stated staff recommend approval of the applications with five (5) conditions.

Mayor King stated that since it was a religious institution the fees would be waived.

13. Annexation Application: 2021-CD-AA-01, Applicant: New Rock Springs Missionary Baptist Church, Owner: New Rock Springs Missionary Baptist Church requests annexation into the City of Dacula. The property is located in Land Lot 331, Parcel 007 of the 5th District and contains 3.0 acres more or less.

Councilman Spain motioned to approve with 5 conditions [listed below]. Councilman Williams seconded. Motion passed unanimously.

- 1. Permitted uses within the subject property shall be limited to church use only.
- 2. No outdoor storage shall be permitted.
- 3. Any new ground sign shall be monument type only with indirect lighting. Ground sign shall be limited to a single monument-type sign with a brick or stacked stone base of at least 2 feet in height. Neon or self-illuminating ground signs shall be prohibited.
- 4. Parking lot and security lighting shall be directed in towards the property so as to minimize the adverse impact on neighboring and nearby residential properties.
- 5. All trash dumpsters shall be screened by an enclosure using a 6-foot high fence with black or green vinyl coated chain link with opaque green or black slats. Pickup shall be limited between the hours of 7:00 a.m. to 9:00 p.m. Monday thru Saturday. Dumpster enclosures shall remain closed, locked, and in good repair at all times.

Pickup shall be limited between the hours of 7:00 a.m. to 9:00 p.m. Monday thru Saturday. Dumpster enclosures shall remain closed, locked, and in good repair at all times.

Mayor King called for a motion to approve PPI's proposal to design the security fencing for the public works utility barn in the amount of \$7,140.

Councilman Williams motioned to approve. Councilman Spain seconded. Motion passed unanimously.
