2. PUBLIC HEARING: Ordinance to amend Article III and Article IX of the Zoning Resolution

City Planner, Hayes Taylor, stated staff recommends that the City amend Article III and Article IX of the Zoning Resolution to include a definition and requirements for data centers. Mr. Taylor provided background on data centers and stated the proposed amendments would require data centers to obtain a special use permit. Mr. Taylor stated staff recommend approval of the ordinance amendment effective immediately.

Member Montalbano inquired about the available water source for the potential data center.

City Planner, Hayes Taylor, answered that water would be provided by Gwinnett County Department of Water Resources and the proposed Ordinance requires that the applicant obtain a capacity letter.

Comment in favor:

Councilmember Williams stated it would be wise for the City to require a special use permit for potential data centers to allow an opportunity for community input and to evaluate potential impact on infrastructure.
