PUBLIC HEARING

<u>Proposed FY 2024 Budget (1st of 3 hearings; 2nd hearing will be held at the November 2, 2023, Voting Session and the 3rd hearing will be held on November 16, 2023)</u>

Chairman Thurmond opened the hearing by asking if there was anyone present who wished to be heard on a Proposed FY 2024 Budget.

The following spoke on a Proposed FY 2024 Budget:

Jane Graves, Dawsonville, Georgia, said she was speaking on behalf of the Long Range Planning Committee and read an email she recently sent the Board of Commissioners: "The Dawson County Long Range Planning Committee respectfully recommends that the Dawson County Planning department be expanded by at least one but likely more than one person during 2024. This recommendation is based on the rapid growth Dawson County is currently experiencing and the subsequent need to ensure the Planning department has the appropriate expertise and human resources required to manage this growth proactively. More specifically, we recommend the following: 1. Hiring an experienced and qualified project planner. This position would be responsible for creating and acting upon formal processes. We recommend the development of formal processes so that planning activities may be delegated to new personnel with minimal disruption. As background, Dawson County experienced a gap in planning capabilities post-COVID when the majority of informed personnel had left their positions. In order to avoid this situation in the future, we strongly recommend that at least one additional qualified project planner be hired in 2024.); 2. Have a plan to expand the Planning & Development department to accommodate the pace of the county's residential and commercial growth. We appreciate the BOC's consideration of this recommendation. If any additional discussion is required, the Long Range Planning Committee would be happy to meet with the BOC during our official meetings or as part of the BOC's regular meeting schedule."

Chairman Thurmond asked if there was anyone else present who wished to speak on a Proposed FY 2024 Budget and, hearing none, closed the hearing.
