ZONING:

ZA 18-07 - John and Rachel Senter have made a request for a rezoning subject to County Commission approval. They are seeking to change the current zoning of RSRMM (Residential Sub Rural Manufactured Moved) to RA (Residential Agricultural/Residential Exurban) for the purposed use of building an accessory structure prior to their primary residence. The subject property is zoned RSRMM (Residential Sub Rural Manufactured Moved) and is located at TMP 095 150 002.

Chairman Thurmond announced that if anyone had contributed more than \$250 to the commissioners or chairman in the past two years and wished to speak they would have to fill out a disclosure form, which would be made available to them. Under normal program, ten minutes

Planning & Development Director Jameson Kinley said the requested rezoning is one that is considered a "downzoning" as density is concerned. He said the applicant intends to build a pole barn prior to a residence in order to store equipment and a recreational vehicle. The subject property is located on Ratcliff Drive, off Thompson Road, according to Kinley. Kinley said the Planning & Development department and the Planning Commission recommended approval of the application as presented, without stipulations.

Applicant John Senter, who currently resides in Cumming, Georgia, said he seeks to rezone the property in order to build a pole barn prior to a residence. He said, if all goes as planned, construction on the residence will begin by the end of 2019.

Chairman Thurmond opened the hearing by asking if there was anyone present who wished to speak either for or against the application and, hearing none, closed the hearing.

PUBLIC COMMENT:

Hugh Stowers Jr.- Dawsonville, Georgia, said he would like to see the Board of Commissioners attempt to work with the city of Dawsonville so as the city would assist in operating and maintaining the planned fire station in the Sweetwater Juno Road area, particularly since this planned station would serve city businesses, including the motorsports park and airport. Stowers made a request to the board to request the Georgia Department of Transportation (GDOT) add right turn arrows in the right lane of Highway 53, beginning in front of Burger King. He made a request to the board to discuss with GDOT how to improve safety at Highway 53 coming out of the Ingles shopping center, across from Burger King. Stowers also asked the board to attempt to

Page 3 of 4 Minutes 01-17-19 get "closer control or observation" of the four-way stop intersection of Grizzle Road and Lumpkin Campground Road. Stowers said he would like to see the county create a promotional Facebook page to market the county and, in conjunction, develop a way to regularly provide citizens the amount of sales tax visitors bring into the county. He said, in preparation for future growth, he would like the board to consider having staff identity and prioritize unsafe portions of county roads and place those road names in a database to include corresponding cost and safety metrics. Stowers encouraged each board member to find a citizen in their district to be "your eyes and ears" to assist in keeping board members abreast of "what is going on." Stowers said the community's water system is "pro-growth," adding that he feels Etowah Water & Sewer Authority will raise costs for all of its customers due to a city-approved multi-family housing development on Highway 9. "The city can approve this housing for people living like sardines in a can, but they cannot supply the water, they cannot supply the sewage, education and enforcement...," said Stowers.
