b. Feasibility Study Proposal

Director Alexander presented the proposal for a community-wide hotel feasibility study, in partnership with the Development Authority of Lumpkin County and the Convention and Visitors Bureau. The three entities would split the cost of the study, which would encompass several sites in the city and one in the county. The board agreed it would be a beneficial product to invest in to attract and court developers. Chair Moore called for a motion to approve or deny the funding of the study, which has a total cost of \$5,233.00.
