# 3. Approval of Minutes

a. Approve the minutes of the March 5, 2025 Planning and Zoning Commission Meeting.

It was moved by Commissioner Owens and seconded by Commissioner Eagleson to approve the minutes of the March 5, 2025, Planning and Zoning Commission Meeting. Voting yea: Martinisko, Keehn, Eagleson, Owens.

#### 4. Sign Review Commission

a. Approve / Deny install of proposed Event Complex Signage

Mr. Mohr discussed the proposed Event Complex Signage. The City of Deadwood desires to install a freestanding sign near the entrance to the events complex located at the intersection of 76 Drive and Main Street. The sign, and its location, do not require a variance.

Commissioner Martinisko asked if this is a replacement sign. Mr. Kuchenbecker stated this sign would replace the banners that are currently hung when events take place. The City is working with the South Dakota Department of Transportation on the sign

location. The design of the sign reflects the design of other wayfinding signs throughout town.

Commissioner Keehn inquired if the sign would be lit. Mr. Kuchenbecker confirmed the sign would be up-lit.

Further discussion occurred regarding placement of the sign, the possibility of it sitting in the right of way, and potential requirements of the South Dakota Department of Transportation.

Commissioner Eagleson asked about the height of the sign and wanted to know if high profile vehicles could safely pass under it. Mr. Mohr clarified the sign will not be driven under by vehicles, it will sit along the side of the road as a wayfinding sign.

Commissioner Joseph asked if the sign would seen from the trail system in the area. It was confirmed by Mr. Kuchenbecker it would be visible.

#### It was moved by Commissioner Owens and seconded by Commissioner Keehn to approve the proposed Event Complex Signage. Voting yea: Martinisko, Keehn, Owens, Eagleson.
